Opinion

NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS)
AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The accompanying financial statements (modified cash basis) present the net assets of the Battelle Memorial Institute Health Reimbursement Arrangement for Retired Staff of Battelle Memorial Institute (the “Plan”) and changes therein. The net benefits of the Plan are funded from the Battelle Voluntary Employees’ Beneficiary Association (VEBA) Master Trust (“Trust Fund”) held by Northern Trust. The Trust Fund also holds assets of the Battelle Memorial Institute Medical Plan for BMI Active Staff, the Battelle Memorial Institute Medical Plan for BMI Retirees, the Battelle Memorial Institute Dental Plan for BMI Active Staff, the Battelle Memorial Institute Dental Plan for BMI Retirees, and the Battelle Memorial Institute Long-Term Disability Plan.

The following description of the Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution plan, intended to be a Health Reimbursement Arrangement (“HRA”) as defined under Internal Revenue Service Notice 2002-45, such that the Plan’s reimbursements of participants’ eligible expenses are excludable from participants’ gross income under Internal Revenue Code Sections 106 and 105(b). The Plan covers eligible retired participants and beneficiaries, who elect to participate, of the U.S. components and election subsidiaries of Battelle Memorial Institute (“BMI” or “Battelle”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. Retirees must elect continuance of coverage, meet the age requirement of 65, and have completed 10 years of service, or must be eligible for Medicare as a result of disability. No participant contributions are permitted.

On March 19, 2019, Battelle Memorial informed current employees of Battelle Corporate Operations and participating subsidiaries that the Battelle Memorial Institute Medical Plan for BMI Retirees and the Health Reimbursement Arrangement for Retired Staff of Battelle Memorial Institute (HRA) will be closed to new entrants after June 1, 2019, and that the last day of coverage under both plans will be December 31, 2020, except for a closed group of disabled participants and their eligible dependents. Coverage for these participants will continue until the earlier of the disabled participant’s end of disability or retirement. Current retirees were notified of the December 31, 2020 last day coverage in a letter dated March 21, 2019.

The amendment, described above, does not affect the future and current retirees of PNNL.

Plan Documents—The Plan began as of January 1, 2013, for Columbus (BCO) participants, and July 1, 2013, for Pacific Northwest National Lab (PNNL) Non-bargaining participants; January 1, 2016, for Pacific Northwest National Lab (PNNL) Bargaining participants.

Notional Participant Accounts—The Plan provides a notional individual account (“HRA account”) for each plan participant into which a specified dollar amount (“HRA allocations”) is contributed annually by Battelle and made available for use in reimbursing participants’ eligible medical expenses. Each participant’s benefits are limited to the amount contributed by Battelle to his or her HRA account, which is subject to forfeiture of unused amounts. Unused notional amounts carry forward to subsequent years. Upon death with no beneficiaries or termination of coverage under the Plan, eligible expenses incurred prior to death or termination of coverage may be submitted up to 180 days from that date. Any unused HRA allocations in the participant’s account after 180 days will then be forfeited. HRA accounts of deceased participants who have spouses also covered under the Plan will not be forfeited and will be available for use by the surviving spouse. Any remaining amounts are not portable if the participant leaves the Plan, either by choice or death.

Benefits Paid—The Plan provides reimbursement for eligible expenses for covered health services.

HRA Allocations—HRA allocations are credited to participant HRA accounts at the beginning of each plan year. HRA allocations for participants who enroll after the beginning of the plan year will be prorated based on the number of months remaining in the plan year upon enrollment. HRA allocations are as follows for the year ended December 31, 2024, based on years of service:

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies are summarized as follows:

Basis of Accounting—The financial statements were prepared on a modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Under the modified cash-basis of accounting, the investments are carried at their approximate fair market value while contributions, benefits, and other payments are recorded when they are paid or received. Purchases and sales of securities are recorded on the settlement-date basis.

Contributions—Contributions are recognized at the time benefits and administrative expenses are paid.

Benefits—Benefits are recognized when paid by the claims administrator. In Note 5 the Plan discloses the potential future funds available to participants to seek for reimbursement.

Administrative Expenses—Administrative expenses are recognized when paid. Certain administrative expenses are paid directly by Battelle.

Claims Administration Agreement—Battelle (the “Plan sponsor”) has a contract with Via Benefits, Willis Towers Watson’s Individual Marketplace, under which they provide certain services, including, among other things, processing of claims.

Use of Estimates—The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. BATTELLE TRUST FUND

As of December 31, 2024 and 2023 the Plan had no investments available for benefits in the Trust Fund. The Plan does not own a specific interest in the investments held in the Trust Fund, though the Plan is part of the Trust Fund.

Interest, dividends, net gains (losses), and certain administrative expenses are recorded by Northern Trust in a separate account for each of the Plans within the Trust Fund.

4. FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan or Trust Fund for an asset or paid by the Plan or Trust Fund to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1—Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2—Inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3—Inputs are unobservable inputs for the asset or liability. Unobservable inputs shall be used to measure fair value to the extent that the observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at the measurement date.

Money Market Fund—The fund operates as a government money market fund which is valued at the daily closing price as reported by the fund. The money market fund is deemed to be actively traded and is classified in Level 1 of the fair value hierarchy.

The following tables set forth by level within the fair value hierarchy the Trust Fund’s assets that were accounted for at fair value on a recurring basis as of December 31, 2024 and 2023. Financial assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Management’s assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and their placement within the fair value hierarchy levels.

6. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. Some administrative expenses of the Plan are paid directly by the Company. The Plan paid certain administrative fees to the trustee which qualify as party-in-interest transactions.

Northern Trust is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

7. PLAN TERMINATION

The employer has not expressed any intent to terminate the Plan, though it may do so at any time upon adequate advance notice to participants. If the Plan is terminated, assets of the Plan, to the extent available, will be applied against claims. Any claims incurred prior to the date of termination that are unpaid upon the exhaustion of Trust Fund assets will be paid by the Plan sponsor.

8. TAX STATUS

The Trust Fund established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust Fund's business-related net investment income is exempt from income taxes. The Trust Fund has obtained an exemption letter dated June 25, 1975, from the Internal Revenue Service (IRS), and the Plan sponsor believes that the Trust Fund, as amended, continues to qualify and to operate in accordance with the applicable requirements of the IRC.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition as a liability or disclosure in the financial statements (modified cash basis).

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. SUBSEQUENT EVENTS

Plan management has performed an evaluation of subsequent events through September 15, 2025, the date the financial statements were available to be issued.
