**(1) Description of the Plan**

The following description of The Principia Corporation Retirement Plan for Faculty & Staff (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**(a) General**

The Plan is a defined contribution plan which satisfies Internal Revenue Code (“IRC”) Section 403(b) covering all employees of The Principia Corporation (the “Plan Sponsor”) who have satisfied the eligibility requirements. The effective date of the Plan was January 1, 1926. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Full-time and part-time employees of the Plan Sponsor participate in the salary deferral portion of the Plan immediately upon hire. The Plan utilizes a calendar year for financial and regulatory reporting purposes.

**(b) Plan Administration**

The Plan is administered by the Benefit Plan Administrative Committee, which consists of certain officers and employees of the Plan Sponsor. In 2014, the Plan Sponsor contracted Transamerica Retirement Solutions Corporation (“Transamerica”) to be the plan recordkeeper. Beginning April 15, 2014, all employee and employer contributions are credited to participant accounts maintained by Transamerica. Plan participants have the option of maintaining their pre-April 2014 accounts with Teachers Insurance Annuity Association (“TIAA”) or Equitable Financial Life Insurance Company (“Equitable”), or they may liquidate all or a portion of such accounts and transfer those amounts to Transamerica. State Street Bank and Trust, TIAA, and Equitable are the custodians of the Plan.

**(c) Contributions**

Employees who meet eligibility requirements begin making salary deferral contributions and receiving Plan Sponsor contributions within 30 days of hire. The default deferral rate upon automatic enrollment is 2%. Participants can contribute up to 75% of annual compensation, as defined in the Plan Document, as pre-tax contributions, Roth contributions, or a combination thereof. Participants may terminate salary deferral contributions at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan Sponsor discretionary match for 2024 and 2023 was established at 6% of compensation, up to a maximum of \$4,500. Total matching contributions to the Plan for 2024 and 2023 amounted to \$1,587,152 and \$1,507,116, respectively.

**(d) Participant Accounts**

Each participant's account is credited with the participant's contributions, the Plan Sponsor's discretionary matching contributions, and an allocation of the Plan's earnings. The allocation of earnings is determined by the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**(e) Vesting**

Participants are 100 percent vested immediately with respect to both Plan Sponsor and participant contributions, plus earnings thereon. Therefore, the Plan does not generate any forfeitures.

**(f) Payment of Benefits**

Upon termination of service, death, disability, or normal retirement at age 65, participants may elect to receive a distribution not to exceed the value of their vested account balance. Participants may additionally take in-service distributions upon reaching the age of 59 ½ years. The Plan provides distributions in either lump-sum or annuity payment forms. In addition, participants may receive distributions under circumstances of financial hardship, as defined in the Plan Document.

**(g) Notes Receivable from Participants**

Participants that have an account with Transamerica may request a loan. Participants may borrow, from their vested pre-tax account or rollover account up to the lesser of (i) \$50,000, or (ii) 50% of their pre-tax and rollover account balance. Loans must be repaid within five years, with an exception if the loan is used to acquire the principal residence of the participant, in which case the specified repayment period may be up to ten years. Plan loans proceeds are removed from a participant's account balance. Interest is payable on the loan and is posted to the account of the participant.

Prior to April 15, 2014, loans were available through TIAA. Such loans were issued directly from funds owned by TIAA and loan proceeds were not removed from a participant's account balance. Since the loans were between the participants and TIAA, the balances owed are not included in the Statements of Net Assets Available for Benefits. At December 31, 2024 and 2023, participants had outstanding balances due to TIAA of \$124,948 and \$118,733, respectively. During 2024 and 2023, accumulations totaling \$-0- and \$3,702, respectively, were used to satisfy Plan loan defaults.

**(h) Investment Options**

Participants may direct their account balance into investment options offered under the Plan in any increment. Investment options are shares in registered investment company funds, pooled separate accounts, and annuity contracts held and managed by the custodians. Participants may change their investment elections and make transfers between investment options as frequently as permitted under the individual agreements.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**(b) Valuation of Investments**

Each participant designates the percentage of their participant account that is allocated to each investment fund. Each participant's interest in each investment fund is adjusted as of each valuation date to reflect his or her proportionate share of the total net fair market value of such investment fund.

The Plan Administrator has no duty to inquire into the investment direction of a participant or into any transfer of funds.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefit Plan Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*(c) Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. Loan balances are secured by participant accounts.

*(d) Payment of Benefits*

Benefits are recorded when paid.

*(e) Administrative Expenses*

Administrative expenses related to investment management are allocated among various funds and are included as an offset to net appreciation in fair value of investments. Other administrative expenses of the Plan are paid by the Plan Sponsor.

*(f) Use of Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(3) Information Certified by the Plan's Custodians**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the custodians of the Plan (State Street Bank and Trust, TIAA, and Equitable) have certified as being complete and accurate the investments and notes receivable from participants on the Statements of Net Assets Available for Benefits, the net appreciation in fair value of investments, dividends, and interest income reflected in the Statements of Changes in Net Assets Available for Benefits as of and for the years ended December 31, 2024 and 2023, and the investment information included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodians.

**(4) Group Annuity Contracts**

The Teachers Insurance and Annuity Association Traditional Annuity (“TIAA Traditional Annuity”) is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (“RA”), Supplemental Retirement Annuities (“SRA”), and Group Supplemental Retirement Annuities (“GSRA”). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant’s principal, plus a specified minimum rate of interest, is guaranteed by TIAA’s claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA’s Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years.

The RA contract does not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. The SRA and GSRA contracts provide for full participant-directed liquidity. When a participant’s accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the Statement of Changes in Net Assets Available for Benefits. The SRA and GSRA contracts are presented at contract value within the Statements of Net Assets Available for Benefits. The fully benefit responsive portions of the TIAA contracts are \$1,402,077 and \$1,376,648 at December 31, 2024 and 2023, respectively.

Additionally, the Plan entered into fully benefit responsive investment contracts with New York Life Insurance Company (“NYLIC”) and Equitable. Contributions to the investments are maintained in either NYLIC or Equitable’s general accounts. Contract value, as reported to the Plan by NYLIC and Equitable, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The balances of these contracts at December 31, 2024 and 2023 are \$13,622,285 and \$12,975,873, respectively.

**(5) Fair Value Measurement**

FASB Accounting Standards Codification Topic 820 (“ASC 820”), *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management’s perceived risk of that investment.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

- The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). These investments are included in registered investment companies in the leveling table below.
- The fair values of Equitable investments in registered investment companies are based on each account’s daily net asset value (“NAV”) which represents the daily per share value of the portfolio of investments of the mutual funds, at which sufficient volumes of transactions occur. Equitable investments are not exchange traded and are excluded from the fair value hierarchy. These investments are included in investments measured at NAV in the tables below.

- The fair values of accumulation units held by the Plan in College Retirement Equities Fund (“CREF”) investments (registered investment companies) are based on each account’s daily NAV, which is considered by Plan management to be the best approximation of fair value. CREF investments are not exchange traded and are excluded from the fair value hierarchy. Data for NAVs is available daily to Plan Administrators and client investors on TIAA’s website. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. These investments are included in investment measured at NAV in the tables below.
- The fair value of the Plan’s interest in the TIAA Real Estate Account (a pooled separate account) is based on the fund’s daily NAV, which is considered by Plan management to be the best approximation of fair value. This investment is excluded from the fair value hierarchy. The unit value of the fund is calculated daily and available to Plan Administrators and client investors on TIAA’s website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. This investment is included in investment measured at NAV in the tables below.
- Investments in the non-benefit responsive portion of TIAA Traditional Annuity contracts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations and considering the credit-worthiness of the issuer. The fair value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract. This investment is included in guaranteed investment account in the leveling tables below.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (d) Funds in this category invest in high-quality, short-term instruments (commercial paper, bank obligations, and U.S. Government-issued securities that are classified as first-tier securities) to achieve high current income and capital preservation.

**(6) Tax Status**

The Plan adopted the Transamerica Volume Submitter 403(b) Plan, for which a favorable determination letter was issued to Transamerica by the Internal Revenue Service in 2017. The Plan has been amended since the date of the determination letter. The Plan Administrator believes that the Plan is designed and operated in compliance with applicable requirements of the IRC and as such is exempt from Federal income taxes.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) Risks and Uncertainties**

The Plan provides participants various investment fund options. These investment funds invest in a combination of stocks, bonds, and other investments. Investment securities in general are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances.

**(8) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would remain 100% vested in their account balances.

**(9) Subsequent Events**

Management has evaluated all subsequent events through the date of the Independent Auditors' Report, the date the financial statements were available to be issued.
