Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the O'Neil Industries, Inc. Incentive Savings Plan ("the Plan") provides only general information. For a more complete description, refer to the plan agreement.

General: The Plan is a defined contribution plan sponsored by O'Neil Industries, Inc. and its subsidiaries ("the Company") for the benefit of their salaried or office employees. Beginning on January 1, 2024, all such employees are immediately eligible to participate. Prior to January 1, 2024, employees were eligible to participate after completing three months of service. In addition, employees may contribute amounts rolled over from other qualified plans. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Plan Administration: Ongoing administration of the Plan is the responsibility of the Plan Committee. Members of the Plan Committee are either appointed by the Company or elected by plan participants. The Plan Committee also monitors investment performance and approves changes in the investment options offered to participants.

Contributions: The Plan permits participant contributions on both a before-tax and after-tax basis. The Company matches employee contributions up to 8% of base salary at a rate of 25% for each union participant. The matching contribution for non-union participants is 50% of contributions up to 8% of base salary. Company contributions are limited to the amount deductible for federal income tax purposes. Employees are automatically enrolled at a 5% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Each active participant having automatic enrollment contributions made on their behalf shall annually increase by 1%, not to exceed 12% of base salary.

Participants may contribute in total up to 75% of their base salaries into the Plan, subject to an annual limit on their before-tax contributions (\$23,000 in 2024 and \$22,500 in 2023). Participants who are age 50 or older could contribute an additional \$7,500 in both 2024 and 2023. For each participant, the Internal Revenue Code ("the Code") further limited the aggregate annual Company and participant contributions to this and other qualified plans of the Company to the lesser of \$69,000 in 2024 and \$66,000 in 2023, or 100% of the participant's taxable compensation. The Code requires additional tests that may limit even further the contributions of highly compensated participants.

Participant Accounts: Each participant's account is credited with his or her contributions, the related Company matching contributions (if applicable) and allocations of net investment income (loss). The allocations of net investment income (loss), plan audit fees, legal fees and investment consulting fees are based on the participants' relative account balances. Fidelity's per-participant maintenance charge and loan fees are charged directly to each participant's account.

Participants are able to direct the investment of their account balances using one or more of the investment options offered under the Plan. Participants can change their investment elections daily.

Vesting: Participants are immediately 100% vested in their own contributions, Company matching contributions and the net investment income thereon.

Benefits: Active participants are entitled to request distributions from their accounts at age 59 ½ or for hardship purposes. The amount, manner and terms of these withdrawals are restricted by the Code and the Plan. Withdrawals prior to age 59½ are generally subject to a 10% federal excise tax on the taxable amount.

Upon termination of service, a participant may request that his or her vested balance be distributed in one lump sum, rolled over to an IRA or another qualified plan or that he or she receive periodic installments. The participant may also elect to leave his or her vested balance with the Plan and withdraw it at a later date if the amount is at least \$5,000. In no event may an inactive participant delay receiving payments beyond April 1 following the calendar year in which he or she attains the age 72.

Notes Receivable from Participants: Active participants may borrow from the Plan using their accounts as collateral. Loan amounts may not be less than \$1,000 nor more than the lesser of (a) 50% of the aggregated vested balance in their accounts or (b) \$50,000 reduced by the highest loan balance during the preceding 12 months. Notes receivable from participants bear interest at the prime rate when the loan request is approved and are repaid through payroll deductions over a period not longer than five years (15 years for loans to acquire principal residences). All loans are subject to the approval of the plan administrator.

Investment and Administrative Expenses: Expenses relating to trustee services, investment consulting services, recordkeeping services, audit services and certain legal services are paid directly by the Plan. To the extent an expense is not paid by the Plan, it is paid by the Company.

Termination: Although the Company has not expressed any intention to terminate the Plan, it may do so at any time.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes therein during the reporting period. Actual results could differ from those estimates.

Investment Valuation: The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis.

Risk and Uncertainties: The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, liquidity, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities held by those funds, and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is reasonably possible that change in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Interest and Dividend Income: Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation (Depreciation) in the Fair Value of Investments: Net realized and unrealized appreciation (depreciation) is reported in the accompanying statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Benefit Payments: Benefit payments are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Collective trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 4 - INCOME TAXES

The plan sponsor utilizes a revised prototype plan document. The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan is in compliance with applicable requirements of the Internal Revenue Code (IRC).

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others.

Notes receivable from participants of \$1,221,606 and \$973,013 at December 31, 2024 and 2023, respectively, qualify as party-in-interest transactions. Certain investment management and professional fees are paid by the Plan to the trustee, which qualifies as party in interest.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through September 16, 2025, which is the date the financial statements were available to be issued.
