Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **IFF 401(k) Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter –*Supplemental Schedule Required by ERISA*

The supplemental schedule of assets held for investment purposes at the end of the year – Schedule H, Line 4i as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is/are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

IFF 401(k) Profit Sharing Plan Notes to the Financial Statements

1. Description of Plan

The following brief description of the IFF (Company) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was established on January 1, 1999, by the adoption of the IFF 401(k) Profit Sharing Plan agreement. The agreement created a defined contribution savings plan which qualifies for exemption from income tax under Section 401 of the Internal Revenue Code (IRC).

General – The Plan is a single employer plan and covers all employees who have attained the age of 21 except for employees covered by collective bargaining agreements. For purposes of salary reduction contributions, an employee becomes eligible at age 21. For purposes of the employer matching, safe harbor and profit-sharing contributions, an employee becomes eligible on the first day of the calendar month coincident with or next following the completion of twelve months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Eligible employees may contribute the maximum allowed by current Internal Revenue Service (IRS) guidelines for approved plans which is \$23,000 for 2024. In addition, employees over age 50 may contribute an additional \$7,500 catch-up contribution in 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

At its sole discretion, the Company may contribute a profit-sharing match. In 2024, the Company made a profit sharing contribution equal to 2 percent of the participant's eligible compensation.

In 2024, the Company made a safe harbor contribution equal to 3 percent of the participant's eligible compensation.

Matching contributions cannot exceed 7 percent of eligible compensation, which is limited to \$345,000 in 2024. No matching contributions were made by the Company in 2024.

In addition to the contributions described above, the Company may make additional qualified non-elective contributions to participants at its sole discretion. The Company did not make a qualified non-elective contribution in 2024.

1. Description of Plan (cont'd)

Participant Accounts – Each participant’s account is credited with the participant’s pre-tax and/or after-tax salary reduction contributions, rollover contributions, an allocation of the Company’s contributions, and Plan earnings and charged with an allocation of administrative expenses and Plan losses. Allocations are based on the participant’s eligible compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions and allocations of employer contributions into various investment options offered by the Plan. The Plan currently offers several investment options.

Notes Receivable from Participants – Participants may, subject to certain conditions and limitations, borrow from the Plan an amount not exceeding 50% of the vested portion of the participant’s account. The aggregate outstanding balance of all loans from this Plan is limited to the lesser of \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made, or 50% of the vested portion of the participant’s account under the Plan. The maximum number of loans a participant may have outstanding at any specific date is one. The term of loan repayment shall not exceed 5 years or within a reasonable time, not to exceed 30 years, for the purchase of a primary residence. The loans are secured by the vested balance in the participant’s account, and bear interest at a fixed rate commensurate with interest rates currently being charged on similar commercial loans by lending institutions. At December 31, 2024 and 2023, interest rates ranged from 4.25% to 9.50%, with maturities through May 2034. Principal and interest are paid ratably through payroll deductions.

Vesting – Participants are immediately 100% vested in their salary reduction contributions and rollover contributions, including the earnings attributable to them. Participants who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan are considered 100% vested in their account balance related to Company contributions. If a participant terminates employment for any other reason, his/her Company contribution balance vests in accordance with provisions of the Plan as follows:

1. **Description of Plan** (cont'd)

Forfeited Accounts – Any amounts which become forfeitures are used in the following manner: to restore any balance for eligible former participants who again become participants, then to reduce any employer matching contributions or to pay administrative expenses incurred by the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,762 and \$26,766, respectively. Forfeited non-vested amounts of \$42,041 were used to fund a portion of the Company contribution in 2024.

Payment of Benefits – Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or an eligible rollover distribution. Participants experiencing financial hardship may withdraw a portion or all of the vested account balance as defined in the Plan.

Termination of Plan – Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

2. **Summary of Accounting Policies**

Basis of Accounting – The financial statements of the Plan have been prepared under the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accepted accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. **Summary of Accounting Policies** (cont'd)

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Participant accounts are charged with an allocation of administrative expense that are paid by the Plan and are included in administrative expenses. Allocations are based on the account balances. Investment related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by officers and employees of the Plan sponsor. No such officer or employee receives compensation from the Plan. The Plan has a revenue-sharing arrangement whereas excess fees will be credited to the Plan and are available to pay the Plan expenses. Excess funds received over Plan expenses paid are maintained in an unallocated "Plan Expense Account". The balance in the Plan Expense Account at December 31, 2024, is \$24,659 (\$26,098 at December 31, 2023). Total revenue and expense flowing through the Plan Expense Account was \$18,378 and \$19,817, respectively, for the year ended December 31, 2024.

Subsequent Events – The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

3. Information Prepared and Certified by Custodians

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, and furnished to the Company. The Company has obtained certifications from the Custodians as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Level 1 – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 – Valuations are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and model-derived valuations whose significant inputs are observable.

Level 3 – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (cont'd)

Following is a description of valuation methodologies used for investments measured at fair value on the statement of net assets available for benefits, and the classification of such investments pursuant to the valuation hierarchy.

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These assets are categorized in Level 1 of the fair value hierarchy.

5. Investments in Fully Benefit Responsive Investment Contracts

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America totaling \$285,005 at December 31, 2024 (\$226,664 at December 31, 2023). Empower Annuity Insurance Company of America maintains the contributions in a general account. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Investments in Fully Benefit Responsive Investment Contracts (cont'd)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract is subject to certain termination clauses. The Plan may transfer funds and terminate the contract; however, the issuer reserves the right to defer such payment for up to 12 months following the contract's termination date. Alternatively, the Plan may leave the funds in the investment contract until such time as all participants have elected to withdraw their investment.

6. Tax Status

The Plan has adopted the CCH Incorporated, d/b/a FTWilliam.com Volume Submitter Profit Sharing Plan. The Internal Revenue Service has determined and informed CCH Incorporated, d/b/a FTWilliam.com by letter dated June 30, 2020, that the Volume Submitter Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Related Party and Party-In-Interest Transactions

Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower) are the custodians and recordkeepers of the Plan. Merrill Lynch, Pierce, Fenner and Smith (Merrill Lynch) as well as Empower Advisory are the investment advisors of the Plan and Shore Tompkins Actuarial Resources (Shore Tompkins) provide administrative services to the Plan; therefore, they qualify as a parties-in-interest. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Total direct payments in 2024 were \$43,243 to Empower, \$41,634 to Merrill Lynch, \$15,602 to Empower Advisory, and \$22,293 to Shore Tompkins. The Company pays directly any other fees related to the Plan's operations.
