I realize this form is late. I apologize. In the past when our plan was active, I filed the form 5500 on time. I always got a notice from Paychex, the company that was handling our plan, and took care of it.

In 2023, we had to close our plan down. I filled out and signed the necessary paperwork to have Paychex take care of shutting the plan down and distributing the proceeds. Everything was done accordingly. Everything was dissolved. I honestly thought that was all I had to do. I did not receive any further notices from Paychex.
