## Independent Auditors' Report

### **Opinion**

We have audited the accompanying financial statements of Choctaw Nation of Oklahoma Thrift Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

## NOTES TO FINANCIAL STATEMENTS

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of the Choctaw Nation of Oklahoma (the "Nation") Thrift Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of the Nation who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each participant may elect to contribute a minimum of 1% of their eligible compensation up to the lesser of the participant's eligible compensation or the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for the year ended December 31, 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 for the year ended December 31, 2024. The Plan also permits participants to make rollover contributions from other qualified plans.

The Nation contributes a safe harbor matching contribution of an amount equal to 133% of each participant's elective contributions, up to a maximum of 5% of the participant's eligible compensation.

Participant Accounts and Investment Options: Participants direct the investment of their contributions and the Nation's matching contributions into one or more formal investment options offered by the Plan, including various mutual funds, a stable value fund, or various other investment options available through a self-directed brokerage account. Participants may change their deferral percentage and investment direction at any time.

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, an allocation of the Nation's contribution and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Vesting: Participants are immediately vested in their contributions and the Nation's safe harbor matching contributions.

NOTE A--DESCRIPTION OF THE PLAN--CONTINUED

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$2,500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable is secured by the balance in the participant's account and bear interest at reasonable rates determined by the Plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in their account, or several types of annuity payment plans. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Plan Termination: Although it has not expressed any intent to do so, the Nation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when they have been approved for payment.

Administrative Expenses: The majority of administrative expenses of the Plan are paid by the Nation. Account transaction fees for loans and other distributions are deducted from participant accounts and are reflected as administrative expenses in the accompanying financial statements.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--CONTINUED

Income Tax Status: Effective April 17, 2006, the Plan adopted the Merrill Lynch Special/Flexible Non-Standardized Prototype Defined Contribution Plan Base Document #03. Effective January 1, 2022, the Plan was restated and adopted the Merrill Lynch, Pierce, Fenner & Smith Inc. Non-Standardized Defined Contribution Pre-Approved Plan. The IRS has determined and informed Merrill Lynch by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant's loan balance is reduced, and a benefit payment is recorded.

Subsequent Events: Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure.

#### NOTE C--STABLE VALUE FUND

The Plan invests in a common collective trust fund (the Invesco Stable Value Fund) whose underlying assets are fully benefit-responsive investment contracts. This stable value fund seeks to provide preservation of principal and provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The stable value fund offers five classes of units (Tier 1 through Tier 5) with identical investment objectives for each class of unit. Each class of unit declares income dividends daily and thereby maintains a net asset value of \$1 per unit.

#### NOTE C--STABLE VALUE FUND--CONTINUED

The underlying investments of the stable value fund consist of conventional guarantee investment contracts (GICs), synthetic guarantee investment contracts (“wrap contracts”) and cash equivalents. The GICs are typically issued with a fixed crediting rate and a fixed maturity date that does not change over the life of the contract. Whereas, wrap contracts typically reset on a monthly or quarterly basis as negotiated with the issuer and do not have a final stated maturity date. Gains and losses on the underlying portfolio are amortized over the duration of the investment, through adjustments to the future interest crediting rate.

A number of factors can influence future crediting rates of wrap contracts, which may include but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in crediting ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals and certain wrap contract terms, including wrap fees.

#### NOTE D--FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D--FAIR VALUE MEASUREMENTS--CONTINUED

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Stable value collective trust fund:* A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* The investments in mutual funds are valued utilizing a market approach wherein the Plan uses the quoted prices in the active market for identical assets. All of these investments are traded in active markets at their net asset value per share and are categorized as Level 1.

*Self-directed brokerage accounts:* These accounts may include mutual funds, common stock and exchange-traded funds all of which are valued at the closing price reported in the active market in which the securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E--INVESTMENT CONCENTRATIONS, RISKS AND UNCERTAINTIES

As of December 31, 2024, three mutual funds make up approximately 36% of Plan assets.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE F--TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by Bank of America, N.A. which also serves as the Plan's custodian and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain assets of the Plan consist of notes receivable due from participants which are considered exempt party-in-interest transactions under ERISA.
