*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Numotion 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Notes to Financial Statements December 31, 2024**

#### **Note 1 - Description of Plan**

The following description of Numotion 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution retirement plan covering all eligible employees of United Seating and Mobility, LLC dba Numotion (the "Company"). All eligible employees of the Company who are age 21 or older may participate in the Plan following the completion of one month of service. Eligible employees may enter the Plan on the first day of the month coinciding with or following the date eligibility requirements are met. Nonresident aliens, leased employees, reclassified employees, and employees covered under a collective bargaining (union) agreement are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors of the Company is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

##### **Contributions**

Each year, participants may make salary deferral contributions to the Plan up to 90% of their pre-tax annual compensation, as defined by the Plan. Eligible participants may elect to have all or a portion of their salary deferral contributions designated as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an Eligible Automatic Contribution Arrangement whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation.

The Company may, at its discretion, make matching contributions to the Plan. For the year ended December 31, 2024, the Company elected to make discretionary matching contributions to the Plan equal to 50% of the first 5% of participant salary deferral contributions. There are no allocation requirements for participants to receive discretionary matching contributions. The Company may, at its discretion, also make nonelective contributions to the Plan. Participants must work at least 1,000 hours during the Plan year and be actively employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contributions. The Company elected to not make any discretionary nonelective contributions to the Plan for the year ended December 31, 2024. Participants also direct the investment of all Company contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and discretionary matching contributions, as well as allocations of any discretionary nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to Financial Statements December 31, 2024

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death, disability, or normal retirement, participants shall become 100% vested in the Company contribution portion of their account. All other participants vest in the Company contribution portion of their account based on credited years of service, as defined by the Plan, according to the following schedule:

Less than 1	0%
1	25%
2	50%
3	75%
4 or more	100%

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as published in *The Wall Street Journal* on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions.

#### Payment of benefits

On termination of service for any reason, participants with an account balance of \$7,000 or less will receive a lump-sum amount equal to the value of the vested interest in their account. For participants with an account balance greater than \$1,000, but less than \$7,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator, unless otherwise directed by the participant. Participants with an account balance greater than \$7,000 will have the option to receive their vested benefit in the form of a lump-sum distribution, as installments, or defer payment of benefits until a later date.

Withdrawals from a participant's salary deferral account may also be made in the event of a financial hardship, in accordance with the provisions specified by the Plan. Participants who are at least 59½ years of age may withdraw all or a portion of the vested balance in their account prior to termination.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$250 and \$1, respectively. These amounts will be used to reduce future employer contributions or to pay Plan expenses. For the year ended December 31, 2024, employer matching contributions were reduced by \$140,728 from forfeited nonvested accounts.

#### Note 2 - Summary of accounting policies

##### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Investment valuation and income recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the discretionary matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants in the subsequent Plan year.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain other transactional fees are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are direct payments made by the Plan for recordkeeping, accounting and certain investment management expenses. Other investment-related expenses are included in the net appreciation in fair value of investments.

#### **Use of estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Subsequent events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

#### Note 4 - Investment contract with insurance company

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America totaling \$3,070,422 and \$2,586,489 as of December 31, 2024 and 2023, respectively. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

Either party to the contract may terminate the contract with at least 60 days advance written notice to the other party.

#### **Note 5 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan.

#### **Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 7 - Related party transactions and party-in-interest transactions**

Plan investments include a variety of mutual funds managed by Empower Trust Company, LLC and a guaranteed investment contract managed by Empower Annuity Insurance Company of America. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid directly from Plan assets to the custodians or their affiliates amounted to \$499,868 for the year ended December 31, 2024. Indirect fees paid to the custodians for certain investment management services are included in the net appreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

Empower Trust Company, LLC provides certain administrative services to the Plan pursuant to a service agreement between the Company and Empower Trust Company, LLC. Empower Trust Company, LLC receives revenue from mutual fund service providers for services Empower Trust Company, LLC provides to the funds. This revenue is used to offset certain amounts owed to Empower Trust Company, LLC for its administrative services to the Plan. If the revenue received by Empower Trust Company, LLC from such mutual fund service providers exceeds the amount owed under the agreement, Empower Trust Company, LLC remits the excess to the Plan's trust.

At December 31, 2023, the Plan's revenue sharing account totaled \$33,877. Such amounts may be used to pay Plan administrative expenses or may be reallocated to the accounts of participants. During 2024, the custodians contributed \$107,764 into the Plan's revenue sharing account which is shown as other income in the accompanying financial statements. From this amount, the Company used \$68,000 to pay Plan administrative expenses to investment advisors and accountants and used \$30,600 to reduce employer matching contributions for the year ended December 31, 2024. The balance, including interest earned, totaled \$43,662 as of December 31, 2024.

#### Note 8 - Tax status

The prototype plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter dated November 14, 2022 in which the Internal Revenue Service (the "IRS") stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 11 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The supplemental schedule includes delinquent participant contributions of \$50 pertaining to the year ended December 31, 2023 for which the Company made a corrective contribution of lost earnings that was deposited into the Plan and allocated to the affected participants in April 2024. The remaining \$24,690 of delinquent participant contributions relating to additional payrolls for the year ended December 31, 2024 were fully corrected through a contribution of lost earnings that was deposited into the Plan and allocated to the affected participant in May 2025. The Company believes that these transactions should not affect the tax-qualified status of the Plan.
