Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Kenwal Group Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 - Plan Description

The following description of Kenwal Group Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for more complete information, including more detailed plan provisions specific to the individual employers who participate in the Plan.

General

The Plan covers substantially all of the employees of Kenwal Steel Corp.; Kenwal Pickling, LLC; and Kenwal Steel Tennessee, LLC (collectively, the "Companies"). All employers are related through certain common ownership. The Plan is a defined contribution plan that provides benefits to eligible participants, as determined according to the provisions of the plan agreement.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants

Generally, participants are eligible to participate in the Plan upon reaching age 18 and completing three months of service.

Contributions

The Plan permits participants to contribute both after-tax and pretax contributions up to the maximum percentage allowable, not to exceed the limits of Internal Revenue Code Section 401(k). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Employer nonmatching contributions may be made at the discretion of each individual participating employer. For the 2024 plan year, the Companies elected to contribute \$1,500 to each nonproduction employee, depending on their plan entry date. Certain production employees are also entitled to a mandatory contribution based on hours worked times a rate as defined in the collective bargaining agreement and plan document.

The Plan also provides for a safe harbor matching contribution equal to 100 percent of participant contributions up to the first 4 percent of eligible compensation. All employees except for certain production employees are entitled to this contribution.

Certain participant loan repayments in 2023 were paid after the time frame required by the Department of Labor. The Companies have remitted the 2023 late loan repayments and related lost earnings during 2024. Certain participant contributions in 2024 were remitted after the time frame required by the Department of Labor. The Companies have remitted the 2024 late participant contributions and related lost earnings in 2025.

Participant Accounts

Employee and employer contributions to the Plan are invested, as directed by the participants, in any one or more investment alternatives. Each participant's account is credited with the participant's contributions and the participant's share of the employer's contribution. Allocation of the plan earnings and expenses to the participant's account is based on each participant's proportionate share of funds in each of the investment accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100 percent vested in all employee and employer contributions.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts the lesser of a minimum of \$1,000 up to a maximum of 50 percent of their account balances at the time of the note initiation or \$50,000 reduced by other outstanding loans. Participants are restricted to three notes receivable outstanding at a time. Participant notes receivable must have a term of no longer than five years and will bear interest at a market rate.

Benefit Payments

Upon termination of service, a participant will receive his or her vested account balance in a lump-sum amount. In the event of an employee's death, the entire account balance will be paid to the participant's spouse or named beneficiary. At age 59½, participants may elect to withdraw all or a portion of their vested account balances as an in-service withdrawal.

Hardship Withdrawals

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) must approve any such hardship withdrawals.

Party-in-interest Transactions

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and its affiliates manage certain plan investments that qualify as party-in-interest transactions, as defined under ERISA guidelines. The Companies also pay certain administrative fees on behalf of the Plan.

Termination

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations. Additionally, each participating employer has the right to cease participation in the Plan.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Companies.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Allocated Insurance Contracts

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and no additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 11, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at closing quoted prices reported in active markets.

Common Collective Trust Fund

The common collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets.

There were no unfunded commitments or redemption restrictions on the investments described above.

Note 6 - Investment Contracts

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Note 6 - Investment Contracts (Continued)

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, Principal Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
