Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of Plan

The following description of the Independent Physicians 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

Eligibility

The Plan is a defined contribution plan sponsored by Independent Physicians Resource, Inc. (the Company, or Plan Sponsor). The Plan covers all eligible employees of the Company, excluding collectively bargained employees and independent contractors. Employees are eligible to participate in the Plan after completing a service requirement of 30 days and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, eligible employees consisted of employees of the Plan Sponsor, Cornerstone Medical Center, LLC, and RelyMD, LLC, which are wholly-owned subsidiaries of the Plan Sponsor.

Effective January 1, 2025, the Plan was amended to allow employees to begin making contributions immediately upon hire, removing the service requirement.

Contributions

Each participant may elect to make pre-tax and/or Roth contributions of up to 99% of eligible compensation, as defined in the Plan document, not to exceed a maximum of \$23,000 for the 2024 Plan year, plus a catch-up contribution of up to \$7,500 for participants who have reached at least 50 years of age by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes safe harbor matching contributions of 100% of the participant's deferral up to the first 5% of eligible compensation. In addition, the Board of Directors may, at their discretion, authorize an additional discretionary profit-sharing contribution. There were no discretionary profit-sharing contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any Company contributions and earnings or losses on the investments in their account and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. The Plan also offers a self-directed brokerage account as an

additional investment option for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions, Company safe harbor matching contributions, and rollovers plus earnings and losses thereon. Participants become 100% vested in the Company's discretionary profit-sharing contributions after three years of service. All amounts become fully vested upon the participant's attainment of normal retirement age, disability, or death.

Forfeitures

Forfeited non-vested accounts were \$6,667 and \$581 as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay administrative expenses of the Plan or to reduce future Plan Sponsor contributions. In 2024, no forfeitures were used to pay the Plan's administrative expenses, however, \$60 of forfeitures were used to reduce the Company's safe harbor matching contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account balance. Participants may only have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate, as defined by the Plan document. As December 31, 2024, notes had fixed interest rates ranging from 4.25% to 9.50% for the term of the note, not to exceed five years, unless used for the purchase of a personal residence. Principal and interest are paid through payroll deductions or by other means as specified in the participant's note agreement. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant or beneficiary may elect to receive a payment of the vested interest in their account in a lump sum distribution. If a participant terminates employment and has a balance between \$1,000 and \$5,000, the participant may have their account paid as a direct rollover to an individual retirement account established by the Company for the benefit of the participant equal to the value of their account. If the account balance is \$1,000 or less, the participant may receive a lump-sum distribution equal to the value of their account. In-service withdrawals are also permitted for participants who have attained age 59½.

Participants are also eligible to receive hardship withdrawals when certain conditions are met.

Administrative Expenses

Administrative expenses paid by participants include distribution fees, loan fees, and other transaction and recordkeeping fees. Investment related expenses are paid by participants based on the specific expense ratio for each fund invested in through a direct payment. Investment related expenses attributable to self-directed accounts are charged directly to the participant's account and are included in administrative expenses. The Plan document permits certain administrative expenses to be paid by the Plan. Expenses paid by the Plan in 2024 included recordkeeping fees and advisory fees paid to service providers of the Plan. These expenses paid to the various service providers of the Plan qualify for party-in-interest transactions. The Company pays all other administrative expenses of the Plan and does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company's discretionary profit-sharing contributions are payable to the Plan after they have been approved by the Company. Any unfunded participant or Company safe harbor matching and Company discretionary profit-sharing contributions are included in the participant or Plan Sponsor contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Accounting Standards Codification (ASC) 326, *Financial Instruments - Credit Losses*, the Plan estimated the current credit risk associated with employer receivables. After giving consideration to the risk characteristics, including historical payment experience, the Plan determined that no allowance for credit loss was necessary at there was no current year activity in the allowance for credit losses.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net increase in fair value of investments include realized and unrealized gains and losses, interest and dividends on those investments, and fees charged for investment management services on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the note to be in default, the note balance is reduced, and a benefit payment is recorded as a deemed distribution.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, including the net increase in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator

and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Plan's qualified institution.

4. Investments

Fees incurred by the Plan for the investment management services are included in net change in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in the self-direct brokerage accounts include cash and cash equivalents, interest-bearing cash, common stock, mutual funds, unit investment trusts, and other assets and are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV), which is based on the contract value of the underlying investments (Level 1). The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

5. Income Tax Status

Effective May 27, 2022, the Plan adopted a non-standardized pre-approved plan offered by Principal that has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. Although the Plan has not obtained an individual determination letter and has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is currently being operating in compliance with the applicable requirements of the IRC and has chosen to rely on the current IRS non-standardized pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in the employer discretionary profit-sharing contributions.
