We are writing to formally notify you of the circumstances surrounding the delay in submitting the required audit for Seaborne PR 1081.01 (d) Plan for the plan year ending December 31, 2024.

Seaborne Virgin Islands Inc filed for bankruptcy protection on December 30, 2024. During the bankruptcy proceedings, the company was sold on July 11, 2025. Throughout this transitional period, we were unable to engage our accounting firm to conduct the 401(k) audit due to operational and financial constraints.

Following the sale, the company has remained under the oversight of a court-appointed trustee while the new ownership awaits approval from the Department of Transportation. This ongoing process has further limited our access to funding and resources necessary to complete the audit currently.

Please be assured that it is our full intention to comply with all regulatory requirements. Once the transition is complete and adequate funding is secured, we will promptly engage a qualified accounting firm to complete the audit. Upon completion, we will resubmit the 2024 Form 5500 with the required audit documentation attached.
