We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of St. Anne's Credit Union 401(K) Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established by St. Anne's Credit Union (the Plan Sponsor or the Credit Union) on January 1, 1997. The Plan covers all employees of the Credit Union upon attaining the age of 21 who have completed three months of service and can enroll into the Plan the first day of the month following the day they meet eligibility requirements. The Plan requires a participant to be employed as of year-end to be eligible to receive the employer discretionary contribution, if applicable. If a participant is not employed as of year-end, the participant must have a minimum of 501 service hours during the plan year to receive an allocation of the employer discretionary contribution. The service requirement is waived upon death, disability, or termination of employment on or after the normal retirement age. The Plan is a contributory defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Investments are participant directed.

The Plan Sponsor is also the Plan Administrator. As Plan Administrator, the Plan Sponsor has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. The custodians of the Plan are Matrix Trust Company (Matrix) and CMFG Life Insurance Company (CMFG). The Plan's recordkeeper is CMFG. The Plan's trustee is Credit Union Employees' Retirement Association (CUERA).

Effective January 4, 2023, the Plan was amended to change its name from St. Anne's Credit Union of Fall River 401(K) Retirement Plan to St. Anne's Credit Union 401(K) Retirement Plan.

Contributions

Participants may elect to contribute any dollar amount or percentage of their eligible compensation to the Plan, on a pre-tax basis, so long as those contributions do not exceed annual limitations set by the IRC. Effective March 1, 2025, the Plan was amended to allow participants to designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified retirement plans.

The Credit Union matches participant contributions equal to 50% of each participant's contributions, up to a maximum of 6% of the participant's eligible compensation. The Credit Union also makes qualified nonelective contributions to the Plan in the amount of 3% of eligible compensation for the Plan year, to each eligible participant. Additionally, discretionary employer contributions may be made by the Credit Union. There were no employer discretionary contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, Credit Union matching, qualified nonelective and discretionary (if any) contributions, and their allocations of (a) Plan earnings (losses) and (b) administrative expenses. Plan earnings (losses) and administrative expenses are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, plus the allocation of Plan earnings on those contributions, at the time of allocation. Participants become fully vested in the Credit Union's contributions and the allocation of Plan earnings on those contributions as follows: 25% after 2 years, 50% after 3 years, 75% after 4 years, and 100% after 5 years. Participants are immediately vested in all accounts upon death, disability, or attainment of retirement age.

Participant Notes Receivable

Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have up to two loans outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions within five years, unless such loan is used to acquire a principal residence, in which case they may repay the loan over a reasonable period that may be longer than five years.

Payment of Benefits

The Plan allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or due to hardship, as defined by the Plan. Upon retirement or disability, a participant will be entitled to 100% of their account balance. Upon termination of service due to death, the participant's beneficiary will be entitled to 100% of the account balance, payable in accordance with the Plan documents. Upon termination of employment for any reason other than retirement, disability, or death, the participant shall be entitled to receive or rollover the vested amount of their account balance. Participant amounts of less than \$5,000 will be paid in a lump-sum distribution only. The Plan also provides for mandatory distribution to participants upon reaching age 73.

Effective January 1, 2024, the Plan adopted the provision of the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE) Act 2.0 to increase the limit for involuntary automatic lump-sum distribution for account balances from \$5,000 to \$7,000.

Hardship Withdrawals

Hardship withdrawals are permitted and subject to limitations imposed by the IRC.

Forfeitures

A participant forfeits the unvested portion of his or her account after the earlier of the following: incurring five one-year breaks in service or receiving a distribution of the entire vested portion of the participant's account. Upon a participant's termination, any non-vested portion of the Credit Union contributions is forfeited. These forfeitures will be used to reduce Plan expenses or to pay future Credit Union contributions to the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,672 and \$8,132, respectively. During 2024, \$8,311 of forfeitures were used to offset Credit Union matching contributions.

Plan Termination

The Credit Union expects to continue the Plan indefinitely. However, the Credit Union reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting the Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's custodians and trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-responsive Investment Contract

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

The Plan has an investment in the CMFG Stable Value Fund, which is a group annuity contract issued by CMFG, which meets this requirement. The custodians maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses, and is recorded at contract value. The guaranteed investment contracts issued are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are paid by participants from their account balances and are expensed when they are incurred. Interest income on participant notes receivable is recorded on the accrual basis. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

Contributions

Participant elective deferral contributions, as well as Credit Union safe harbor matching contributions and Credit Union qualified nonelective contributions are recorded weekly when the Credit Union remits the payroll deductions for investment into Plan. Prior to April 1, 2023, Credit Union safe harbor matching contributions and Credit Union qualified nonelective contributions were remitted monthly.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Plan Sponsor, unless the Plan Sponsor directs that the expenses be paid by the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in two mutual funds that accounted for approximately 25% of total Plan investments as of December 31, 2024 and three mutual funds that accounted for approximately 35% of total Plan investments as of December 31, 2023. Additionally, the fully benefit-responsive investment contract accounted for approximately 14% and 15% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by two custodians. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in the mutual funds in the amount of \$13,360,166 and \$11,662,089, respectively, are reported at level 1 within the fair value hierarchy.

4. Fully Benefit-Responsive Investment Contract

The Plan has an investment in the CMFG Stable Value Fund, a group annuity contract, which is a traditional fully benefit-responsive investment contract. Participants may generally direct the withdrawal or transfer of all or a portion of their investment at contract value. Contributions to this fund are deposited into the CMFG Life Insurance Company's general account, which primarily invests in bonds. Certain events, such as amendments to the Plan documents, the Plan's provisions regarding transfers to or from a competing investment option, or Plan Sponsor events that cause a significant withdrawal from the Plan limit the Plan's ability to transact with the custodians.

The Plan believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.

The guarantee of values provided for investments made by the insurance company under the Plan's contracts is based on the financial strength and claims-paying ability of the insurance company.

The value of this contract as reported to the Plan by CMFG, is equal to the sum of contributions made, less withdrawals and administrative expenses, plus interest credited. CMFG is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting rate under this contract is 1.00%, and the crediting rate is reviewed quarterly. The crediting interest rate was 3.25% and 3.15% at December 31, 2024 and 2023, respectively. The contract value of the CMFG Stable Value Fund at December 31, 2024 and 2023 was \$2,257,070 and \$2,024,263, respectively.

5. Summary of Financial Data Certified by the Custodians

6. Income Tax Status

The Plan has been designed using a non-standardized pre-approved profit sharing plan, in which the Internal Revenue Service (IRS) stated in a letter dated June 30, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

The Plan investments are held and managed by Matrix and CMFG. CMFG is the Plan's recordkeeper. Therefore, transactions between the Plan and these parties qualify as party-in-interest transactions, as defined by ERISA. For the year ended December 31, 2024, fees paid directly to CMFG amounted to \$25,591. In addition, participant notes receivable also qualify as party-in-interest transactions.

9. Subsequent Events

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as "super catch-up" contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Effective January 1, 2025, the Plan was amended to include an automatic contribution provision, whereby newly eligible employees are automatically enrolled to defer 1% of annual pre-tax eligible compensation to the Plan unless they affirmatively elect not to participate in the Plan. Additionally, the Plan also includes an automatic escalation provision for automatically enrolled participants whereby deferral percentages are increased on the first day of each Plan year by 1%, not to exceed 6% of a participant's eligible compensation. An eligible employee may elect not to contribute to the Plan, or to elect to contribute a different percentage of eligible compensation.

Management has evaluated subsequent events through September 3, 2025, which is the date these financial statements were available to be issued.
