### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of HealthTexas Medical Group 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of HealthTexas Medical Group 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was adopted by Physicians PrimeCare (Plan Sponsor) effective September 1, 2005.

The Plan is a defined contribution plan covering all eligible employees, as defined, of the Plan Sponsor and certain affiliates.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

***Contributions***

Employer contributions to the Plan may consist of profit-sharing contributions, matching contributions, and employer special contributions (also known as 401(k) safe-harbor contributions) made annually at the discretion of the Plan Sponsor. The Plan Sponsor approved safe harbor nonelective contribution is equal to 3% of compensation. The total employer contribution in 2024 was \$2,633,716 net of forfeitures applied.

Participants are eligible to participate in the Plan immediately upon employment. Effective as of March 1, 2022, the Plan was amended so employees who are hired on or after March 1, 2022 are automatically enrolled in the Plan. Additionally, all employees with hire dates after March 1, 2022 who have not made an affirmative election with the plan trustee will be automatically enrolled at 3% after 60 days of employment. Effective as of January 1, 2023, the Plan was amended to change the definition of service for eligibility and vesting purposes from the counting of hours method to the elapsed time method. For this method, 1,000 hours of service was changed to a service requirement of six months for the purpose of the benefiting participant requirements for the additional profit-sharing contributions.

Participants who terminate their employment during the plan year for reasons other than death, disability, or retirement will not be eligible for the elective profit-sharing contribution but will receive safe-harbor and other employer contributions as required to comply with Internal Revenue Code (IRC) Section 410(b) coverage requirements.

Each year, participants may contribute up to 50% of their pre-tax annual compensation, as defined in the Plan, subject to IRC rules and regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 by the end of the plan year and who have already made the maximum elective deferral may make an additional pre-tax "catch-up" contribution. Participants are always 100% vested in their pre-tax contributions, rollover contributions, and special employer safe-harbor contributions.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Each participant has the option of directing their contributions and employer contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and any Plan Sponsor matching, profit-sharing, and special safe-harbor contributions, and plan earnings are charged with an allocation of certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions and employer safe-harbor contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and profit-sharing contributions is based on years of continuous service. A participant is 100% vested after five years of credited service or upon the death or disability of the participant.

***Notes Receivable From Participants***

In certain situations, the plan administrator will allow the participant to borrow funds from their account in the Plan. Loans are only allowed to be taken for reason of hardship and may not be for less than \$1,000. The maximum amount of a loan is the lesser of: i) one-half of the vested account balance, or ii) \$50,000 (reduced by the excess of (a) the highest outstanding loan balance during the one-year period ending on the day before the loan is made, over (b) the outstanding loan balance on the date of the loan). Each loan must be adequately secured by the participant's vested account balance and bear a reasonable rate of interest. The loan (including interest) must be repaid within five years unless it is for the purchase of a primary residence, in which case the loan repayments may be extended for a reasonable period of time beyond five years. Loans must be repaid by mandatory periodic payroll deductions. Participants may have up to two loans outstanding at one time.

***Payment of Benefits***

Generally, plan benefits begin as soon as practicable after the later of (i) the date participant reaches their normal retirement date or (ii) the date participant leaves employment. If a participant leaves employment due to disability, they may elect to begin receiving benefits as soon as administratively feasible after employment ends. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments over a period of time not to exceed the joint life expectancy of the participant and their spouse or a combination of lump-sum and installment payments. For termination of service for other reasons, a participant must receive the value of the vested interest in their account as a lump-sum distribution.

The Plan Sponsor may periodically distribute the funds of terminated participants who do not make a distribution election. If the vested account balance is \$1,000 or less, the funds will be distributed in the form of a lump-sum distribution. For vested benefits over \$1,000 up to \$5,000, the funds will be distributed in a direct rollover to an individual retirement account designated by the plan administrator.

For vested benefits exceeding \$5,000, benefits may be paid by lump-sum distribution, remain in the Plan until the earlier of age 65 or death of the participant, or rolled over into another qualified plan. Hardship withdrawals are available upon approval.

***Forfeited Accounts***

Participant forfeitures of nonvested contributions may be used to reduce employer contributions for the year in which the forfeiture occurs. Forfeitures used to reduce the 2024 contribution were approximately \$67,000. There were no unallocated forfeitures as of December 31, 2024 and 2023.

***Basis of Accounting***

The accompanying financial statements are prepared using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments in short-term investment funds and mutual funds are stated at fair value based on quoted market prices. Investments in common/collective trusts are stated at net asset value (NAV) per accumulation unit of the investment held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Plan Sponsor or by the Plan, at the Plan Sponsor's discretion.

**Note 3. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment and notes receivable from participants information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

**Note 4. Disclosure about Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by Charles Schwab Trust Bank, the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor paid certain administrative expenses related to the Plan for the year ended December 31, 2024. The Plan Sponsor provides certain administrative services at no cost to the Plan.

**Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets but no later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. During the year ended December 31 2024, contributions totaling \$97,374 were not remitted to the Plan timely.

**Note 9. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a 401(k) profit-sharing plan and trust sponsored by Schwab Retirement Plan Services, Inc. This plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service (IRS) stating that the Plan constitutes a qualified plan under Section 401 of the IRC and that the related trust was tax-exempt as of the financial statement date. The Plan has not obtained or requested a determination letter. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were available to be issued.
