## INDEPENDENT AUDITOR'S REPORT

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule, schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Synacor, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Information about the Plan agreement beyond the information provided below is contained in the Plan document and summary Plan description. Copies of these are available from the Plan Administrator.

**General:** The Plan is a defined contribution plan covering substantially all employees of Synacor, Inc. (the "Company") upon each employee's effective date of hire. The Plan does not include union employees, non-resident aliens, leased employees, residents of Puerto Rico, or interns. There are no age or service requirements for elective deferrals. One year of service is required to receive employer non-elective discretionary profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Pension Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions:** Participants may contribute an unlimited amount of their pretax annual compensation as elective deferral contributions as defined in the Plan, subject to the annual limitations of the Internal Revenue Code (IRC). The Plan also permits participants to make after-tax contributions and catch-up contributions as defined. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled into the Plan upon meeting eligibility requirements with salary deferrals of 6 percent of eligible compensation, with incremental increases of 1 percent annually up to a maximum of 10 percent, unless the employee makes an affirmative action to not have contributions made on his or her behalf or have contributions made in a different amount.

The Plan provides for employer non-elective discretionary profit-sharing contributions. The Company has sole discretion as to the amount of any non-elective discretionary profit-sharing contributions. There were no non-elective discretionary profit-sharing contributions during the years ended December 31, 2024 and 2023. The Plan also provides for discretionary employer matching contributions. The Company provides for employer matching contributions calculated on an annual basis at a rate of 50 percent of the first 6 percent of the participant's deferral.

**Vesting:** Participants are immediately vested in their elective deferral contributions and rollover contributions, plus actual earnings thereon. Vesting in employer non-elective discretionary profit-sharing contributions and discretionary employer matching contributions, if any, are based on years of service, as defined. A participant is 25 percent vested each year in non-elective discretionary profit-sharing contributions and discretionary employer matching contributions until fully vested after four years of service.

**Participant Accounts:** Each participant's account is credited with the participant's elective deferral contribution, the Company's contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the participant's highest outstanding loan amount during the prior 12 months or 50 percent of their vested account balance, whichever is less. Generally, loans are to be repaid within a five-year period. If the loan is to be used to acquire a principal residence, repayment terms may be longer. The loans are secured by remaining account balance. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through bi-weekly or semi-monthly payroll deductions.

**Payment of Benefits:** Participants may receive distributions upon termination of employment, reaching age 59½, death, disability or financial hardship.

#### NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Forfeited Accounts:** At December 31, 2024 and 2023, non-vested forfeitures amounted to \$1,035 and \$4,911, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. Plan expenses and employer contributions were reduced by \$42,926 and \$9,047 for the years ended December 31, 2024 and 2023, respectively.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits:** Benefits are recorded when paid.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation on investments.

**Subsequent Events:** These financial statements have not been updated for subsequent events occurring after September 15, 2025, which is the date these financial statements were available to be issued.

#### NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Money market funds:** Valued at cost plus accrued interest. The money market funds are classified as Level 1 investments.

**Shares of registered investment companies:** Valued at the NAV of shares held by the Plan at year end. The NAV is the closing price reported on the active market on which the securities are traded.

#### NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company (Ascensus) is the trustee of the Plan and The Vanguard Group, Inc. is the recordkeeper of the Plan. Plan investments are managed by Ascensus as of December 31, 2024 and 2023. Ascensus is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. The Plan also holds notes receivable representing participant loans.

#### NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 6. CERTIFICATION

The following financial information relating to the Plan's assets as of December 31, 2024 and 2023, as well as income (losses) and transactions for the years then ended, has been derived from information provided by Ascensus, the trustee of the Plan, and has been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent accountants.

#### NOTE 7. TAX STATUS

The Plan has adopted a non-standardized form of a prototype plan sponsored by Ascensus LLC. The prototype plan provider has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS), which states that the prototype plan satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management and counsel, believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
