### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Select Arc, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Description of Plan

The following description of the Select Arc, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of Select Arc, Inc. (the Company) who are not members of a collective bargaining unit, have six months of service and are aged 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant contributions:** Eligible employees may contribute up to 100% of their compensation as defined by the Plan. Eligible employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations under the Internal Revenue Code (IRC).

**Employer contributions:** The Company has an option to make a discretionary matching contribution according to the Plan document. Since the Plan's inception, the Company has elected to make a matching contribution equal to 50% of the first 4% of a participant's contribution to the Plan. Contributions are subject to certain limitations under the IRC. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations permitted under current regulations.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately and distinctly, into which investment the participant contribution and Company contribution is to be invested.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus earnings thereon is based on years of continuous service at a rate of 20% per year after two years of service.

**Notes receivable from participants:** Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance. The minimum amount for any single loan is \$1,000. Loan terms do not exceed five years, except if the funds are for certain home-related loans. The loans are collateralized by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are repaid through payroll withholding. Interest on participant loans is at a rate of prime plus 1%. The interest rates on outstanding loans ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

**Payment of benefits:** On termination of service, a participant is eligible to receive a distribution equal to the vested value of the participant's account. A participant may, under certain conditions, withdraw all or a portion of their account balance without terminating their employment. If a participant's vested account balance, excluding rollover contributions, is less than \$7,000, then the participant's account will be paid in a single lump-sum cash distribution as soon as administratively feasible after termination of employment. If a participant's vested account balance, other than rollover contributions, exceeds \$7,000, the participant has the right to defer the commencement date of the distribution.

**Forfeited accounts:** Forfeited, nonvested accounts as of December 31, 2024 and 2023, totaled \$14,062 and \$8,156, respectively. Forfeitures, if available, are used to reduce future employer matching contributions. No forfeitures were used to offset employer contributions during 2024.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as more explicitly described in the Financial Accounting Standards Board Accounting Standards Codification.

**Investments:** Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan provides for investments in mutual funds and a fixed annuity investment contract.

Because the fixed annuity investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fixed annuity investment contract. The fixed annuity investment contract is presented on the face of the statements of the assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income.

**Contributions:** Participant contributions are recognized when earned. The Company's matching contributions are recognized concurrently with employee contributions.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** A significant portion of the Plan's administrative expenses are paid by the Company.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans that were not distributed as of December 31, 2024 and 2023, totaled \$34,925 and \$56,078, respectively.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 11, 2025, the date the financial statements were available to be issued.

#### **Note 3. Information Prepared and Certified by the Plan's Trustee**

The information related to investments and notes receivable from participants that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by Empower Annuity Insurance Company of America, the Plan's trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to Plan investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 7 and the supplemental schedule related to the Plan's investments.

Empower Annuity Insurance Company of America also certified the completeness and accuracy of \$976,471 of net appreciation in fair value of investments, \$585,808 of interest and dividends income related to investments, and \$27,138 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### **Note 4. Investment Contract with Insurance Company**

The Plan has a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America, trustee of the Plan, at December 31, 2024 and 2023. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting interest rates are based on an agreed-upon formula with the issuer, and are guaranteed for an agreed-upon period, usually quarterly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, the contract issuer may terminate the contract with 75 days advance notice to the contract owner for reasonable cause, which includes the contract owner's failure to render performance necessary to comply with the terms of the contract, failure to maintain contract value of at least \$20,000, plan disqualification or termination, the determination that amended terms of the Plan may have an adverse effect on obligations under the contract, or knowledge of a competing allocation option included in the Plan. Upon termination by the contract issuer, a market value adjustment or other withdrawal restrictions may apply.

#### **Note 5. Plan Termination**

Although it has not expressed such an intention, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, the assets of the Plan will be distributed to participating employees or their beneficiaries. The Company shall have no right, title or interest in the contributions made by it under the Plan.

#### Note 6. Income Tax Status

The Plan has adopted a pre-approved plan which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved Plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before fiscal 2021.

#### Note 7. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under this standard are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Note 7. Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Assets measured at fair value on a recurring basis:** The following table summarizes assets measured at fair value on a recurring basis as of December 31, 2024 and 2023, segregated by the level of the valuation inputs with the fair value hierarchy utilized to measure fair value:

#### Note 8. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### Note 9. Parties in Interest

Certain Plan investments are managed by the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for trustee services to Empower Annuity Insurance Company of America totaled \$89,609 for the year ended December 31, 2024.
