Notes to Financial Statements

Note 1 - Description of the Plan:

The following description of the Ferguson Construction Co. (Company) 401(K) Plan for Operations (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed six months of service and are age eighteen or older, and are hourly employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum allowable under the tax law of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employee deferrals for the years ended 2024 and 2023 were \$626,789 and \$650,369, respectively. Effective January 1, 2022, the Company matches up to 4% of compensation, with no limit for employees who participate. The Company matches for 2024 and 2023 were \$344,726 and \$356,714, respectively. A discretionary profit sharing contribution may be contributed at the option of the Company's board of directors. The Company made a discretionary profit sharing contributions of \$407,408 and \$0 for the years ended 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (1) the Company's contributions and (2) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions to several investment options.

Loans to Participants

Participant loans are not permitted.

Note 1 - (Continued)

Payment of Benefits

On termination of service, a participant will receive a lump-sum amount equal to the value of his or her vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023 there were \$58,460 and \$58,102 of forfeited nonvested accounts, respectively. These accounts were used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$59,344 and \$61,866 respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Note 2 - Summary of the Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held in Guaranteed Interest Funds are valued at fair value, which represents contributions, reinvested income, less any withdrawals plus accrued interest. Fair value is adjusted to contract value on the financial statements. Interest rates approximate market rates. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through July 8, 2025, the date the financial statements were available to be issued.

Note 3 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 4 - Tax Status:

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has obtained a favorable determination letter from the Internal Revenue Service and the Plan sponsor believes that the plan continues to qualify and to operate as designed.

Note 5 - Risks & Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6 - Information Prepared and Certified by Trustee:

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the trustee.

Note 7 - Related Party and Party in Interest Transactions:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are shares of a money market account managed by Reliance Trust Company. Reliance Trust Company is the Custodian defined by the Plan and, therefore, these transactions qualify, as party in interest transactions.

Note 8 - Market Conditions:

Changes in investment returns and fair values can have a significant effect on the Plan. Management is monitoring investment market conditions and the impact declines are having on the Plan's investment portfolio. Due to the volatility of the financial markets as of the date of this report, there is uncertainty regarding the impact which continued volatility may have on the Plan's investment portfolio.

Note 9 - Fair Value Measurements:

Generally Accepted Accounting Principles establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Generally Accepted Accounting Principles are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

As required by Generally Accepted Accounting Principles, a financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Level 2 Transamerica Stable Value fund is considered fairly stated at contract value.

Note 10 - Investment Contract with Insurance Company:

The Transamerica Stable Value Advantage Account is a stable value fund that invests in the general account of the insurance company issuing the contract that offers the particular Stable Value Advantage Option investment choice. Assets held in the Stable Value Advantage Account are commingled with the assets in the insurance company general account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. Accordingly, the contract value is the fair market value to be disclosed. In addition:

- A. The Stable Value Advantage Option investment choice is a non-tradable obligation of MetLife. Thus, the investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Reliance Trust Company.
- B. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable - for example, a significant decline in creditworthiness of MetLife, the Stable Value Advantage Option investment choice may no longer be considered fully benefit-responsive.
- C. The terms of Transamerica Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans or transfers to other investment choices within the plan.
- D. Since the Stable Value Advantage Option investment choice is an obligation of MetLife, the occurrence of an event that limits the ability of the investment to transact at contract value with Transamerica and participants holding the investment is not probable.
- E. The Stable Value Advantage Option investment choice allows participants reasonable access to their assets in it.
