***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Howard Miller – Hekman Profit-Sharing and 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits (Modified Cash Basis) as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits (Modified Cash Basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Howard Miller – Hekman Profit-Sharing and 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for presentation of the financial statement in the circumstances. #### **Note A – Description of Plan**

The following description of the Howard Miller - Hekman Profit-Sharing and 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing and 401(k) plan covering substantially all employees of Howard Miller Company, Woodmark Originals, Inc., and Zeeland, Michigan employees of Hekman Furniture Company (collectively, the Company). Eligible employees can become participants in the 401(k) portion of the Plan and receive discretionary matching contributions from the Company on the first day of the first payroll period of each month after completion of six months of employment with 500 hours of service. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

A participant may elect to make contributions to the Plan through payroll deductions, subject to statutory limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3%. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

The Company may make a matching contribution based on the participant's contribution. This matching contribution amount is discretionary and is determined annually. A matching contribution of 50% of the first 3% and 15% of the next 3% deferred by each participant was made for the years ended December 31, 2024 and 2023. The amount of matching contributions made by the Company were \$166,228 and \$177,439 for the years ended 2024 and 2023, respectively.

The Company may also make profit-sharing contributions to the Plan on behalf of eligible Company employees in amounts as determined by its Board of Directors. These amounts are prorated based on earnings of participants during the plan year. Profit-sharing contributions were \$50,000 and \$35,835 for the years ended 2024 and 2023, respectively.

#### **Plan Operations**

The Company has appointed Principal Trust Company (Trustee) to serve as the Trustee of the Plan for the period August 1, 2024 through December 31, 2024. The Company had appointed Reliance Trust Company (Custodian) to act as the Custodian and Transamerica Retirement Solutions, LLC (Trustee) to serve as Trustee for the period January 1, 2024 through July 31, 2024, and for the year ended December 31, 2023. The Company acts as plan administrator. The Custodian/Trustee is responsible for holding the investments of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participants reporting requirements are fulfilled.

#### **Note A – Description of Plan (Continued)**

##### **Participant Accounts**

Individual accounts are maintained for each participant, with benefits limited to the amount contributed to the participant's account plus or minus any allocation of income, expenses, gains, or losses. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of elective and Company matching and profit-sharing contributions into various investment options offered by the Plan.

##### **Vesting**

Participants are immediately vested in their voluntary contributions and qualified nonelective contributions plus actual earnings thereon. Vesting in the employer profit-sharing accounts is based on years of continuous service, as follows:

Vesting in the employer matching contribution accounts is based on years of continuous service, as follows:

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

#### **Note A – Description of Plan (Continued)**

##### **Loans to Participants**

Under certain conditions, a participant may obtain a loan from the Plan. A participant's loan cannot exceed the lesser of \$50,000, reduced by the participant's highest outstanding loan balance during the one-year period ending on the day before the new loan is issued, or one half of the participant's non-forfeitable interest in the Plan. The loan will bear a reasonable interest rate, be adequately secured, and not exceed a period of five years (unless used for the purchase of a primary residence). Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service, retirement, early retirement, total and permanent disability, attainment of age 65, or death, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service withdrawals are permitted upon attaining age 59½ or in cases of financial hardship. Distributions can be made directly to the participant, their designated beneficiary, or rolled over to another qualified plan.

##### **Costs and Expenses**

Certain transaction fees and administrative expenses are paid by the Plan, unless otherwise paid by the Company, and are based on reasonable and customary rates. Expenses that are paid by the Company are excluded from these financial statements.

##### **Forfeited Accounts**

Forfeited balances of discretionary match and profit sharing accounts are used to offset employer contributions or pay administrative expenses. Forfeitures of \$8,499 and \$19,682 were used to reduce employer contributions during the year ended December 31, 2024 and 2023, respectively. Forfeitures of \$692 and \$14 were used to pay plan expenses for the years ended December 31, 2024 and 2023, respectively. The balance in the forfeiture account at December 31, 2024 and 2023 was \$13,564 and \$71, respectively.

#### **Note B – Summary of Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared using the modified cash basis of accounting and, accordingly, are not presented in conformity with generally accepted accounting principles. Under this basis of accounting, interest and dividend income and contributions are recorded when received rather than when earned, and expenses are recorded when the disbursements are made rather than when the obligation is incurred.

#### **Note B – Summary of Accounting Policies (Continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### **Investments and Income Recognition**

Investments are reported in the Plan's financial statements at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements and Note D for the fully benefit-responsive contract.

Income from interest is recorded when it is received. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the modified cash basis of accounting. Related fees are charged directly to the participant's account and are included in administrative expense when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document; therefore, an allowance for credit losses is not considered necessary at December 31, 2024 and 2023.

##### **Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

#### **Note C – Fair Value Measurements**

The Plan's investments, except those required to be reported at contract value, are reported at fair value in the accompanying Statements of Assets Available for Benefits (Modified Cash Basis). The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on quoted net asset values (NAV) of the shares held by the Plan on the last business day of the plan year.

*Pooled separate accounts:* Valued at NAV based on the closing price for underlying securities, reported on the active market on which underlying securities are traded or based on quoted prices of similar assets. The NAV of each of the separate accounts is reported by the fund managers as of the financial statement date based on recent transaction prices and represents the price at which the Plan would be able to initiate a transaction. The pooled separate accounts held by the Plan provide for daily redemptions by the plan at reported NAV with no advance notice requirement and have no unfunded commitments.

#### Note D - Investment Contracts with Insurance Companies

For the year ended December 31, 2023, plan assets included a fully benefit-responsive group annuity fixed income contract issued by the Transamerica Life Insurance Company (Transamerica). Transamerica maintains the contributions in a Stable Value investment account. The methodology for calculating the interest crediting rate is defined in the terms of the contract. Under terms of the existing contract, Transamerica will credit the Plan's fund the applicable portion of investment income semi-annually, effective on the first day of the semi-annual period. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity dates. The crediting interest rate for the year ending December 31, 2023 was 1.65%.

As described above, because the fixed income contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits (modified cash basis) attributable to the contract. Contract value, as reported to the Plan by the custodians, represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and fees. Participants may ordinarily direct permitted withdrawal or transfer of all or a portion of their investment at contract value within reasonable timeframes.

#### ***Note D - Investment Contract with Insurance Companies (Continued)***

The fixed income contract is an insurance contract. As a result, the plan may transact or terminate the contract according to the terms defined in the contract at any time. If a plan sponsor wishes to remove the Transamerica Stable Value investment choice as an option from the plan, then depending on the contract, there may be a hold for up to a 270-day period on the Stable Value investment choice assets at the plan level if the most recently announced upcoming credited rate has increased or has not changed. Additionally, under limited circumstances, Transamerica may impose up to a 12-month delay period on all withdrawal requests.

For the year ended December 31, 2024, plan assets include a fully benefit-responsive group annuity fixed income contract issued by Principal Life Insurance Company (Principal Life). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the assets available for benefits attributable to the guaranteed investment contract. The contract is presented on the face of the statement of assets available for benefits at contract value. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest rate credited was 4.85% for the year ended December 31, 2024. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### ***Note E - Information Certified by Certifying Entities***

All investment information disclosed in the accompanying financial statements (modified cash basis) and Supplemental Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments, other income, interest income from notes receivable from participants and interest and dividends for the years then ended, were obtained or derived from the information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company for the period August 1 2024 through December 31, 2024, and Transamerica Trust Company for the period January 1, 2024 through July 31, 2024 and for the year ended December 31, 2023.

#### ***Note F – Risks and Uncertainties***

The Plan utilizes various investment instruments, including mutual funds and stable value funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Assets Available for Benefits (Modified Cash Basis).

#### ***Note G – Party-In-Interest Transactions***

Plan investments include investments managed by Principal Trust Company and Transamerica Trust Company (and their affiliates), who hold the Plan's investments as of December 31, 2024 and 2023, respectively. Therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$127,129 and \$139,514 for the years ended December 31, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. Those party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### ***Note H – Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

#### ***Note I – Tax Status***

The prototype plan adopted by the Plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the Plan's tax counsel also believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### ***Note I – Tax Status (Continued)***

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### ***Note J – Subsequent Event***

Subsequent to year end, the Company announced its plans to wind down operations and initiate the process of dissolving the entity. In accordance with the Plan document and applicable regulations, all participant accounts would become 100 percent vested in the event of plan termination.
