**Note 1 - Description of the Plan**

The following brief description of Bomco, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan, established on May 1, 1973, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees who have attained the age of eighteen, except residents of Puerto Rico, leased employees, summer interns and temporary employees are eligible to participate in the plan on the first day of the month following their first day of employment with the Company. Participants may change their deferral percentage at any time with the change being effective on the first day of the month following the election. Effective March 26, 2021, the Plan was restated to meet the current IRS requirements. There were no significant changes to the Plan provisions from this restatement.

The Plan includes an employees' thrift savings plan established under the provisions of Internal Revenue Code Section 401(k). Under the savings plan, a certain percentage of employees' wages, as defined in the Plan, can be deferred as an employee contribution to the Plan.

**Automatic Enrollment** - Employees who first become eligible to participate in the Plan on or after June 1, 2014, who fail to affirmatively make any deferral election (including an election to contribute 0% of eligible compensation) within the time prescribed by the Administrator, shall be deemed to have elected to defer 3% of eligible compensation as a pre-tax contribution. Participants may change such deferral percentage at any time with the change being effective on the first day of the month following the election. Contributions received under this automatic enrollment feature are invested in the Fidelity American Funds based on the participant's expected retirement date until changed by the participant. Participants may elect to have their deferral rate increased automatically by 1% annually up to a maximum of 10% unless participants elect otherwise.

**Contributions** - Participants may contribute up to 75% of pretax eligible compensation up to the maximum percentage and amount allowed under the Internal Revenue Code. Participants may designate all or a portion of their elective deferrals as Roth elective deferrals. Contributions made by "highly compensated" employees may be restricted to satisfy Internal Revenue Code nondiscrimination rules. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans.

Discretionary matching and profit-sharing amounts may be contributed at the option of the Company's Board of Directors. Participants must be an active participant and be employed on the last day of the plan year and have attained the age of eighteen. Also, each participant is to receive an amount identical to the amount received by all other eligible participants. For the year ended December 31, 2024, the Company elected to make discretionary profit-sharing contribution to the Plan in an amount of \$67,600, of which \$34,000 was recorded as receivable at December 31, 2024.

**Participants' Accounts** - Each participant's account is credited with (a) the participant's contribution, (b) the employer's discretionary matching contribution, (c) the employer's discretionary profit-sharing contribution, if any, (d) plan earnings and (e) plan expenses, if any. Allocations of plan earnings are based on account balances, as defined. The benefit which a participant is entitled to is the benefit that can be provided from the participant's vested account.

**Note 1 - Description of the Plan (Continued)**

**Vesting** - Participants are immediately vested in their rollover and salary deferral contributions plus actual earnings thereon. Vesting in the employer discretionary match and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after three years of credited service.

**Investment Options** - Upon enrollment in the Plan, and at any time during the plan year, participants may direct their contributions in one percent increments to various investment options comprised of certain selected mutual funds and a stable value fund. Participants may reallocate their funds or redirect new contributions daily among any of the offered funds.

**Notes Receivable from Participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined regularly by the plan administrator. Principal and interest are paid ratably through payroll deductions. Generally, notes must be repaid within five years unless being used to purchase a principal residence in which the loan repayment period may not extend beyond ten years. Participants may have only one note outstanding at a time.

**Forfeitures** - Forfeitures can be used to reduce plan expenses related to the administration of the Plan. Any remaining amounts will be evenly allocated to the accounts of eligible participants. For the year ended December 31, 2024, forfeitures of \$2,189 were allocated to the accounts of eligible participants. No forfeitures were used to reduce plan expenses during 2024. As of December 31, 2024 and 2023, unallocated forfeitures amounted to \$465 and \$0, respectively.

**Payment of Benefits** - Upon retirement, disability or death, participants or beneficiaries are entitled to a distribution equal to the total value of the participant's vested account. Upon termination of service, a participant may generally elect to receive the value of their vested account in a lump-sum cash payment, a rollover distribution to an eligible retirement account or a combination of both payout options. If the balance is greater than \$7,000, the participant or beneficiary may elect to defer payment of benefits until a minimum distribution is required. Vested account balances of \$1,000 or less are automatically distributed to the participant in the form of a lump sum payment unless an alternative distribution election is made by the participant. Effective January 1, 2024, for balances greater than \$1,000, but less than \$7,000, benefit payments are rolled over into an IRA account for the benefit of the participant unless an alternative distribution election is made by the participant. If the balance is greater than \$7,000, the participant or beneficiary may elect to defer payment of benefits until a minimum distribution is required to be made. Participants may also withdraw from their elective deferrals upon certain hardship situations defined in the Plan or withdraw their funds upon attainment of age 59 ½.

**Plan Amendment and Termination** - The Plan may be amended at any time by the Board of Directors, provided that no such amendment may deprive participants of their vested benefits. Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts, and the assets would be distributed to participants in accordance with the terms set forth in the Plan.

**Administrative Expenses** - Generally, the Company pays the administrative expenses relating to the Plan except those relating to advisor fees, plan administration fees, and transaction-based fees which are paid by the Plan's participants. Investment management fees charged to the Plan for all investments are deducted from income earned daily and are not separately reflected. Consequently, investment management fees are reflected as a reduction of realized and unrealized gains, net in the fair value of investments. Advisor fees and plan administrator fees are paid by the Plan's participants. Transaction-based fees for origination of notes receivable and distributions are paid directly by the individual participant. During the plan year ended December 31, 2024, fees paid by the Plan's participants amounted to \$32,574.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with U.S. generally accepted accounting principles.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefit during the reporting period, and disclosures of contingent assets and liabilities, if applicable, at the date of the financial statements. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - All investments are recorded at fair value in these financial statements. Fair value is measured in accordance with U.S. generally accepted accounting principles, as more fully described in Note 4. The net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis or, if not materially different, the settlement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Unit Values** - Individual participant accounts for the Putnam Stable Value Fund are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the trust but do have an interest therein represented by units which are valued daily. The trust earns interest which is automatically reinvested in additional units. Generally, contributions to and withdrawals from the trust are converted to units by dividing the amount of such transactions by the unit values as last determined and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable are reclassified as distributions in accordance with the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits** - Benefits are recorded when paid.

**Income Tax Status** - The Plan operates under a Fidelity Volume Submitter Plan. The Volume Submitter Plan document being utilized obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Since that date, the Plan has been amended. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In determining the recognition of uncertain tax positions, the Plan applies a more-likely-than-not recognition threshold and determines the measurement of uncertain tax positions considering the amounts and probabilities of the outcomes that could be realized upon ultimate settlement with taxing authorities. As of December 31, 2024, the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is generally subject to potential examination by taxing jurisdictions for the prior three years. There are no tax audits in progress for any tax periods.

**Subsequent Events** - The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is the date of the Independent Auditor's Report which is the date the financial statements were available to be issued.

**Note 3 - Information Certified by Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and realized and unrealized gains and losses, net, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**Note 4 - Fair Value Measurements**

Fair value is defined under U.S. generally accepted accounting principles as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan is required to maximize the use of observable inputs, minimize the use of unobservable inputs, and disclose in the form of an outlined hierarchy the details of such fair value measurements. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions. The fair value hierarchy is based on three levels of inputs as follows:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than those included in Level 1. For example, quoted prices for similar assets in active markets or quoted prices for identical assets in inactive markets.

Level 3 - Unobservable inputs reflecting management's own assumptions about the inputs used in estimating the value of the assets.

The following is a description of the Plan's valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund and calculated at the close of business on the NYSE. The NAV is based on the value of the underlying asset owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in mutual funds are classified within Level 1 of the valuation hierarchy.

***Common Collective Trust ("CCT")***

The Plan's investment in a common collective trust consists of an investment in a stable value fund. The stable value fund is composed primarily of guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions valued at the Net Asset Value (NAV) of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The common collective trust fund does not have any unfunded commitments relating to its investments, and participant directed redemptions have no restrictions. If the Plan initiates a full redemption of the stable value fund the issuer reserves the right to require twelve months notification to ensure that securities liquidations will be carried out in an orderly business manner. These investments measured at net asset value per share have not been classified in the fair value hierarchy. The fair value amounts presented in the tables below are intended to permit reconciliations of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**Note 5 - Related Party Transactions**

Certain plan investments are shares of mutual funds and a money market fund managed by Fidelity Management Trust Company, the trustee of the Plan. Accordingly, certain transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, fees paid for advisor and origination of notes receivable and distributions totaling \$32,574 were charged directly to participant accounts and paid to the Plan's trustee. Investment related expenses are included in realized and unrealized gains and losses, net. Notes receivable from participants also qualify as party-in-interest transactions. The Company, as plan sponsor, pays certain administrative expenses of the Plan.

**Note 6 - Notes Receivable from Participants**

As of December 31, 2024, notes receivable from participants bear interest at rates ranging from 4.25% to 9.50% and mature at various dates through July 2029. As of December 31, 2023, notes receivable from participants bear interest at rates ranging from 4.25% to 9.50% and mature at various dates through October 2028.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
