## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Lattimore, Black, Morgan & Cain, P.C. Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audit.

**Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. DESCRIPTION OF THE PLAN**

The following description of the Lattimore, Black, Morgan & Cain, P.C. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan which was adopted to provide retirement benefits for eligible employees of Lattimore, Black, Morgan & Cain, P.C. (the Plan Sponsor). The Plan covers all employees who complete at least 1,000 hours of service during the eligibility computation period, as defined by the Plan, and who are age 18 or older (Participants). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor serves as the Plan administrator and is responsible for the oversight of the Plan.

Effective November 1, 2023, the Plan was amended to change the Plan year from a fiscal year ending May 31 to a calendar year ending December 31.

**Contributions**

Participants may voluntarily make qualified retirement contributions on a pre-tax or after-tax Roth basis to the Plan as provided for under Section 401(k) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor does not make matching contributions, however, the Plan Sponsor may make discretionary nonelective contributions allocated among the Participants based on employment group. In order to receive the nonelective contribution, Participants must be employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Plan Sponsor contributed 3% of eligible compensation for all eligible employees, except managing directors of the corporation who received 6% of eligible compensation. Owners of the corporation received 9% of eligible compensation. The Plan Sponsor contributed \$2,930,078 and \$1,656,451 for the year ended December 31, 2024 and for the period June 1, 2023 to December 31, 2023, respectively. Plan Sponsor receivables represent amounts approved by the Plan Sponsor for contribution to the Plan that have not yet been funded by the Plan Sponsor.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants in the Plan may contribute up to the Internal Revenue Service (IRS) limitations. Participants may change their contribution percentages any time.

Each newly eligible employee is automatically enrolled in the Plan unless they elect not to participate. An automatically enrolled Participant contributes 3% of eligible compensation that is invested in a designated balanced fund until changed by the Participant. The automatic elective deferral contribution will be automatically increased as soon as administratively feasible the first day of the new Plan year in a 1% increment each year (for two years) with a maximum automatic elective deferral contribution of 5% of compensation if the Participant did not change the initial automatic enrollment amount.

**Participant Accounts**

Each Participant's account is credited or charged with Participant and Plan Sponsor contributions, investment income (losses), and administrative expenses. Allocations are based on Participant compensation or account balances as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

**Vesting**

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's contribution is based on years of continuous service.

A Participant is vested in the Plan Sponsor's contributions at the rate of 20% per year of credited service, as defined, starting with the second year of service, and all amounts are fully vested after six years of credited service. In the event of disability, as defined in the Plan document, or death, a Participant becomes fully vested in their account balance.

**Investment Options**

Upon enrollment in the Plan, a Participant may direct their contributions in any of the investment options provided under a custodial agreement with Fidelity Personal Trust Company, FSB (the Custodian). Participants may change their investment options at any time.

**Notes Receivable from Participants**

Each Participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. A Participant may have no more than two loans outstanding at one time. The notes receivable from Participants are secured by the balances in the respective Participants' accounts and bear interest at annual rates determined by the recordkeeper. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, permanent disability or retirement, a Participant may receive a lump-sum payment equal to his or her entire account. For termination of service for other reasons, a Participant may receive the value of the vested interest in their account as a lump-sum distribution or elect to leave the vested balance in their account. Hardship withdrawals are permitted under certain instances, as defined in the Plan document. Participants who terminate employment with a vested account balance of \$5,000 or less will have their account automatically rolled over to an IRA unless they specify a payment option.

**Forfeitures**

Forfeitures are created when Participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures are used to reduce the Plan Sponsor's future contributions to the Plan. There were no unallocated forfeitures as of December 31, 2024 or 2023. For the year ended December 31, 2024 and the period June 1, 2023 to December 31, 2023, Plan Sponsor contributions were reduced by \$369,226 and \$161,356 due to forfeited accounts, respectively.

**Transfers from Affiliated Plan**

Transfers from affiliated plan represents the transfer of Participant balances from an affiliated defined contribution benefit plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from Participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a Participant defaults on a loan and has reached a distributable event, the defaulted loan is considered a distribution and included with benefits paid to Participants.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor or through a revenue sharing arrangement with the Custodian. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees paid through revenue

sharing are included within administrative expenses. The Plan pays outside service providers for administrative expenses such as investment advisory fees, disbursement payment fees and recordkeeping fees and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 855, *Subsequent Events*.

**3. INFORMATION CERTIFIED BY CUSTODIAN**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividend income for the year ended December 31, 2024 and for the period June 1, 2023 to December 31, 2023, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Custodian. The Plan administrator has obtained certifications from the Custodian that the investment-related information is complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques

used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market account:* Valued at the NAV of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. PARTY-IN-INTEREST TRANSACTIONS**

The Retirement Plan Company, LLC, recordkeeper for the Plan, provides investment advisory and recordkeeping services for the Plan and, therefore, qualifies as a party-in-interest. The fees paid for investment advisory and recordkeeping are included in administrative fees on the financial statements and qualify as exempt party-in-interest transactions. For the year ended December 31, 2024 and December 31, 2023, Plan Sponsor received approximately \$2,706 and \$1,100 in revenue sharing income from the Custodian, which was used to pay administrative fees. The Plan

also invests in investments sponsored by the Custodian of the Plan and, therefore, these investments qualify as exempt party-in-interest transactions. Party-in-interest transactions also include loans made to Participants.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become 100% vested in their Plan Sponsor contributions.

## **7. TAX STATUS**

The Plan has adopted a prototype nonstandardized pre-approved profit-sharing plan with cash or deferred arrangement (CODA) sponsored by The Retirement Plan Company, LLC. The IRS has determined and informed The Retirement Plan Company, LLC by an opinion letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. The prototype plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, no provision for taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
