We have audited the financial statements of the Mole Lake Casino 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024, and we have issued our report thereon dated September 15, 2025. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management’s knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The most sensitive estimates affecting the financial statements were the estimates of the fair value of investments which were disclosed in Note 4 to the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

*Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

*Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

*Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No misstatements were identified during the audit.

*Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified no such reportable findings during the audit.

*Disagreements with Management*

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. *Management Representations*

To our knowledge, there were no such consultations with other accountants.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

*Other Matters*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to the Financial Statements

December 31, 2024 and 2023

### 1. Description of the Plan

The following description of Mole Lake Casino 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (the “Code”) covering all employees of Mole Lake Casino (the “Organization”). The Plan sponsor and administrator is Sokaogon Gaming Enterprise Corporation. The trustee and custodian of the Plan is Mid Atlantic Trust Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is currently in conformity with all Internal Revenue Service (“IRS”) and Department of Labor rules and regulations.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act (“Secure 2.0 Act”) was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act for the years ended December 31, 2024 and 2023. Plan management expects the Plan to be formally amended prior to the Secure Act 2.0 deadline.

#### *Eligibility*

Employees are eligible to participate in the Plan and make salary reduction contributions upon attaining the age of 18 and completing two months of service with the Organization. Employees are eligible to receive employer matching and non-elective contributions upon attaining the age of 18 and completing one year of service with the Organization. Nonresident aliens are excluded from participating in the Plan.

#### *Contributions*

Under the terms of the Plan, eligible employees may elect to defer any amount of their annual compensation limited to a maximum annual amount specified by the IRS (\$23,000 for employees under age 50 and \$30,500 for employees ages 50 and over). Deferrals may be made on a pre-tax and/or after-tax (Roth) basis through salary deductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Effective September 1, 2024, the Plan was amended to change the Organization’s matching contribution from 200% of each employee’s contribution up to 2% of eligible compensation to 100% of each employee’s contribution up to 4% of eligible compensation. In addition, the non-elective contributions equal to 1% of the eligible compensation were eliminated. For the year ended December 31, 2024 the Organization made matching contributions and non-elective contributions of \$122,856 and \$26,944, respectively.

## 1. Description of the Plan (Continued)

### *Participant Accounts*

Each participant's account is credited with the participant's contribution, including the earnings and losses on these contributions, and an allocation of the Organization's matching and non-elective contributions. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Investment Options*

The Plan provides a variety of investment options with differing risk and growth characteristics. As of December 31, 2024 and 2023, the Plan's net assets available for benefits were invested in mutual funds. Participants may change their investment allocations and transfer their account balances among the various funds at any time.

### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contributions plus earnings thereon is based on years of service in accordance with the following schedule:

|-------------------------|---------------|
| Less than 1             | 0%            |
| 1                       | 20%           |
| 2                       | 40%           |
| 3                       | 60%           |
| 4                       | 80%           |
| 5 or more               | 100%          |

Participants also become fully vested in the Organization's contributions at their normal retirement age of 65, due to disability, upon death and upon termination of the Plan.

### *Notes Receivable from Participants*

Participants may borrow from their accounts, subject to Code regulations, up to the lesser of a) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the current outstanding balance of loans as of the date of the new loan; b) 50% of the vested balances in the Plan. The minimum loan amount is \$1,000. Loans are required to be repaid within five years of the date of the loan issue except for a home loan which is payable in ten years. The outstanding loans are secured by the balance in the participant's account. The interest applied to the loan is the prime interest rate plus one percent. Principal and interest are paid ratably through payroll deductions. Interest rates on participant loans ranged from 9.25% to 9.50% as of December 31, 2024. The notes mature through June 2027. The unpaid balance of any loan is immediately payable upon termination of employment and may be offset against the participant's vested account.

## 1. Description of the Plan (Continued)

### *Benefit Payments and Withdrawals*

Benefits start on a participant's normal retirement date if the participant is no longer an employee and has a vested account under the Plan. The participant may choose to have benefits paid on this date even if the participant is still an employee. Normal retirement means the first day of the month on or after the participant reaches age 65. If a participant's employment ceases as a result of termination, normal retirement, death or disability, the participant or participant's beneficiaries are entitled to receive the value of the participant's vested interest. Participants or their beneficiaries may receive benefit payments in a lump-sum amount equal to the value of the participant's vested interest, in installments over a period determined by the participant, or a direct transfer to a qualified plan of equivalent value. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### *Forfeited Accounts*

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used to reduce employer contributions. During 2024, forfeitures of \$1,422 were used to reduce employer contributions. The forfeiture account balance was \$0 as of December 31, 2024 and 2023.

### 2. Summary of Significant Accounting Policies (Continued)

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. In accordance with the Plan's policy of stating investment at fair value, net unrealized gains for the year are included in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold, as well as unrealized gains and losses on investments held during the year.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

### 3. Information Prepared and Certified by the Trustees

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, investments at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee of the Plan.

### 4. Fair Value Measurements

The FASB Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC, Fair Value Measurements and Disclosures, are described below.

- **Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- **Level 2** - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for financial instruments measured at fair value:

*Mutual funds*: Valued at the quoted market price of shares held by the Plan at year end.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following table sets forth, by level within fair value hierarchy, the Plan’s invested assets as of December 31:

### 5. Related Party and Party-In-Interest Transactions

The Plan engages in transactions involving acquisition or disposition of units in funds managed by the trustees. The Plan allows participants to borrow from their vested balances. These transactions qualify as party-in-interest transactions. All of these transactions are exempt from prohibited transaction rules under ERISA.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

### 7. Tax Status

The Plan sponsor adopted a non-standardized prototype plan, which received a favorable IRS opinion letter dated November 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes have been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes a position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
