NOTE A - DESCRIPTION OF THE PLAN

The following description of the Andis Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees within Andis Company (the Company). Employees must have completed 60 days of service and have attained 18 years of age before being eligible to make salary deferrals into the Plan. Employees must complete one year of service and attained 18 years of age before being eligible to receive the Company's matching contribution. There are no eligibility requirements for the annual discretionary contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Participant Contributions

All newly eligible employees are automatically enrolled in the Plan with a deferral rate of 5%. The employee may make an affirmative election to opt out of the Plan by completing a salary reduction agreement. Each participant may elect to contribute from 1% to 100% of his or her eligible salary, or a specific dollar amount, up to the maximum amount allowed under the Internal Revenue Code (IRC) to be allocated to his or her account. The participants choose to direct a percentage of their contributions to any of the available fund options. Contributions are made through payroll deductions.

Company Contributions

The Company matches the employee contribution with a discretionary amount determined by the Company. For the period of January 1, 2024 through February 29, 2024 and for the year ended December 31, 2023 the Company elected to match 50% of the first 8% of eligible participants' contributions. For the period of March 1, 2024 through December 31, 2024 the Company elected to match 50% of the first 5% of eligible participants' contributions. In addition, the Company may make an annual discretionary contribution to the Plan. There were no additional annual discretionary contributions made by the Company during the years ended December 31, 2024, and 2023. Company contributions are allocated in the same manner as participant contributions. Rollover contributions are also permitted under the Plan.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's voluntary contribution and Company contributions, charged with withdrawals and credited with an allocation of Plan earnings, net of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' contributions and earnings are immediately 100% vested. A graduated vesting schedule is used for Company contributions and earnings thereon, as shown by the following:

Payments of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive the balance of his or her account in a lump-sum payment or a portion of his or her entire balance, as defined. A participant whose service is terminated for any other reason is entitled to the distribution of the then-vested portion of the account balances. Participants having an immediate and heavy financial hardship without any other source of funds may request a hardship withdrawal of their vested balance.

Forfeitures

Forfeitures of the non-vested portion of participant accounts may be used to pay administrative expenses of the Plan or to reduce Company matching or discretionary contributions. There was \$36,891 and \$71,138 of forfeitures used to reduce the Company's contributions or pay administrative expenses of the Plan for the years ended December 31, 2024 and 2023, respectively. There were \$55,847 and \$1,079 of unallocated forfeitures from non-vested accounts as of December 31, 2024 and 2023, respectively.

Income Taxes

The Plan has adopted the Volume Submitter Defined Contribution Plan, which is a Lincoln Retirement Services Company LLC (Lincoln) Volume Submitter Plan, effective September 4, 2018. The Internal Revenue Service (IRS) has determined and informed Lincoln, by a letter dated March 31, 2014, that the Volume Submitter Plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC; therefore, the Plan administrator believes that the Plan was qualified and that the related trust was tax-exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America (U.S. GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

The Plan is primarily responsible for the payment of Plan fees and expenses, which are expensed as incurred; however, the Company, in its discretion, may decide to pay all or some of these expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The financial statements are prepared under the accrual basis of accounting in accordance with U.S. GAAP.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions to Plan assets during the reporting period. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the Lincoln Stable Value Account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

The net appreciation (depreciation) in fair value of investments reflected in the accompanying statements of changes in net assets available for benefits represents the difference between fair value and the cost of the investments as well as the realized gain or loss on sales of investments, measured by the difference between the proceeds received and the cost of investments sold. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Benefits Paid to Participants

Benefits are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value and their classification in the valuation hierarchy as of December 31. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the closing price reported on the active market on which the individual securities are traded.

Collective trust funds - Valued at the net asset value (NAV) of shares held by the Plan at year end. The collective trust funds do not have a finite life, unfunded commitments related to these types of investments, or significant restrictions on redemptions. These funds invest in investment contracts and security-backed contracts. The funds' investment objectives are to protect principal while providing a higher rate of return than shorter maturity investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - GUARANTEED AND FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Lincoln Stable Value Account is a fixed annuity contract issued by the Lincoln National Life Insurance Company. The annuity is offered through a variety of contract types, including fixed annuity, stable value and a stable value separate account. The type of contract through which a participant invests in the Lincoln Stable Value Account determines the applicability of certain account features, such as the guaranteed minimum interest rate (GMIR), the distribution or payout requirements upon termination and participant-initiated transfers.

No event will result in the Plan not being able to receive contract value over a five-year installment period. Any of the following events can trigger termination by the issuer, resulting in the Plan not being able to receive immediate contract value:

- a. Any changes billed to the client contract owner haven't been paid to Lincoln within 30 days.
- b. The Plan ceases to meet the requirements of the IRC for purchasers of this contract.
- c. At any time following the end of the third contract year, the contract owner's account balance is less than \$15,000.
- d. At any time following the end of the third contract year, there is no deposit activity for a 25 consecutive month period and the contract owner's account balance is less than \$50,000.
- e. The contract owner fails to furnish requested information or other documentation.
- f. Lincoln discovers any misrepresentation of material information.
- g. Lincoln discontinues offering this contract form to the public.
- h. The Plan terminates its recordkeeping agreement with Lincoln.

Transactions involving the funds administered by Lincoln Financial, the trustee of the Plan, are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE F - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Assets held as of December 31, 2024, as shown on schedule H, line 4i - schedule of assets (held at end of year).

The Plan's independent certified public accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related amounts included in the accompanying financial statements and supplemental schedule.

NOTE G - RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect employees' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become fully vested upon termination of the Plan.

NOTE I - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through September 8, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the accompanying financial statements except as noted below.
