## **INDEPENDENT AUDITORS' REPORT**

Plan Administrator and Participants  
Strippit, Inc. Pension Plan for Hourly Employees

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Strippit, Inc. Pension Plan for Hourly Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Strippit, Inc. Pension Plan for Hourly Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### **1. Description of Plan**

The following description of the Strippit, Inc. Pension Plan for Hourly Employees (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a non-contributory defined benefit pension plan sponsored by Strippit, Inc. (the Company). All full-time employees who are represented for collective bargaining purposes by Local 1691 (the Union) are eligible for participation in the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration

The Company is responsible for the general administration of the Plan and carrying out the Plan's provisions. In 2024, Vanguard Fiduciary Trust Company and Fidelity Brokerage Services, LLC served as the trustees and the custodians of the Plan's assets. The Company pays certain administrative expenses of the Plan.

#### Eligibility

Effective October 31, 2003, benefits under the Plan were frozen. Prior to that date, an employee was eligible to participate in the Plan after completion of one year of service if the employee worked at least 1,700 hours during that time. No new participants are permitted to enter the Plan.

#### Vesting

Participants became 100% vested upon the completion of five years of credited service. A year of credited service was granted for each plan year in which an employee worked at least 1,700 hours of service. The Plan was frozen on October 31, 2003; therefore, no additional years of credited service will be earned after that date.

#### Payment of benefits

Under the Plan, a participant is eligible for normal retirement benefits upon attaining age 65 or on the fifth anniversary of employment if hired after age 60. The Plan also has provisions for early retirement benefits. The normal monthly retirement benefit is equal to \$26 for each year of credited service. The Plan provides for early and disability retirement benefits at reduced levels upon completion of certain age and service requirements. Benefits are payable in the form of joint and survivor annuity, single life annuity or a lump sum payment.

### **1. Description of Plan** (Continued)

#### Funding policy

Employees are neither required nor permitted to contribute to the Plan. The Company makes contributions to the Plan as determined by its actuary to be required under accepted actuarial principles in order to meet the minimum funding requirements of ERISA. The Company's contribution amounted to \$-0- for both the years ended December 31, 2024 and 2023 which met or exceeded the minimum funding requirements of ERISA.

#### Administrative expenses

Record keeping, fiduciary fees, tax filings, actuarial services and audit fees are paid by either the Plan or the Plan Sponsor. Investment commissions are paid from the Plan's assets and are charged directly to the related investment earnings in the year incurred. For 2024 and 2023, administrative expenses consisted of the following:

### **2. Summary of Significant Accounting Policies**

#### Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for plan benefits and changes in those net assets.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Cash and cash equivalents

The Plan considers all highly liquid investments with a maturity of three months or less to be cash and cash equivalents.

#### Investments

The Plan's investments were stated at fair market value. Shares of registered investment companies were valued at quoted market prices which represented the net asset value of shares held by the Plan at year end. Investment income (loss) and administrative expenses were allocated to the individual plans based upon average monthly balances invested by each plan.

#### Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of benefits

Benefits are recorded when paid.

#### Actuarial present value of accumulated plan benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to services rendered by employees through October 31, 2003, at which time participants stopped accruing benefits. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits payable under all circumstances (retirement, death, disability and termination of employment) are included to the extent they are deemed attributable to employee service rendered through October 31, 2003.

#### Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

#### Fair value measurements (Continued)

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash equivalents:* Includes money market accounts, certificates of deposit and all highly-liquid debt instruments purchased with an original maturity date of three months or less.

*Mutual funds:* Values are determined based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value of these investments is subject to market volatility and may be susceptible to fluctuations.

### **2. Summary of Significant Accounting Policies** (Continued)

#### Risks and uncertainties

Contributions to the Plan and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates and demographics. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the changing nature of these assumptions and the level of risk associated with investment securities, it is at least reasonable possible that changes in these assumptions and in the values of investment securities will occur in the near term. Additionally, such changes could materially affect accumulated benefit obligations and the amounts reported in the statements of net assets available for plan benefits.

#### Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The Plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

#### Plan management's review of subsequent events

The plan administrator evaluated events occurring between the end of the most recent plan year and September 4, 2025, the date the financial statements were available to be issued.

### **3. Accumulated Plan Benefits**

The actuarial present value of accumulated plan benefits is determined by an actuary and is that amount which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, termination or retirement) between the valuation date and the expected date of payment.

### **6. Related Party Transactions**

In 2024, Vanguard Fiduciary Trust Company and Fidelity Brokerage Services, LLC served as the trustees and the custodians of the Plan's assets. The Plan invested in shares of mutual funds managed by affiliates of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company acted as the custodian for only those investments as defined by the Plan. Transactions in such investments qualified as party-in-interest transactions which were exempt from prohibited transactions rules. Administrative fees paid to Vanguard Fiduciary Trust Company amounted to \$13,450 and \$13,186 for the years ended December 31, 2024 and 2023, respectively. On December 23, 2024, the Plan transitioned from Vanguard Fiduciary Trust Company to Fidelity Brokerage Services, LLC and assets were held in money market funds managed by affiliates of Fidelity Brokerage Services, LLC. Administrative fees paid to Fidelity Investments amounted to \$812 and \$-0- for the years ended December 31, 2024 and 2023, respectively.

### **7. Tax Status**

The Plan obtained its latest determination letter on July 16, 2002 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable provisions of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since receiving this determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### **8. Investment Risks**

The Plan invests in various investment securities. Investments in securities are generally exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### **9. Plan Termination**

The Company reserves the right under the Plan to terminate the Plan subject to the provisions set forth in the Plan and ERISA.

In the event that the Plan is terminated, the net assets of the Plan will be allocated for payment of benefits to the participants in the order of priority as determined in accordance with ERISA, applicable regulations thereunder and the plan document, as follows:

- a) Benefits former employees or their beneficiaries have been receiving, or that employees eligible to retire would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority is limited to individuals in pay status, or eligible to be in pay status as of three years prior to the plan termination date. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the three years preceding Plan termination.
- b) Other benefits guaranteed under Title IV of ERISA.
- c) All other nonforfeitable benefits.
- d) All other benefits.
- e) Funding in excess of vested benefits reverts back to the respective employer.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination, subject to a statutory ceiling on the amount of an individual's monthly benefit.

Whether all participants receive their benefits should the Plan be terminated at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, the priority of those benefits to be paid and the level and type of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guarantee while other benefits may not be provided for at all. (See **Subsequent Event**)

### **10. Subsequent Event**

The Plan Sponsor, subsequent to year end, has indicated that they will be terminating the Plan subject to the provisions set forth in the Plan and ERISA. The Plan termination is expected to occur in October, 2025.

### ***Actuarial Cost Methods:***

#### **Traditional Unit Credit**

The actuarial cost method used in the valuation was the traditional unit credit cost method.

The normal cost is the sum of all the individual normal costs for each participant. For active participants, the individual normal cost is the present value of the benefit earned during the year being valued. The normal cost is zero for active participants whose credited service equals or exceeds the plan maximum, and for non-active participants.

The actuarial accrued liability is the sum of the individual accrued liabilities for all participants. The individual accrued liability for an active participant is the present value of the accrued benefit as of the valuation date. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded liability is the actuarial accrued liability less the valuation assets.

The total annual cost of the plan is the normal cost plus an amount to amortize the shortfall amount.

#### **Projected Unit Credit**

The actuarial cost method used in the development of the maximum contribution and the at-risk liabilities, if applicable, was projected unit credit cost method.

Under this method, the normal cost is the sum of the individual normal costs for all participants. For an active participant, the individual normal cost is the present value at the current age of the projected benefit at the assumed retirement age, based on the actuarial assumptions, divided by the participant's expected years of credited service at that age. For a non-active participant, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all plan participants. For an active participant, the individual accrued liability is the product of the normal cost and the total years of credited service at the current age. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded actuarial accrued liability equals the actuarial accrued liability less the valuation assets.

### ***Asset Valuation Method:***

The actuarial value of the assets is determined by using the average value of the fair market value of the plan's assets at the valuation date over a 24 month period adjusted for contributions, distributions, expected earnings, and includes contributions receivable discounted to the plan year end. The asset value determined under this method is adjusted to be no greater than 110% and no less than 90% of the fair market value of assets.

### ***Participants included in valuation:***

All employees who are eligible to participate as of the valuation date, plus retirees, beneficiaries and terminated participants entitled to current or future benefits.

## **Schedule SB, Part V – Statement of Plan Provisions**

### ***Eligibility***

All full-time, permanent employees who are members in good standing in the Union, International Association of Machinists and Aerospace Workers, Local Lodge 1691, District 76 Workers enter on their date of employment. No new participants enter the plan after October 31, 2003.

### ***Credited Service***

Service is credited for each plan year in which the participant works 1,700 hours. Fractional credit is given for any year in which the participant works less than 1,700 hours, to the nearest 1/10 of a year. No service is credited after October 31, 2003.

### ***Vesting Credit***

Vesting credit is earned for each plan year in which a participant works 1,000 hours.

### ***Normal Retirement***

#### Eligibility

The earlier of age 62 and completion of 10 years of credited service, or age 65.

#### Amount of Benefit

Monthly benefit of \$26.00 multiplied by Service. The accrual rate increase from \$21 was adopted in August, 2001 retroactive to February 7, 2000. Benefit accruals ceased as of October 31, 2003.

### ***Early Retirement***

#### Eligibility

Attainment of age 55 and Rule of 85, or age 60 and 10 years of credited service.

#### Amount of Benefit

Accrued benefit based on service at Early Retirement prior to age 62 reduced 0.5% for each month benefit commences prior to age 62.

### ***Disability***

#### Eligibility

At any age following 10 years of service.

#### Amount of Benefit

Monthly benefit is the accrued benefit at date of disability.

### ***Death Benefit***

#### Eligibility

After 5 years of service

One-half of the benefit that would have been paid if the participant had retired the day before he died under the joint and survivor option. Benefits are paid immediately or at the participant's early retirement age, if later. If participant is age 40 or greater with at least 10 years of service, benefit is 50% of accrued benefit payable immediately.

## ***Vesting***

### Eligibility

5 years of service

### Amount of Benefit

Accrued benefit payable at normal retirement date or at early retirement. If paid at early retirement, the benefit is reduced for actuarial equivalence for benefit commencement prior to age 62.

## ***Normal Form of Payment***

If married, benefits are paid in the form of a joint and survivor annuity. If not married, benefits are payable for the life of the participant.

## ***Optional Forms of Payment***

The plan provides the following forms of payment: Life annuity and 50%, 55%, and 75% Joint and Survivor annuities.

## ***Assumptions for Optional Forms of Payment***

Optional forms of payment are calculated by multiplying the monthly pension benefit payable at the time of retirement by a percentage based upon the following formulas:

*Life Annuity:* 100%;

*50% Joint and Survivor Annuity:* 100%; however, if the Spouse is more than 5 years younger than the Participant, the 100% factor is reduced 2% for each full year and proportionately for any fractional part of a year the age difference exceeds 5 years.

*55% Joint and Survivor Annuity:* 90% if the dates of birth of the Participant and the Participant's spouse are within 12 months of each other. If the spouse is at least 12 months older than the Participant, the 90% factor is increased by .5% for each full 12 month period by which the spouse's age exceeds the Participant's age (not to exceed 100%); if the spouse is at least 12 months younger than the Participant, the 90% factor is decreased by .5% for each full 12 month period by which the spouse's age is less than the Participant's age.

*75% Joint and Survivor Annuity:* 85% if the dates of birth of the Participant and the Participant's spouse are within 12 months of each other. If the spouse is at least 12 months older than the Participant, the 85% factor is increased by .5% for each full 12 month period by which the spouse's age exceeds the Participant's age (not to exceed 100%); if the spouse is at least 12 months younger than the Participant, the 85% factor is decreased by .5% for each full 12 month period by which the spouse's age is less than the Participant's age.

## ***Contributions***

The employer pays the total cost of the plan.

**Schedule SB, Line 22 – Description of Weighted Average Retirement Age**

The assumed retirement age is 65.
