



Credited years are plan years from date of hire excluding the following:

Years before the effective date  
Years before age 18  
Years with less than 1,000 hours

**Top-Heavy Minimum Benefit**

Top-heavy minimum benefits are provided under another plan of the employer

**Top-Heavy Status**

A plan is top-heavy if over 60% of the value of all accrued benefits in all of the employer's plans are for the benefit of key employees. A key employee is generally an officer or owner of the company. This plan is currently top-heavy.

**Death Benefit**

Proceeds of any insurance policies on the life of the participant plus the actuarial equivalent of the accrued benefit earned to date of death less the cash value of such policies but in no event more than the reserves under a typical Individual Level Premium funding method

**Cash Balance**

The annual Interest Crediting Rate for this plan year is 5.00%
