## **Independent Auditors' Report**

### ***Opinion***

We have audited the financial statements of BBL Companies 401(k) Retirement Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes To Financial Statements

**Note 1: Description Of Plan**

The following description of the BBL Companies 401(k) Retirement Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan was adopted on January 1, 1996 and is a defined contribution plan covering all employees of BBL Construction Services, LLC and Affiliates (the Companies) who are at least 18 years of age and are not considered an excluded employee as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Currently, the Companies are contributing at a mandatory rate of 3% of eligible compensation. The Companies may make matching contributions to the Plan at the discretion of Plan management. For the years ended December 31, 2024 and 2023, employer matching contributions were 50% of employee contributions up to 4% of eligible compensation. Members of a union covered by a collective bargaining agreement where retirement benefits were a subject of good faith negotiations are eligible to make elective employee contributions, rollover contributions, and to receive the employer matching contribution but are not eligible for the mandatory 3% employer contribution. The Companies may also make discretionary profit sharing contributions to the Plan at the discretion of Plan management. The Companies did not make discretionary profit sharing contributions for the years ended December 31, 2024 and 2023. Participants can contribute 100% of compensation subject to Internal Revenue Code limitations and employees who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with Internal Revenue Code provisions. Participants may also contribute amounts representing distributions from other qualified plans. In accordance with the provisions of the Plan, each participant has the right to direct the investment of their employee and employer contributions and any rollover/transfers, if applicable, into the Plan.

Participant accounts - Each participant's account is credited or charged, as applicable, with all participant contributions and allocations of the Companies' contributions, transfers, plan earnings (losses), payments, forfeitures, withdrawals, expenses, or other distributions made to or from such accounts during the period. Allocations are based on participant earnings or account balances, in accordance with terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested 100% in the 3% "safe harbor" non-elective contribution. Participants in the profit-sharing accounts and matching accounts become fully vested over a six-year period, or earlier, in accordance with the provisions of the Plan. The vesting schedule applicable for each individual is based on dates of participation.

**Note 1: Description Of Plan (Continued)**

Participants' loans - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and are made in accordance with the terms of the Plan.

Payment of benefits - On termination of service due to death, disability, retirement, or separation from service, a participant or their beneficiary will be entitled to receive a distribution of his/her total vested account balance. Benefits will be paid in accordance with terms of the Plan.

Plan termination - Although it has not expressed any intention to do so, the Companies have the right, under the Plan, to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, each participant's account will become fully vested and be distributed in accordance with the Plan Agreement.

**Note 2: Summary Of Significant Accounting Policies**

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

**Note 2: Summary Of Significant Accounting Policies (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Purchases and sales of securities are recorded on a trade-date basis with the gain or loss based upon the average-cost method. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a volume submitter plan which has received an advisory letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on total net assets available for benefits or the change in net assets available for benefits.

**Note 3: Fair Value Measurements**

The following is a description of the valuation methodologies used for assets at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at quoted market prices at year-end.

*Stable Value Fund:* The Stable Value Fund is composed primarily of investment contracts and is valued at the net asset value (NAV) of the units of the portfolio. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. The objective of the Stable Value Fund is to provide preservation of capital and relatively stable returns consistent with comparatively low risk.

*Common Collective Trust:* The value of a fund unit will be based on the net asset value as a practical expedient (NAV) per unit of each of the portfolios in which assets of a fund are invested. The NAV per unit is determined by the portfolio and equals the total value of its assets, less its liabilities divided by the number of its outstanding units. The objective of the Common Collective Trust is to seek long-term capital appreciation by investing, primarily, in equity securities.

The preceding methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Companies provide the Plan with certain accounting and administrative services for which no fees are charged. Certain fees are paid by the Companies for administration of the Plan.

**Note 5: Forfeited Accounts**

Forfeited non-vested accounts at December 31, 2024 and 2023 amounted to \$13,178 and \$7,690, respectively. Forfeitures may be used to reduce employer contributions or pay plan expenses. Forfeitures used to reduce employer contributions and plan expenses during the years ended December 31, 2024 and 2023 amounted to \$19,877 and \$8,374, respectively.

**Note 6: Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7: Commitments And Contingencies**

The Plan follows the guidance for uncertainty in income taxes. As of December 31, 2024, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

**Note 8: Subsequent Events**

Management has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued.
