1. DESCRIPTION OF THE PLAN

The following description of the Molson Coors Consolidated Retirement and Thrift Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined contribution 401(k) savings plan applicable to hourly and salaried union employees of Molson Coors Beverage Company USA LLC (the Company). The Plan was amended and restated effective January 1, 2020.

The Company is the primary sponsor of the Plan. The Company is the successor to MillerCoors LLC and is a wholly owned subsidiary of Molson Coors Brewing Company (MCBC) since October 10, 2016. The Molson Coors Beverage Company USA LLC Benefit Plan Governance Committee (the Committee) is appointed by the Chief Financial Officer and acts as fiduciary for the Plan. In accordance with its power as fiduciary, the Committee has entered into a trust and asset management agreement with Fidelity Management Trust Company (the Trustee).

The Company is obligated to continue the Plan during the terms of several collective bargaining agreements, the latest of which expires on November 1, 2025. While the Company has not expressed any intent to discontinue the Plan after that date, it is not prohibited from doing so.

Each employee covered under the Plan is eligible to become a participant after completion of the eligibility waiting period. Participants are auto-enrolled with contributions of 4% for employees who do not actively elect or opt out before their eligibility date.

Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

Contributions

Participating employees may make voluntary before-tax and/or after-tax Roth contributions collectively (salary reduction contributions) of whole percentages, up to a maximum percentage of pay as defined in the Plan document and up to a maximum limit defined by the Internal Revenue Code (the Code). Some of the Plan's sub-groups may also make traditional after-tax contributions. In addition, catch-up contributions are available to participants who are age 50 or older at the end of the Plan year. Participants may change their voluntary salary reduction contribution at the beginning of any payroll period. The Company also makes Company matching contributions and Company retirement contributions to some of the Plan's sub-groups.

Participants may also contribute amounts representing distributions from other eligible retirement Plans (rollover contributions). All contributions are subject to certain limitations in accordance with Internal Revenue Service (IRS) guidelines.

Participants direct the investment of their salary reduction contributions into various investment options offered by the Plan.

The Plan currently offers stable value funds, mutual funds, pooled separate accounts, and common/collective trusts as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's salary reduction contributions, Company matching contributions (where applicable), Company retirement contributions (where applicable), and Plan earnings/(losses), and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary reduction contributions, Company matching contributions (where applicable), and actual earnings thereon. However, some of the sub-groups in the Plan have a vesting requirement in their accounts attributable to Company retirement contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, minus the highest outstanding loan balance during the previous 12 months immediately preceding a loan application, or 50% of the participant's vested account balance (excluding Company retirement contributions for all but two sub-groups of the Plan that are eligible to include these contributions in the calculation of amounts available for loan and loan proceeds). Loan terms range from 1 to 5 years for general purpose loans and up to 25 years for the purchase of a primary residence.

Notes Receivable from Participants (continued)

The loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to prime rate of interest reported by Reuters News Service on the last business day of the month prior to the month in which the loan application is filed by the participant. As of December 31, 2024 and 2023, interest rates on outstanding loans ranged from 3.25% to 8.50%.

Principal and interest are paid through payroll deductions. However, if a participant terminates employment with the Company, any outstanding loan will become due and payable. Participants may continue to make loan payments from a personal bank account provided the payment is made via Automated Clearing House (ACH).

Payment of Benefits

Participants or their beneficiaries are eligible for distributions upon termination, retirement, death, if the participant continues to be actively employed. In the event of hardship, as defined in the Plan document, participants may withdraw some or all of their vested account balance. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$299,000 and \$53,000, respectively. These accounts are used to reduce future Company contributions. During the years ended December 31, 2024 and 2023, approximately \$0 and \$436,000, respectively, was used to reduce Company contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contracts which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the total cost of the investment (amount paid at time of purchase plus or minus any additional deposits or withdrawals) plus accrued interest. This is also referred to as book value. The Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, the Trustee, and insurance companies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Generally, certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Annual recordkeeping and Trustee service fees are paid for by the Company. Fees related to the administration of participant loans are charged directly to the participant's account balance and are included in administrative expenses. Investment-related expenses are included in the net asset value of investments.

Subsequent Events

The Company evaluated the accompanying financial statements for subsequent events and transactions through September 12, 2025, the date these financial statements were available for issue, and has determined that no material subsequent events have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.

3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation/(depreciation) in the fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the entity has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS (continued)

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the current trading value of shares held by the Plan at year end.

Pooled separate account: Plan assets are represented by a “unit of account” and per unit value whose value is the result of the accumulated values of underlying investments. These investments are primarily equity, fixed income, real estate and short-term cash collective funds, with varying degrees of both market and credit risk. The funds have no unfunded commitments, and participants can redeem their investments on a daily basis, pursuant to the terms of the funds’ declaration of trust.

Common/collective trusts: These are trusts established for the collective investment of assets contributed from employee benefit plans maintained by more than one plan sponsor. Units are valued based on the fair value of the fund's underlying investments, with the fund valued at Net Asset Value observable only indirectly via fund managers by fund participants.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a portfolio of investment contracts that is comprised of one traditional investment contract as well as a synthetic investment contract. These contracts meet the fully benefit-responsive investment contract criteria, and therefore, are reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of contract value between the types of investment contracts held by the Plan.

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract(s), which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The synthetic investment contracts held by the Plan include wrapper contracts that provide a guarantee that the credit rate will not fall below 0%. Cash flow volatility (for example, timing of benefit payments), as well as asset underperformance, can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in each contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed periodically for resetting.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a periodic basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include, but are not limited to the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan;
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; and/or
5. Premature termination of the contract.

There are no probable events anticipated that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include, but are not limited to the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and/or
4. A material amendment to the agreements without the consent of the issuer.

6. RELATED-PARTY & PARTY-IN-INTEREST TRANSACTIONS

The Plan holds investments in funds managed by affiliates of Fidelity Management Trust Company (Fidelity), the Trustee of the Plan, and as such, these transactions qualify as exempt party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company is obligated to continue the Plan during the terms of several collective bargaining agreements, the latest of which expires on November 1, 2025. In the event of Plan termination, all participants would become 100% vested in their accounts.

8. INCOME TAX STATUS

The Plan has received a determination letter from the IRS dated August 1, 2014 stating that the Plan and related Trust were designed in accordance with Section 401(a) of the Internal Revenue Code (the Code). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes the Plan is qualified and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
