INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
The Places for People Inc. Employees Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of The Places for People Inc. Employees Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 31, 2025, June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the seven months ended January 31, 2025 and the years ended June 30, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Places for People Inc. Employees Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 31, 2025, June 30, 2024 and 2023, and for the seven months ended January 31, 2025 and the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Places for People Inc. Employees Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Places for People Inc. Employees Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of June 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF THE PLAN

The following description of The Places for People Inc. Employees Retirement Plan ("Plan") provide only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

Places for People, Inc., (the "Organization"), sponsors a defined contribution 403(b) plan covering all employees who have elected to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

On September 15, 2024 the Plan was amended to be a frozen Plan, as a result of the Organization forming a partnership with Brightli, Inc. Subsequently, on January 31, 2025, the Plan's assets were merged into the Brightli Retirement Savings Plan. A total of \$7,531,428 in assets was transferred from the Organization's Plan to the Brightli Retirement Savings Plan.

Eligibility

Upon employment, employees may begin participation on the first day of each month. Employees are eligible to receive employer-matching and profit sharing contributions after attaining age 21 and completing one year of service (minimum of 1,000 service hours).

Contributions

The Plan allows employee elective contributions in the form of salary deferrals up to 100 percent of pretax annual compensation (subject to Internal Revenue Code ("IRC") limitations), and also permits rollovers from other qualified plans. The Organization, at the discretion of the board of directors, may contribute each year a matching percentage of participant contributions to the Plan. For the period and years ended, employer discretionary matching contributions were 25% of the participant's elective deferrals up to 4% of the employee's eligible compensation and subject to IRC limitations. The Plan also allows participants to make Roth deferral contributions. Participants direct the investment of their contributions plus the employer's portion into various investment options offered by the Plan.

Forfeited accounts

Forfeitures of terminated participants' non-vested account balances reduce future Organization contributions or administrative payments. During the seven months ending January 31, 2025, the year ended June 30, 2024, and the year ended June 30, 2023, forfeited account balances of \$5,301, \$6,478, and \$17,881 were applied to reduce the Organization's matching contributions. At January 31, 2025 and June 30, 2024 and 2023, remaining forfeited non-vested accounts totaled \$0.

Participant accounts

The Plan credits each participant's account with their contribution, earnings from investment options chosen by the participant and an allocation of the Organization's contribution. The Plan allocates matching Organization contributions based on each participant's contributions for the year, whereas Plan earnings are allocated proportionately among all participants based on their investment ownership percentage in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants immediately vest in their voluntary contributions plus actual earnings thereon. The participant vests in the Organization's contribution plus related earnings thereon based on years of continuous service. Participants vest 100% after completing six years of service. After completing year one, the employee vests 20% per year, thereafter.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive their vested account balance in a life annuity, a lump-sum payment or choose to have it rolled over into another qualified plan or IRA. A participant will receive a lump sum distribution if their account balance is \$5,000 or less. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account.

Active participants who reach age 59 ½ or experience a qualifying financial hardship may withdraw all or part of their investment account. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Code safe harbors.

Notes receivable from participants

Participants may borrow from their account, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant must have sufficient vested funds in his retirement account to secure the loan which bears interest at a rate commensurate with local markets at the time of origination. Principal and interest must be paid ratably bi-monthly through payroll deductions. The maximum repayment period for a loan is five years unless used for the acquisition of a participant's primary residence.

Administrative expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Organization.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The Plan's financial statements are prepared on the accrual basis of accounting under accounting standards generally accepted in the United States of America ("U.S. GAAP").

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. CERTIFICATION BY CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2420.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from the American United Life Insurance Company ("AUL") that all information provided by them as of January 31, 2025, June 30, 2024, and June 30, 2023 and for the seven months ended January 31, 2025 and the years ended June 30, 2024 and 2023, is complete and accurate. Information included in the accompanying financial statements as to investments, net appreciation in fair value of investments, interest and dividend income, and all information in the supplemental schedule is presented in reliance solely upon those certifications.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2025, June 30, 2024, and June 30, 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The guaranteed interest account investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of this investment was \$161,750, and \$161,565, as of June 30, 2024 and 2023, respectively.

The contract is designed to accrue interest based on a crediting rate established by the contract issuer. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Additionally, certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain its tax exemption under Section 403(b). Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2025, June 30, 2024, and June 30, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

7. PLAN TERMINATION

Although they have not expressed any intent to do so, management reserves the right to discontinue the Plan at any time, subject to the terms of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

8. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include an investment option managed by AUL. AUL is the custodian as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for administrative services were \$1,366, \$1,290, and \$621 for the period ended January 31, 2025 and the years ended June 30, 2024 and 2023, respectively.

9. RISKS AND UNCERTAINTIES

The Plan provides investment options in professionally managed funds that purchase stocks and bonds of publicly traded companies, U.S. Government obligations and money market funds. Such investments are exposed to various risks such as interest rates, the overall market and credit. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits at January 31, 2025, June 30, 2024 and June 30, 2023.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 17, 2025, the date which the financial statements were available to be issued.

10. SUBSEQUENT EVENTS (continued)

Effective January 1, 2024, the Plan was amended to allow employees to make Roth contributions up to 100 percent of annual compensation.
