Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of the Denver Art Museum DC Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Denver Art Museum DC Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Teachers Insurance and Annuity Association of America (TIAA) and the College Retirement Equities Fund (CREF) as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Denver Art Museum DC Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Denver Art Museum DC Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis-of-Matter

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 3 of the financial statements, the board of trustees of the Denver Art Museum, the Plan sponsor, voted in July 2015 to terminate the Plan, which indicates that the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon termination. Our opinion is not modified with respect to that matter.

(1) General Description of the Plan

The following description of the Denver Art Museum DC Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan that covers all employees of Denver Art Museum (Museum). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 31, 2015, the Plan has been frozen with no further contributions being made to the Plan. The Museum has established a new 403(b) Plan, effective as of January 1, 2016, with OneAmerica as trustee.

(b) Contributions

Effective December 31, 2015, no contributions are to be added to the Plan. The Plan currently offers two variable annuity funds and one guaranteed insurance contract as investment options for participants.

(c) Participant Accounts

Beginning in 2016, participants have a choice to maintain their accounts in this Plan, transfer their account balance to the new retirement plan under OneAmerica, or make a separate withdrawal from the Plan. The total plan transfers for the years ended December 31, 2024 and 2023 were \$44,838 and \$57,642, respectively.

If a participant terminates employment, the participant may elect to receive a distribution of a portion or all of the participant's vested account balance, depending on investment options with withdrawal restrictions (see note 6).

(d) Vesting

Contributions, pre-tax deferrals, and income earned thereon are fully vested immediately and cannot be forfeited, even if employment is terminated or an employee becomes ineligible to participate in the Plan.

(1) General Description of the Plan, Continued

(e) Plan Loans to Participants

This Plan is frozen and therefore the issuance of loans to participants is handled on a case by case basis through TIAA. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest total outstanding Plan loan balance in the 12 months immediately before the date of the participant's new loan. The loans are issued directly from funds owned by TIAA, the Plan's custodian, and not from a participant's account. Each loan is secured by the participant's vested account balance. All loans bear a reasonable interest rate, established by TIAA, which are commensurate with the prevailing interest rate charged on similar loans under like circumstance by persons in the business of lending money. During 2024 and 2023, interest rates ranged from 4.28% to 4.82%, which are similar to loans from commercial lending institutions. Loans require at least quarterly payments under a level amortization schedule over a period not exceeding five years, except in the purchase of a primary residence, in which case the term is up to 10 years. Total loans outstanding at December 31, 2024 and 2023 were \$22,830 and \$21,721, respectively.

(f) Payment of Benefits

On termination of service due to death, a single lump-sum cash payment or annuity option will be made to the participant's designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, an annuity option, or a direct rollover to an individual retirement account or to another employer's tax qualified plan. Certain investment options have restrictions on how quickly amounts can be paid out (see note 6).

(g) Expenses

Plan administration fees are paid from the assets of the Plan to the extent permitted by the individual agreements. Expenses may be allocated among all Plan participants or charged directly against individual account balances. Fees charged directly to individual account balances include general recordkeeping fees and expenses related to processing distributions or loans, qualified domestic relations orders, and directing the investment of the participant's account balance. Total fees for the years ended December 31, 2024 and 2023 were \$27,600 and \$23,544, respectively.

(h) Hardship Distributions

In 2016, the Plan was frozen and no longer allows hardship distributions. Therefore, there were no hardship distributions in the 2024 or 2023 Plan years.

(i) Plan Transfers

The Museum decided to terminate the Plan effective December 31, 2015. Active participants had the option to transfer their balance to the Denver Art Museum Retirement Plan (Retirement Plan) established January 1, 2016. However, some participants did not have the ability to transfer all their funds if their account was invested in a certain annuity with withdrawal restrictions (see Note 6). As those withdrawal restrictions are released additional transfers could occur in future years, until all those funds are released. Active participants continue to transfer funds to the Retirement Plan, and the total Plan transfers were \$44,838 and \$57,642 during the years ended December 31, 2024 and 2023, respectively.

(2) Summary of Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Investments

Investments are reported at fair value. Fair value is determined as more fully described in note 2(d). Investments in money market funds with readily determinable market values are reported at fair value based on quoted prices in active markets. The market value for traditional annuities represents contract value which equals the accumulated cash contributions, interest credited to the plan's contracts, and transfers, less any withdrawals and transfers. The market values for investments in real estate and variable annuities represent the Plan's pro-rata interest in the net assets of each investment and are based on the fair value of the underlying assets. These investments are not publicly traded on national security market exchanges and may be valued differently than if readily available markets existed for such investments. Management is responsible for the fair value measurement of investments reported in the financial statements and believes that the reported values are reasonable.

Investment return consists of the Plan's distributive share of any interest, dividends, capital gains and losses, generated from investments, as well as the change in fair value of the investments. Gains and losses attributable to investments are realized and reported upon a sale or disposition of the investments. Unrealized gains and losses are included in the change in net assets available for benefits.

(d) Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. US GAAP establishes a fair value hierarchy that prioritizes investments based on the assumptions market participants would use when pricing an asset. The fair value hierarchy gives the highest priority to quoted prices in active markets (observable inputs) and the lowest priority to an entity's assumptions (unobservable inputs). The Plan groups assets at fair value in three levels based on the markets in which the assets and liabilities are traded, and the reliability of the assumptions used to determine fair value. In addition, the Plan reports certain investments using the "practical expedient" method. The practical expedient allows net asset value per share or its equivalent to represent fair value for reporting purposes when the criteria for using this method are met. Investments valued using net asset value per share or its equivalent are not categorized within the hierarchy.

These levels are:

- Level 1 Unadjusted quoted market prices for identical assets or liabilities in active markets as of the measurement date.

(d) Fair Value Measurements, Continued

- Level 2 Other observable inputs, either directly or indirectly, including:
- Quoted prices for similar assets/liabilities in active markets;
 - Quoted prices for identical or similar assets in non-active markets;
 - Inputs other than quoted prices that are observable for the asset/liability; and,
 - Inputs that are derived principally from or corroborated by other observable market data.
- Level 3 Unobservable inputs that cannot be corroborated by observable market data.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. These classifications (Level 1, 2 and 3) are intended to reflect the observability of inputs used in the valuation of investments and are not necessarily an indication of risk or liquidity.

Market price is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument, as well as the effects of market, interest and credit risk. Instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. It is reasonably possible that change in values of these instruments will occur in the near term and that such changes could materially affect amounts reported in the Plan's financial statements.

(e) Participant Accounting Records

The Plan's custodian, TIAA, maintains individual participants' accounting records. Contributions and income are allocated by the custodian to the participants' accounts on a daily basis, and statements are prepared and sent to all participants quarterly.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Subsequent Events

Management has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

(3) Plan Termination

In July 2015, the Museum's board of trustees approved the freezing of the Plan, effective as of December 31, 2015, with the intention that the Plan will be terminated at such time and in such manner as permitted by applicable law. When the Plan is terminated, the net assets of the Plan will be allocated for payment of Plan benefits to the participants and beneficiaries in order of priority determined in accordance with applicable law and the Plan document. Full termination of the Plan is not expected to occur within the next year.

(4) Tax Status

The Plan has been informed by its contract administrator that the 403(b) plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since its adoption. The Museum is of the opinion that the Plan is currently being operated as and fulfills the applicable requirements of a qualified plan.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements and determined there are none. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan files Form 5500, and the three previous tax years remain subject to examination.

(5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(6) Investments

(a) Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient, which is a reasonable estimate of fair value, have not been classified in the fair value hierarchy. The fair value amounts presented in the above table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of assets available for benefits.

Level 1 assets have been valued using a market approach. Fair value for Level 3 investments is determined by using the contract value adjusted for current market interest rates that exceed current crediting rates, as this approximates fair value. The variable annuities and real estate fund are measured at the net asset value (NAV) per share as reported by the investment manager or sponsor as a practical expedient. There were no changes in the valuation techniques during the current year.

The TIAA Traditional Annuity is a non-benefit responsive, fixed rate annuity contract with a guaranteed minimum rate of interest between 1% and 3%. Because of the guaranteed nature of this annuity there are withdrawal restrictions, in which participants may only make withdrawals in the form of a life annuity or in 10 installments, over a 9-year withdrawal period.

(7) Related Party Transactions

Investment products and plan administrative services are provided by TIAA. TIAA is the third-party administrator and provides administrative services as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

(8) Financial Data Certified by the Plan Trustee
