## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of  
HomeFront, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of HomeFront, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of HomeFront, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### 1. DESCRIPTION OF THE PLAN

##### *General*

The following description of the HomeFront, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

##### *Eligibility*

Each employee of HomeFront, Inc. (the “Company”) becomes eligible to participate in the Plan after attaining age 18 and completing 6 months of service. To receive an allocation of the employer matching contribution the employee must also have completed one year of service. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

Participants are permitted to make elective deferrals of their compensation up to \$23,000 for 2024. However, participants who have attained age 50 by year-end may also make catch-up contributions of \$7,500 in 2023. Catch-up contributions are not subject to any other contribution limits or to the nondiscrimination rules. The Company makes matching contributions equal to 100% of the 3% of employee deferrals. The Company may make discretionary contributions on annual or semiannual basis. For the year ended December 31, 2024 and 2023, the Company made no discretionary contributions.

##### *Participant Accounts*

Each participant’s account is credited with the contributions and allocation of Plan earnings in accordance with his/her investment direction. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### *Benefits*

In the event of termination for reasons other than death, disability or normal retirement, balances in participant accounts are payable in lump-sum or installment payments. Benefits are recorded when paid.

##### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 2 years of service if he/she works at least 1,000 hours during each plan year. A participant is 100% vested upon the attainment of full retirement age, death, or termination of the Plan.

##### *Forfeitures*

Forfeited nonvested accounts shall be applied to reduce the Employer’s contribution at the end of the next Plan year during which the participant has received distribution of his or her vested interest. Forfeitures used by the employer to reduce the employer’s contributions for the years ended December 31, 2024 and 2023 were \$0.

#### **1. DESCRIPTION OF THE PLAN (Continued)**

Forfeitures for the years ended December 31, 2024 and 2023 were \$2,330 and \$1,106, respectively. The forfeiture account balance as of December 31, 2024 and 2023 was \$14,373 and \$11,643, respectively.

##### *Participant Loans*

Participants may borrow from their fund account a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through biweekly payroll deductions. Participants may only have one loan outstanding at any time.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### *Accounting Method*

The financial statements of the Plan are prepared using the accrual method of accounting.

##### *Use of Estimates*

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded as received.

##### *Payment of Benefits*

Benefits payments to participants are recorded upon distribution.

##### *Administrative and Investment expenses*

Administrative and Investment fees charged and deducted from the Plan assets totaled \$26,612 and \$21,781 for the years ended December 31, 2024 and 2023. Other administrative expenses incurred on behalf of the Plan including those expenses associated with accounting, legal, and other administrative services of the Plan are assumed by the Plan Sponsor.

##### *Subsequent Events*

Management has evaluated events and transactions occurring subsequent to December 31, 2024 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

#### 3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate, amend, modify or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

#### 4. INVESTMENT CERTIFICATION

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the financial information included in the Plan financial statements, except for contributions receivable, contributions, and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by Ascensus Trust Company, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### 5. INVESTMENTS

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in fair value by 444,118 and \$532,138 during 2024 and 2023, respectively.

#### 6. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. An asset's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The three levels of the fair value hierarchy under ASC 820 are as follows:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets.

Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset.

Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e. supported with little or no market activity).

The following is a description of the valuation methodologies used for instruments measured at fair value:

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Plan Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value on a recurring basis in the accompanying statement of net assets available for benefits.

(a) This class includes investment in common/collective trust that primarily invests in high-quality bonds with short to intermediate-term maturities and insurance contracts which aim to provide price stability on a day-to-day basis. The investment contracts are issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics as traditional investment contract and is comprised of two parts: the first part is a fixed income security or portfolio of fixed income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The Fund's investment objective is to maintain principal. The fair value of the investments in this class have been estimated using the net asset value per unit of the investments in the trust.

#### 7. PARTY-IN-INTEREST TRANSACTIONS

The HomeFront Inc. 401(k) Plan, the participants, and the Trustees have all been identified as related party transactions. The Plan invests in shares of mutual funds managed by the Trustees. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Participant loans also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA. Direct fees paid by the Plan for the investment record keeping and custodial services amounted to \$26,612 and \$21,781 for the years ended December 31, 2024 and 2023, respectively.

Fees paid during the year for legal, accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services and paid directly by the plan sponsor.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Internal Revenue Service has determined and informed the Ascensus Trust Company of the prototype standardized profit sharing plan by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **10. PLAN AMENDMENTS AND MODIFICATIONS**

The Plan had no material amendments or modifications.
