## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Miura America Co., LTD. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1. Description of Plan

The following description of the Miura America Co., Ltd. Retirement Plan (the "Plan") provides benefits for the eligible employees of Miura America Co., Ltd. (the "Company"). Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General:

An employee is eligible to participate in the Plan following the date on which the employee attains age 21 and completes at least two months of eligible service, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions:

Eligible participants may elect to defer up to 100% of their annual compensation, subject to the maximum amount allowed by the Internal Revenue Code, and make a contribution to the Plan with certain limitations as defined by the Plan. The Plan adopted an automatic enrollment feature for newly eligible participants, whereby these participants will be automatically enrolled in the Plan at a 8% salary deferral rate unless elected otherwise. There is no annual escalation of deferral rates once enrolled. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Company makes matching contributions equal to 50% of the participant's elective deferral up to 8% of the participant's compensation. An employee may terminate his or her election to participate at any time.

An employee may rollover into this Plan a distribution which qualifies as an "eligible rollover distribution" under IRC Section 402(c)(4). An "eligible rollover distribution" can only be made from a 401(a) plan, IRA, or annuity (IRA).

##### Participant accounts:

Each participant has an individual account that includes their contributions and allocations of the Company's contributions, Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting:

Participants are immediately vested in their elective deferral contributions and employer matching contributions plus actual earnings thereon.

## Note 1. Description of Plan (continued)

## Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$102 and \$98, respectively. These accounts will first be used to pay any administrative expenses and then to reduce future employer contributions. There were no forfeitures used during the year ended December 31, 2024.

## Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50% of the Member's Vested Account, reduced by any outstanding note balance or (b) \$50,000, reduced by the highest outstanding note balance during the one-year period ending on the day before the note is made. Only one loan per participant is allowed at a time. The notes receivable from participants are secured by the balance in the participant's account, have various maturities through 2028, and bear interest at rates ranging from 4.25% - 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Note terms may extend up to five years except for notes used to acquire a primary residence. Principal and interest is paid ratably through bi-weekly payroll deductions.

## Payment of benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum cash payment, a direct rollover to an IRA or other qualified plan, or any combination thereof. Payment of benefits will be made as soon as administratively feasible, with participant consent required for balances greater than \$5,000.

Hardship withdrawals from participant pre-tax elective deferral amounts are permitted as defined in the Plan.

## Note 2. Significant Accounting Policies

## Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

## Note 2. Significant Accounting Policies (continued)

## Investment valuation and income recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

## Administrative expenses:

Audit fees and some third-party administrative fees may be paid by the Company. All maintenance fees and investment advisory fees are netted with the investment earnings and losses.

## Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

## Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

## Note 3. Related Party Activity

Certain plan investments are shares of a general insurance contract managed by Nationwide Life Insurance Company and shares of mutual funds managed by Nationwide Trust Company FSB. Nationwide Life Insurance Company and Nationwide Trust Company FSB are the custodians as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

## Note 4. Information Prepared and Certified by Custodians

The following information was compiled from data certified by the custodians, Nationwide Trust Company, FSB and Nationwide Life Insurance Company as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits - December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits - Year Ended December 31, 2024.
- C. Investment information included in Schedule of Assets Held at End of Year.

## Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

## Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## Note 7. Income Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan as its' plan document. The underlying non-standardized pre-approved profit sharing/money purchase/CODA plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under the applicable sections of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt and no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Note 8. Investment Contract with Insurance Company

The plan has a fully benefit-responsive investment contract with Nationwide Life Insurance Company. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the financial statements of net assets available for benefits at contract value, which approximates fair value. Contract value, as reported to the plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

## Note 8. Investment Contract with Insurance Company (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.49% for 2024. Such interest rates are reviewed on a quarterly basis for resetting.

The plan has the right to pay out the current value of the contract, without application of a market value adjustment, provided that the plan gives a ninety day written notice to Nationwide Life Insurance Company, and further provided that the plan does not treat this contract differently from other contracts of the same class and risk characteristics.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## Note 9. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 10. Plan Amendments

Effective April 29, 2024, the Plan was amended and restated to increase employer matching contributions to 50% of the participant's elective deferral up to 8% of the participant's compensation, and increase the automatic deferral percentage to 8% of participant's compensation.

Note 11. Subsequent Events

Subsequent events have been evaluated through August 20, 2025, which is the date the financial statements were available to be issued.
