Notes to Financial Statements

Note 1: Description of Plan

The following description of the E.R. Wagner Manufacturing Company, Inc. Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General

The Plan is a defined contribution plan sponsored by E.R. Wagner Manufacturing Company, Inc. (the "Company"). The Company is the plan administrator.

As of January 3, 2023, Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the custodians. Prior to January 3, 2023, Associated Trust Company, N.A. was the custodian. The custodians hold the Plan's assets, make distributions, and are responsible for the Plan's recordkeeping.

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Prior to March 15, 2023, employees had to reach the age of 21 to be eligible to participate in the Plan. Effective March 15, 2023, employees must reach the age of 18 to be eligible to participate in the Plan.

Contributions

Participants may elect to defer up to 50% of their eligible pretax or after-tax compensation, as defined by the Plan, subject to the maximum contribution limits allowed by the Internal Revenue Service ("IRS"). Participants, aged 50 and older, may make catch-up contributions. The Plan allows participants to roll over distributions from other qualified retirement plans ("rollovers").

Effective January 1, 2023, eligible employees that do not make a deferral election are automatically enrolled to contribute 3% of compensation, unless they affirmatively elect not to participate in the Plan. Participants will be increased 1% annually on the first day of the Plan year to a maximum of 15%.

The Company is required to make a fixed matching contribution equal to 25% of the participant's contribution up to 6% of eligible compensation for all participants. In addition, the Company may make an additional discretionary matching contribution for nonunion participants. In 2024, the Company made a discretionary matching contribution equal to an additional 25% of participant's contributions up to 6% of eligible compensation for all participants.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Investment Options

Participants direct all contributions into one or a combination of investment fund choices. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Notes Receivable from Participants

Participants may borrow against their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The term of the note may not exceed five years. The notes bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through periodic payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, plan earnings (losses) and charged with benefit payments and an allocation of administrative expenses, as defined. The benefit to which a participant is entitled is the vested balance that can be provided by the participant's account.

Vesting

Participants are immediately vested in their contributions plus earnings (losses) thereon. Participants vest in Company fixed and discretionary matching contributions and earnings (losses) thereon at a rate of 33% per year and become fully vested after three years of service. Participants automatically become fully vested upon the attainment of normal retirement age (65), death, or disability.

Forfeitures

Forfeitures are portions of a participant account that are lost by terminating employment prior to becoming fully vested. Forfeitures of nonvested amounts are used to reduce future Company matching contributions or pay Plan expenses. Company matching contributions were reduced by \$20,096 in 2024 from forfeited nonvested accounts. No amounts were used to pay administrative expenses in 2024. As of December 31, 2024 and 2023, there were \$231 and \$3,712, respectively, of forfeited nonvested accounts.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon retirement, death, disability, or termination of employment, the participant's vested balance may be distributed, at the discretion of the participant, in a lump-sum or in periodic payments of equal installments.

Participants may withdraw, upon substantial financial hardship as defined by the Plan, any portion of the balance in their respective account attributable to their contributions. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principals generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates and are subject to change in the near term.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract ("FBRIC"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2: Summary of Significant Accounting Policies (Continued)

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Note issuance and distribution fees are charged directly to participants' accounts and are recorded as administrative expenses. The custodian and recordkeeping fees were paid by the participants of the Plan and are recorded as administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events have been evaluated through July 10, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Fully Benefit-Responsive Investment Contract

The Plan invests in a FBRIC with Empower Annuity Insurance Company of America ("Empower Annuity") in the form of a guaranteed investment contract ("GIC") that invests in traditional investment contracts. Empower Annuity maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The average crediting interest rate was approximately 1.41% for the year ended December 31, 2024. There is no reserve against contract value for credit risk of Empower Annuity or otherwise.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity, including Plan termination and other events as specified in the GIC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Empower Annuity to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Certified by Plan Custodians

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the balance of their respective accounts.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Note 8: Party-in-Interest Transactions

Certain Plan investments are managed by the Custodians. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the Custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 9: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 10: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Company is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Company. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the year ended December 31, 2023 December 31, 2024, totaling \$168, were remitted outside the 15-day requirement. This transaction constitutes a prohibited transaction as defined by ERISA.
