Notes to Financial Statements

NOTE 1 PLAN DESCRIPTION

The following description of the Michelman, Inc. Retirement and Savings Plan (the "Plan") is provided for information purposes only. Participants should refer to the Plan document for more complete information.

General

The original effective date of the Plan was July 1, 1985. The Plan was most recently amended and restated, effective April 1, 2021. The Plan is a defined contribution plan, covering employees of Michelman, Inc. (the "Company") who are not covered by a collective-bargaining agreement, and who have met certain service requirements, as defined. The Board of Directors of the Company controls and manages the operation and administration of the Plan. The Plan is subject to the Employee Retirement Income Security Act ("ERISA").

Contributions

Each year, participants may make elective deferral contributions to the Plan on a before tax basis and after tax basis. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code ("IRC") of 1986 as amended (\$23,000 at December 31, 2024). Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants who do not complete a salary deferral agreement on or after 30 days of eligibility notice are automatically enrolled in the plan and have 5% of their eligible compensation withheld. The Company makes matching contributions to the Plan up to 100% of the first 5% of eligible compensation for the Plan year, as defined in the Plan document. In addition, the Company may contribute discretionary profit sharing contributions to the Plan at the discretion of the Company's Board of Directors. No discretionary profit sharing contributions were made in 2024 or 2023. The Plan is a safe harbor plan in which all participants are 100% vested in all safe harbor matching contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matching and discretionary profit sharing contributions are invested as directed by the participants. The Plan currently offers numerous mutual funds and one guaranteed investment contract as investment options for participants.

Notes to Financial Statements (Continued)

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Vesting

Participants are vested immediately in their contributions, as well as all safe harbor matching contributions made by the Company (effective January 1, 2020), plus actual earnings thereon. Any matching contributions earned prior to January 1, 2020 are fully vested after 3 years of service. Forfeitures are used to reduce administrative expenses of the Plan. Any forfeitures remaining after administrative expenses have been paid shall be used to reduce Company contributions. During 2024, the Plan sponsor used \$10,398 of the forfeiture balance to reduce employer contributions as well as \$119,000 to pay Plan expenses. The total balance of unallocated forfeitures and Plan expense account was \$21,769 and \$76,596 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. All loans shall bear a reasonable rate of interest as determined by the Plan administrator. For participants employed by the Company, principal and interest is paid ratably through payroll deductions. Upon termination of employment for any reason, the participant may remit the outstanding balance of the loan within 90 days provided such repayment is made before the participant requests a distribution.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in a lump-sum payment or installments upon participant request.

In-service distributions are permissible from the Plan for participants that have obtained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump-sum payment.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw that portion of the participant's 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of Michelman, Inc. Retirement and Savings Plan have been prepared on the accrual basis.

Notes to Financial Statements (Continued)

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation

Certain investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Fully benefit-responsive investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Related-Party Transactions

Certain Plan investments are invested in accounts managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the Trustee as defined by the Plan and therefore these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services provided by the employees to the Plan.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Company has evaluated all events subsequent to the balance sheet date of December 31, 2024, through August 29, 2025, which is the date these financial statements were available to be issued.

NOTE 3 INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2007, the Plan entered into a benefit-responsive investment contract with Empower Trust Company, LLC. Empower Trust Company, LLC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive, and because of this the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination and contract termination prior to Empower Trust Company, LLC recovering all start-up costs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Either party may terminate the contract with at least 60 days advance written notice to the other party.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Empower Trust Company, LLC. Empower Retirement, LLC received an opinion letter from the Internal Revenue Service (“IRS”), dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.
