We have performed audits of the accompanying financial statements of CRG 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. CRG 401(k) PLAN NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the CRG 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of the Contracting Resources Group, Inc. (the “Company” and “Plan administrator”), except union employees and nonresident aliens. An employee of the Company is immediately eligible to participate in the Plan’s deferral, Company safe harbor matching, and Company prevailing wage provisions upon date of employment. To participate in the discretionary Company matching portion and the Company nonelective portion of the Plan, an employee must complete a year of service equal to 1,000 hours. Entry dates to participate in the employer matching and the nonelective portions of the Plan are the first day of the Plan year quarter following the achievement of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Administration – The Plan sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan Agreement. Participants have the option of contributing a percentage of their taxable compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are allowed to make contribution modifications at the beginning of each pay period. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, which are reflected as rollovers. John Hancock Life Insurance Company (U.S.A.) (“John Hancock”) is the Plan’s trustee.

The Company makes safe harbor matching contributions on behalf of all participants in an amount equal to 100% of the first 4% of base compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Company made safe harbor contributions of \$443,538. At the discretion of the owner of the Company, the Company may also make additional matching contributions. During the year ended December 31, 2024, the Company did not make any additional matching contributions.

The Company will make prevailing wage contributions on behalf of each participant who performs services subject to the Service Contract Act, Davis-Bacon Act, or similar federal, state, or municipal prevailing wage statutes. The prevailing wage contribution is not subject to any age or service requirements and is fully vested. The prevailing wage contributions for the year ended December 31, 2024 were \$39,120.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, Company safe harbor matching contributions, Company matching contributions, as well as allocations of the Company’s prevailing wage contributions and Plan earnings (losses). Participant accounts are charged with their withdrawals and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the Plan year.

Note 1—Description of the Plan (continued)

Vesting – Participants are vested immediately in their contributions, Company prevailing wage contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's matching contribution and Company qualified nonelective portions of their accounts is based on years of continuous service. A participant is 20% vested after two years of service and receives an additional 20% of vesting each year of service until 100% vesting is reached after six years of credited service. Participants will be 100% vested in Company contributions in the event of death or total and permanent disability regardless of years of service.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Participants may only have one loan outstanding at any time. Loans terms cannot exceed five years, unless it is a home loan, in which case the loan term cannot exceed 30 years. Principal and interest are paid ratably through payroll deductions, unless the participant makes a prepayment which can be made via check.

Payment of Benefits – Upon termination of service or attaining normal retirement age, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account in accordance with the Plan Agreement. Installments are available for participants or beneficiaries who must receive required minimum distributions under Internal Revenue Code ("IRC") 401(a)(9). In-service and hardship withdrawals are also allowed as defined in the Plan Agreement.

Forfeited Accounts – The nonvested portion of former participants' accounts attributable to Company matching and Company nonelective contributions will be used to reduce the amount of future employer contributions, or to pay Plan expenses. Forfeited accounts totaled \$541 and \$-0- at December 31, 2024 and 2023, respectively. In 2024, no forfeited nonvested accounts were utilized to reduce future employer contributions or to pay plan expenses.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Investment Management Fees and Operating Expenses – Investment management fees and operating expenses charged to the Plan for certain investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Note 2—Summary of significant accounting policies (continued)

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 or 2023.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, a qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4—Fair value measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There has been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts ("PSA") – Valued at net asset value ("NAV") of units held by the Plan at year-end provided by the issuer of the account. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised, primarily, of shares of mutual funds at December 31, 2024 and 2023. The PSAs seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. Certain PSAs are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. Included in the pooled separate accounts is a stable value fund which represents participation units of a collective investment trust for which NAV is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at NAV of units of the bank collective trust. The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There are currently no redemption restrictions or unfunded commitments on these investments. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

International global funds seek long-term growth of capital while providing current income by investing, on a global basis, in common stocks in U.S. dollars or other currencies. They may also invest in issuers in developing countries.

Small cap funds seek growth of capital through investment in common stocks selected on the basis of potential for capital appreciation and may invest in securities of foreign issuers and non-dollar securities.

Mid cap funds seek growth of capital through investments in stocks of small and medium sized companies that exhibit positive growth characteristics.

Large cap funds seek long-term growth of capital by investing primarily in common stocks of U.S. and foreign companies that have solid long-term growth records and the potential for good future growth.

Asset allocation/balanced funds seek the highest total return over time consistent with an emphasis on both capital growth and income primarily through investments in debt and equity securities.

Bonds seek maximum total return consistent with preservation of capital and prudent investment management by investing primarily in investment grade securities.

Note 5—Related party transactions and party-in-interest transactions

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest. Notes receivable from participants and related activity also qualify as party-in-interest transactions.

John Hancock provides recordkeeping and transaction processing services to the Plan. Blue Ridge Associates and Lowes FS LLC provide investment advisory services to the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping, transaction processing, and investment advisory services amounted to \$19,919 for the year ended December 31, 2024. John Hancock is the custodian of the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Company matching and Company nonelective portions of their accounts.

Note 7—Income tax status

The Internal Revenue Service (“IRS”) ruled on November 30, 2020, that the pre-approved plan of Coastal Pension Services, Inc. upon which the Plan is based, is designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the financial statements.

Note 9—Subsequent events

The Plan has evaluated all subsequent events through September 16, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
