Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dare Foods Incorporated 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dare Foods Incorporated 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Dare Foods Incorporated 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A.--DESCRIPTION OF PLAN

The following description of Dare Foods Incorporated (Company or Sponsor) 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) and profit sharing plan established by the Company, effective June 1, 1990. Effective January 1, 2021, the Madrona Specialty Foods 401(k) Savings Plan merged into the Dare Foods Incorporated 401(k) Savings Plan. The Plan was amended effective January 1, 2021 to become a safe harbor plan and to allow Roth contributions and restated effective February 18, 2022 as part of the Cycle 3 restatement requirements. Effective January 1, 2023, the Plan was amended to change the definition of compensation to remove all compensation exclusions, other than certain post severance compensation which is excluded without exception. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company. An employee becomes eligible to participate in the Plan after completing 3 months of service. The entry date is the first day of the month upon satisfaction of the eligibility requirements. See Note J.

Contributions: The Plan is funded by eligible participant elective deferrals which may range from 1% to 70% of eligible compensation, safe harbor matching contributions, and additional discretionary contributions. To receive additional discretionary contributions, the employee must be employed on the last day of the Plan year.

The Company contributes a qualified match of 100% of elective deferral contributions that are not over 3% of pay, plus 50% of elective deferral contributions that are over 3% but are not over 5% of pay. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their future deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirements plans. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions and an allocation of plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions as applicable, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Vesting: Participants are immediately vested in their rollover contributions, elective deferrals, and safe harbor match contributions, plus actual earnings thereon. A participant is 100% vested in discretionary contributions and discretionary nonelective contributions after six years of credited service or upon becoming disabled or death, or reaching normal or early retirement age.

Retirement: The normal retirement date is the first day of the month on or after the date the participant turns 65. Early retirement is permitted upon the date a participant reaches age 55.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or other amount or life annuity.

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, or other forms of distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death, if the vested account is more than \$5,000. For terminated participants, with balances between \$1,000 and \$5,000, the balance will be paid out in a single sum as a direct rollover to an IRA unless the participant elected a lump sum distribution, or rollover to another Plan or IRA of the participant's choice. Distributions of accounts \$1,000 or less are automatically paid out in a lump sum. Age 59 ½ in service distributions are allowed. Hardship distributions are allowed in accordance with the provisions of the Plan. Distributions are allowed from rollover contributions at any time.

Notes Receivable from Participants: The Plan does not allow participant loans.

Forfeited Accounts: Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures may first be used to pay Plan expenses and the remainder will be reallocated to eligible participants as employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$0. During 2024, \$657 of employer contributions were paid from forfeited non-vested accounts.

Investment Options: Participants are allowed to direct their contributions and account balances in a variety of investment options including mutual funds, pooled separate accounts, and guaranteed investment accounts. The Plan Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees such as for distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are deducted from each funds' earnings and are included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by the investment advisor and trustee and custodian. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--INVESTMENT CONTRACT

The Plan has an investment contract with Principal Trust Company (Principal). Principal maintains the assets of the Plan in pooled separate accounts, mutual funds and invests in guaranteed interest accounts.

The guaranteed interest accounts are part of the general assets of the insurance company and are valued at fair value as they are not fully benefit responsive. The fair value is the value paid when funds are withdrawn prior to their maturity. Crediting interest rates ranged between 4.90% and 5.70% for the year ended December 31, 2024.

NOTE C.--INVESTMENT CONTRACT (Continued)

A surrender charge may apply to transfers or withdrawals from an unmatured guaranteed interest account. The reference rate used to determine if a charge applies is equal to the applicable fixed U.S. Treasury rate plus 0.50%. A charge applies when the reference rate is higher than the rate being credited to the unmatured funds being transferred or withdrawn. The amount of the surrender charge is calculated as follows: 1) The applicable fixed U.S. Treasury Rate plus 0.50% minus the rate being credited, multiplied by 2) The number of years and fractional parts of a year left in the Guarantee Period, multiplied by 3) The amount being surrendered. A surrender charge may not apply to withdrawals due to retirement, termination of employment, disability, or death.

NOTE D.--CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and dividend and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (custodian of the Plan) and Principal Trust Company (custodian of the Plan).

NOTE E.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at NAV less operating expenses accrued but not deducted, if any, which is based on the fair value of the underlying investments held in such separate accounts.

Guaranteed interest accounts: Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. Fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by the custodian, Principal Trust Company and Principal Life Insurance Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain employees of the Company serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

NOTE G.--TAX STATUS

The Plan was amended and restated effective February 18, 2022 and adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE G.--TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan, including employer contributions, shall become fully vested and non-forfeitable.

NOTE I.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE J.--SUBSEQUENT EVENTS

Effective January 2025, the Plan adopted the federally declared disasters withdrawals and domestic abuse withdrawals Secure 2.0 Act provisions.

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.
