Report of Independent Auditors

To the Participants and Trustee of

Opinion

We have audited the financial statements of Licensed Tugmen's and Pilots' Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net (deficit) in liquidation as of March 31, 2025 and 2024, and the related statements of changes in net (deficit) in liquidation for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net (deficit) in liquidation of Licensed Tugmen's and Pilots' Pension Fund as of March 31, 2025 and 2024, and the changes in its net (deficit) in liquidation for the years then ended, and the accumulated plan benefits as of March 31, 2025 and 2024, and the changes in its accumulated plan benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matters

Plan Insolvency and PBGC Assistance

As described in Note 2, the Plan was terminated on October 1, 2011, which coincided with the withdrawal of the remaining two participating employers. The Plan's actuary determined that the current value of assets plus future investment earnings were not projected to cover benefit payments and administrative expenses beyond the Plan year beginning April 1, 2021, assuming experience emerges as projected and there are no changes in Plan provisions, actuarial assumptions, laws or regulations. During the year ended March 31, 2022, the Plan applied for and began receiving financial assistance from the Pension Benefit Guaranty Corporation (PBGC), and reduced benefit payments to participants to the level guaranteed by the PBGC. Our opinion is not modified with respect to this matter.

Emphasis of Matters (continued)

Liquidation Basis

Pursuant to termination of the Plan on October 1, 2011, the Plan changed its basis of accounting from the going concern basis to the liquidation basis, in accordance with accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

March 31, 2025 and 2024

Note 1. Summary of Significant Accounting Policies

Method of Accounting - Licensed Tugmen's and Pilots' Pension Fund (the Plan) was terminated, and all employers withdrew from the Plan on October 1, 2011, as described in Note 2. The accompanying financial statements were prepared using the liquidation basis of accounting, in accordance with generally accepted accounting principles.

Actuarial Present Value of Accumulated Plan Benefits - Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service which employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

General - The Plan was established in 1963 as a result of collective bargaining agreements between Licensed Tugmen's and Pilots' Protective Association of America, ILA, AFL-CIO and various employer associations to provide retirement and disability benefits for eligible participants. The Plan was primarily funded by employer contributions as specified in the collective bargaining agreements. The Plan was a multiemployer defined benefit pension plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Prior to termination of the Plan, a participant was eligible for a normal pension at age 65 with five or more years of participation in the Plan, including at least one year of service earned in 1974. A participant was eligible for a deferred vested pension if retirement occurred before entitlement to a normal pension but after completion of ten or more years of service, including at least one year of service earned after 1974, and if ineligible for any other pension. All participants became fully vested upon termination of the Plan. Participants should refer to the summary plan description for more complete information.

Note 2. Description of the Plan (continued)

Plan Termination and PBGC Financial Assistance - On October 1, 2011, the Trustees exercised their right to discontinue and terminate the Plan. This action coincided with the withdrawal of the Plan's two remaining employers. The Trustees, upon the Plan's termination and prior to their resignation, appointed an Independent Neutral Trustee who assumed all authority granted to the prior Trustees. A notice of mass withdrawal was submitted to the Pension Benefit Guaranty Corporation (PBGC) and was procedurally approved.

The actuary continues to evaluate the Plan annually, following the mass withdrawal, to assess the ability to satisfy all of its liabilities for nonforfeitable benefits in full. This annual valuation is prepared according to the requirements of ERISA 4041A and 4281 and subsequent PBGC regulations.

In December 2020, the Plan distributed to each participant the Notice of Insolvency and Notice of Insolvency Benefit Level. These notices were also timely filed with the PBGC. On April 1, 2021, the Plan reduced benefit payments to the PBGC guaranteed levels. In connection with this notice, the Plan submitted an application in May 2021 for financial assistance.

On November 16, 2021, the Plan entered into a Promissory Note (Note) with the PBGC designed to provide financial assistance in the form of loans for payment of basic benefits under the Plan and the Plan's reasonable administrative expenses. The Plan sends a funding request to the PBGC on a quarterly basis to cover the funding deficiency for the upcoming quarter. In addition, the PBGC may waive the PBGC premiums for any Plan year in which the Plan receives financial assistance. The amount waived will be treated as additional financial assistance and added to the loan balance. The Note states that the Plan is obligated to repay PBGC for all such financial assistance, with interest, if the Plan's financial condition improves. The PBGC does not require repayment as long as the Plan continues to be insolvent. The funds received from the PBGC have been structured as loans and bear interest at the rate in effect under Section 6621(a)(2) of the Internal Revenue Code, compounded daily. A security agreement is in place for the Note, which states that the PBGC will retain a security interest in all future employer contributions and withdrawal liability payments, if any. The cumulative financial assistance received from the PBGC through March 31, 2025 and 2024 totaled \$1,286,433 and \$992,663 respectively. The Plan has accrued interest of \$134,046 and \$61,092 as of March 31, 2025 and 2024, respectively. Although it is unlikely that the loan would ever be repaid, it is a contractual obligation of the Plan and is recorded as a liability in accordance with generally accepted accounting principles.

Note 3. Actuarial Information

Actuarial valuations of the Plan were made by Cheiron as of March 31, 2025 and 2024. The Plan was terminated October 1, 2011 and is required to have an annual valuation until it has satisfied all of its liabilities in full for nonforfeitable benefits. The valuations were prepared by the actuary according to the requirements of ERISA Sections 4041A and 4281 and pursuant to PBGC regulations. The valuations monitor the value of Plan benefits to determine whether the level of assets is sufficient to pay benefits for the following two years.

Note 3. Actuarial Information (continued)

The latest funded status certification as of April 1, 2011 was provided by the Plan's actuary, indicating that the Plan was in critical status, within the meaning of the Pension Protection Act of 2006 (PPA), as amended. The PPA requires the Trustees of a multiemployer pension plan that has been certified by the actuary as being in critical status to develop a rehabilitation plan that is intended to enable the Plan to cease to be in critical status by the end of the rehabilitation period or at such later time as determined by the Trustees. The rehabilitation plan must be based on reasonable anticipated experience and on reasonable actuarial assumptions. The Trustees adopted a rehabilitation plan which was to begin on April 1, 2011. However, due to the mass withdrawal, the employers did not follow the rehabilitation plan, and were assessed a 10% surcharge for work performed on and after April 1, 2011, as required by the PPA.

Due to events outside the control of the Plan, the Plan will not emerge from critical status and, based on reasonable assumptions, became insolvent during November 2021, as projected. The Plan's actuary determined that the current value of assets plus future investment earnings are not projected to cover benefit payments and administrative expenses beyond the Plan year assuming experience emerges as projected and there are no changes in Plan provisions, actuarial assumptions, laws or regulations.

Note 4. Tax Status

The Plan's latest determination letter is dated August 21, 2015, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code and is, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Risks and Uncertainties

The actuarial present value of accumulated plan benefits was determined based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
