A. DESCRIPTION OF PLAN

The following description of the Ascent Residential, LLC (the “Company” or “Plan Administrator”) 401(k) Plan (the “Plan”), as amended and restated January 1, 2024, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General – The Plan is a defined contribution plan covering all employees who have attained six months of service and are 21 years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Trustees are responsible for the oversight of the Plan. The Trustees also determine the appropriateness of the Plan’s investment offerings and monitor investment performance.
2. Contributions – Each year, participants may contribute a percentage of pretax and after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds held in pooled separate accounts. The Company utilizes the “safe harbor” matching contribution method in order to satisfy certain non-discrimination tests required by the Internal Revenue Service (“IRS”). The “safe harbor” matching contribution amount is an amount equal to 100 percent of each eligible participant’s elective deferral which do not exceed 3 percent of compensation, plus 50 percent of each eligible participant’s elective deferral which exceed 3 percent and do not exceed 5 percent of compensation. During Plan year 2024, the Company made “safe harbor” matching contributions and other corrective contributions totaling \$168,382. Contributions are subject to certain statutory limitations.
3. Participants’ Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and (b) Plan earnings or losses and charged with an allocation of any administration expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. Vesting – Participants are immediately vested in their voluntary contributions, any “safe harbor” matching contributions, plus actual earnings thereon.
5. Investment Options - Participants direct contributions, including employer cash matching and non-matching contributions, into any of the investment options offered by John Hancock Life Insurance Company, the Plan’s Custodian. Participants may change their investment options at any time.

A. DESCRIPTION OF PLAN (continued)

6. Payment of Benefits – The following are the Plan provisions with respect to the payment of benefits:
- Upon termination of service due to disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the vested amount of a participant's account (excluding rollovers) does not exceed \$5,000, the participant's vested account will be distributed from the Plan. The participant may either elect to receive this distribution in cash or to roll over the distribution to an individual retirement account or to a qualified plan.
 - Upon termination of service due to death, the participant's balance will be distributed to their beneficiary. Generally, distribution must begin by the end of the year following the death of the participant and may be paid over a period not longer than the beneficiary's life expectancy. If the beneficiary is the participant's spouse, distribution will be delayed until the year in which the participant would have attained 73 years of age; however, the beneficiary may elect to begin distributions earlier.
 - Participants are allowed to make withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Management estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

All Plan investments as of December 31, 2024 and 2023 were held by John Hancock Life Insurance Company, the Plan Custodian. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note D for discussion of fair value measurements.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment valuation and income recognition (continued):

The Plan offers a choice of various mutual funds via pooled separate accounts including (i) money market and bond funds which invest primarily in securities issued or guaranteed by the United States Treasury and certain United States Government agencies and municipalities that provide income that is generally not subject to state income tax, (ii) fixed-income funds which invest in a diversified group of high-quality, fixed income investments, and (iii) equity funds which invest in common stocks and consist of several individual investment options for various levels of risk tolerance. Investments in pooled separate accounts are recorded at the fair value of the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

D. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include (i) quoted prices for similar assets or liabilities in active markets; (ii) quoted prices for identical or similar assets or liabilities in inactive markets; (iii) inputs other than quoted prices that are observable for the asset or liability; (iv) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable input and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

There are no Plan assets that require the use of Level 1, Level 2, or Level 3 inputs for the periods presented.

Pooled separate accounts are valued, as a practical expedient, at the Net Asset Value ("NAV") of units held by the Plan at year end. The NAV of these accounts is based on the market value of its underlying mutual funds. The NAV is not a publicly-quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Company officers are eligible participants who have made contributions to the Plan, therefore, these transactions qualify as party-in-interest transactions. Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company U.S.A. John Hancock Life Insurance Company U.S.A. is the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. For the year ended December 31, 2024, the Plan made direct payments to the third party administrator and solicitor of \$33,429. The Plan sponsor pays directly any other fees related to the Plan's operations. These transactions are exempt from the prohibited rules under ERISA.

F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the 401(k) Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts and Plan assets would be distributed to participants and their beneficiaries in accordance with the provisions of the Plan and subject to ERISA guidelines.

G. INCOME TAX STATUS

The Company adopted a non-standardized pre-approved profit sharing 401(k) plan. The pre-approved profit sharing plan received a favorable opinion letter from the IRS on June 30, 2020, which stated that the pre-approved profit sharing plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since the pre-approved profit sharing plan received the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Notwithstanding the foregoing, the IRS may nonetheless audit the Plan to ensure it has been operated in accordance with the Plan document and applicable laws. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

I. CONCENTRATION OF INDIVIDUAL INVESTMENTS

As of December 31, 2024 and 2023, the fair values of the Plan’s investments in the MyWayRetirement Index 2030 Fund, MyWayRetirement Index 2035 Fund, and MyWayRetirement Index 2040 Fund totaled \$2,272,462 and \$2,043,983, respectively. These investments approximated 64% of the total Plan’s investments as of December 31, 2024 and 2023.

K. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Plan failed to timely remit participant contributions in accordance with Department of Labor regulations. For the year ending December 31, 2024, the Company remitted to the Plan \$10,576 of delinquent participant contributions. Late remittances of participant contributions for the year ended December 31, 2024 were fully corrected outside the Voluntary Fiduciary Corrections Program (“VFCP”) in June 2024.

In November 2024, late remittances of participant contributions for the year ending December 31, 2022, totaling \$23,703 were fully corrected outside the VFCP.
