NOTE 1 DESCRIPTION OF THE PLAN

The following description of the H. F. Lenz Company 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of H. F. Lenz Company (Company). Effective January 1, 2020, employees become eligible to participate in the plan upon completion of at least three (3) months of consecutive service. Upon reaching eligibility, participants may enter the Plan on the first day of the month coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum amount of annual compensation, as defined in the Plan, not to exceed certain IRS limits. Participants may also designate all or a portion of their elective deferrals as after-tax Roth elective deferrals. The Plan maintains an automatic enrollment feature whereby eligible participants will be automatically enrolled at a deferral rate of three percent (3%), unless the participant elects otherwise.

Under the plan, the Company makes a discretionary matching contribution equal to a uniform percentage of a participant's salary deferral. The discretionary matching percentage amounted to four percent (4%) for 2024 and thirty-three and one thirty-third percent (33.33%) for 2023. At the discretion of its governing body, the Company may make a discretionary profit sharing contribution to the Plan. Discretionary contributions made by the Company is made annually according to the terms of the Plan Document. The discretionary contribution to the Plan for the year ended December 31, 2024 amounted to \$525,000. The discretionary contribution is included as a component of employer contributions in the accompanying statement of changes in net assets available for benefits.

Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions to the Plan are recorded in the period that payroll deductions are made from participants. Company contributions are accrued based upon the period those contributions relate to.

Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies, common collective trust funds which consist of managed advisory portfolios, as well as a guaranteed deposit administration contract issued by The Standard as investment options available to participants.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution and related employer matching contribution, (b) an allocation of the Company's discretionary profit sharing contribution, and (c) an allocation of investment earnings and administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their voluntary contributions, rollover contributions, and any earnings thereon. Vesting in the remainder of their account (including employer match and employer profit sharing contributions) is earned in accordance with the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 3	0%
3 or More	100%

Regardless of the number of years of service, a participant's account balance becomes fully vested when the participant retires, becomes permanently disabled, or dies.

Forfeited Accounts

Forfeitures may first be used to reduce plan administrative expenses. Any remaining forfeitures may be used to reduce employer contributions to the Plan. Forfeited non-vested balances amounted to \$-0- and \$14,520 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, accumulated forfeitures of \$23,101 were used to reduce employer matching and profit-sharing contributions.

Payment of Benefits

Upon retirement, death, or termination, the participant or beneficiary may elect to receive distributions from the Plan in the form of a lump sum distribution. Partial withdrawals are only permitted to satisfy the minimum required distribution provisions of the Internal Revenue Code. In-service withdrawals are also permitted for participants who have reached normal retirement age. The Plan also maintains a provision for hardship withdrawals.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their account balance. Loan terms range from one (1) to five (5) years, however, an extended repayment period may be available provided the loan is used to help acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of the valuation methodologies used for assets measured at fair value.

Net investment gain/(losses) from registered investment companies and common collective trust funds includes dividends, capital gain distributions, and realized and unrealized appreciation (depreciation). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by either the Company or the Plan. Administrative expenses paid by the Plan consist primarily of administrative fees paid to the record-keeper and third-party service providers.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

Level 1 – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the net asset value (“NAV”) of shares held by the Plan at year end

Common Collective Trust Funds: Valued at the NAV of units held by the Plan at year end adjusted for any cash held for liquidity purposes and any fees imposed by the fund. The net asset value per unit is determined by dividing the net assets by the number of units outstanding on the day of valuation. The net asset value of the fund is determined daily. Units are issued and redeemed daily, at the daily net asset value. Also the net investment income and realized and unrealized gains on investments are not distributed.

Investment Contract with Insurance Company: Represents a fully benefit-responsive investment contract and guarantees a fixed rate of interest. See Note 4 for valuation methodology for the investment contract with insurance company.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Standard Stable Asset A Fund

The Plan invests in a fully benefit-responsive stable asset fund issued by the Plan's record-keeper, The Standard, with total contract value of \$5,127,004 and \$4,739,817 as of December 31, 2024 and 2023, respectively. The Standard maintains the contributions to this fund in an unallocated fund, whose assets are invested with other general assets of The Standard. The account was credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. There are no reserves against contract value for the credit risk of The Standard or otherwise.

Certain events may limit the ability of the plan to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a payout adjustment may apply. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

On a quarterly basis, The Standard's asset advisory group provides The Standard with an interest rate forecast for the coming quarter based on the investments underlying the guaranteed contracts. Based on these rates and the margins required for our business The Standard declares a crediting rate for assets in the fund for the coming quarter. The minimum crediting rate specified in the contract is 1.00% per annum. Management approval at The Standard is required for all crediting rates.

The contract owner may terminate the contract at any time with thirty (30) days advance written notice to The Standard. The Standard may terminate the contract with thirty (30) days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by either party, the payout value may be subject to adjustment, either in a single lump sum payment or in installment payments.

NOTE 5 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE 7 TAX STATUS

The Plan has adopted The Standard Retirement Services, Inc. Volume Submitter 401(k) Profit Sharing Plan. The volume submitter plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The volume submitter plan has been amended since receiving the determination letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities held by the Plan, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 RELATED PARTY TRANSACTIONS

Plan investments are held by StanCorp Financial Group (Reliance Trust Company and plan recordkeeping and administration responsibilities are performed by The Standard.) Reliance Trust Company is the custodian as defined by the Plan and The Standard is the record-keeper as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the Reliance Trust Company and to The Standard, amounted to \$5,692 and \$56,685, respectively during the plan year ended December 31, 2024.

The plan also designated First National Trust Company as a directed trustee and advisor for the Plan. Fees paid to First National Trust Company amounted to \$57,457 during the plan year ended December 31, 2024.

NOTE 10 SUBSEQUENT EVENTS

Subsequent events were considered through August 19, 2025, which is the date that financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.


