### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of American Nickeloid Company 401(k) Peru Union Salary Deferral Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### Note 1. Plan Description

The following description of American Nickeloid Company 401(k) Peru Union Salary Deferral Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of American Nickeloid Company (the Company) represented by a collective bargaining agreement who have completed three months of service. The Plan excludes non-bargaining employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Board of Trustees. The Board of Trustees has overall responsibility for the operation and administration of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Company's owners.

**Contributions:** Participants may contribute up to 100% of annual compensation, subject to certain limitations, as defined in the Plan, provided this will not cause the Plan to violate the provisions of the 401(k) discrimination limits. Participants may elect to designate all or any portion of their elective deferral contributions as Roth elective contributions. Participants who have not elected to have a specified amount contributed to the Plan will automatically have 3% of compensation deferred, unless they have made an election not to participate in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company shall contribute a Company matching contribution amount to all Walnutport participants equal to 50% of elective contributions up to 8% of eligible compensation. Effective May 1, 2024, the percentage increased to 100% of elective contributions up to 5% of eligible compensation. The Company shall contribute a Company matching contribution to all Peru participants equal to 100% of elective contributions up to 3% of eligible compensation. Additionally, participants at the Peru location who started employment on or after July 1, 2011, shall receive an amount equal to 3% of compensation for each payroll period they were active participants. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions and allocation of a) the Company's contributions, and b) plan earnings/losses and charged with certain administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in the amount of their elective and rollover contributions plus actual earnings thereon. Walnutport participants are vested immediately in the Company's matching contribution and earnings thereon. Vesting in all Company contributions for Peru participants is based on years of continuous service. A Peru participant is 20% vested after one year of service, 40% vested after two years of service, 60% vested after three years of service and 80% vested after 4 years of service. A Peru participant is fully vested after five years of credited service.

**Investment options:** Each participant has the option to invest their account balance and Company and participant contributions in selected investment options as made available and determined by the Plan Administrator. Participants have the option to transfer monies between funds and change the allocation of their investment election daily.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Upon death, disability, retirement or termination of service for any reason, a participant may elect to receive either a lump sum amount equal to the value of their vested accounts or receive regular installments over a period not to exceed their life expectancy. A participant can also elect to receive their benefits in the form of an annuity. Participants that have attained age 59½ may take in-service withdrawals from vested balances in their accounts. In addition, hardship distributions are permitted if certain criteria are met. If a Participant's vested balance is \$1,000 or less, the Participant's entire vested account shall be paid directly to the participant. If a Participant's vested balance is greater than \$1,000 but less than \$5,000, the Participant's entire vested account shall be paid directly to an individual retirement plan designated by the Plan Administrator.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions:** Contributions from Plan participants and matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Administrative expenses are paid by the Plan. Certain other expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent events:** The Plan's management has evaluated subsequent events through September 19, 2025, the date on which the financial statements were available to be issued.

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under the FASB Accounting Standards Codification (ASC) Topic 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**Units of collective investment trusts:** Units of collective investment trusts are valued based on the NAV per unit of the collective investment trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimating the fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Insurance company pooled separate accounts:** The fair value of the investments in the insurance company's pooled separate accounts is determined by the insurance company and represents the NAV per share based on the fair value of the underlying investments comprising the pooled separate accounts. The NAV is used as a practical expedient to estimating fair value. The practical expedient is not used when it is determined to be probable that the separate account will sell the investment for an amount different than the reported NAV.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investments and size of transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

**Investments measured using the NAV per share practical expedient:** The following tables summarize investments for which fair value is measured based on NAV practical expedient per share as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments. The redemption notice period is applicable only to the Plan.

#### Note 5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are pooled separate accounts managed by Principal Life Insurance Company (Principal Life) and collective investment trust funds managed by Principal Global Investors Trust Co. (Principal Global). Principal Life and Principal Global are affiliates of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and administrative services to Principal Life amounted to approximately \$32,000 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which they receive no compensation from the Plan. Other administrative expenses are paid by either the Plan or the Plan Sponsor as provided by the Plan document.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and IRC. In the event of Plan termination, participants would become 100% vested in their Company contributions and the net assets of the Plan would be allocated to the participants on the basis of their individual account balances.

#### Note 7. Income Tax Status

The Plan has adopted a pre-approved defined contribution plan sponsored by Principal Life Insurance Company. The pre-approved defined contribution plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the pre-approved defined contribution plan's qualified status. The pre-approved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
