### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Abt Electronics, Inc. 401(k) Retirement Savings Plan and Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Abt Electronics, Inc. 401(k) Retirement Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1. Description of the Plan**

The following description of the Abt Electronics, Inc. 401(k) Retirement Savings Plan and Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that covers all employees of Abt Electronics, Inc. and its controlled entity, Abt Home Services, Inc. (Company). Such employees are eligible to participate in the Plan on the first day of the month following the first day of their employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act* (ERISA), as amended by subsequent legislation.

**Contributions**

Each year, participants may contribute up to 100% of their pre-tax annual compensation or the maximum amount allowed in accordance with the Internal Revenue Code (IRC), as defined (\$23,000 in 2024). Participants who have attained age 50 before the end of the plan year are eligible to make a catch-up contribution of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective January 1, 2018, new and rehired eligible employees will be automatically enrolled in the Plan at a 3% pretax contribution rate unless the employee elects a higher or lower pretax contribution rate or declines participation in the Plan. The Company may make annual matching contributions to all participants, who are employed on the last day of the plan year and have completed 1,000 hours of service, equal to a discretionary percentage determined annually by the Company. Employer-matching contributions for 2024, were 50% of participant-directed contributions, limited to \$1,100 per participant. Matching contributions totaled \$1,525,342 (net of forfeitures) for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

The Plan permits participants to direct the investment of their accounts into a variety of registered investment companies and a money market account. Participants may change their investment options daily.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's contributions plus actual earnings thereon are vested at a rate of 25% for each year of service, being fully vested after four years of credited service, or upon death, disability or normal retirement.

**Forfeited Accounts**

Forfeitures are first utilized to pay certain administrative expenses, with any remaining balance used to reduce the employer's matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$34,530 and \$75,935, respectively. During 2024, forfeitures of \$34,530 were used to reduce employer's matching contributions.

***Payment of Benefits***

Payments of benefits are made to participants or their beneficiaries upon death, retirement, disability, termination of employment or for financial hardship, as defined. Benefits are payable in a lump sum or by other methods, as described in the Plan.

***Notes Receivable From Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the prior twelve-month period, with no more than two loans outstanding at any time. Effective July 1, 2019, the Plan was amended to allow no more than one loan outstanding at any time. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined at loan's origination. The interest rates on loans outstanding ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

***Administrative Expenses***

The Company pays certain costs related to plan administration, including outside professional services. Other expenses incurred by participants as a result of investments held and participant transactions are paid by the Plan. Certain investment fees are netted in the net depreciation in fair value of investments.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable noted in 2024. The Plan distributed the 2023 excess contribution payable amounts to the applicable participants in 2024.

***Payment of Benefits***

Benefits are recorded when paid.

**Note 3. Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The money market fund and cash is valued at cost which approximates fair value (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Information Certified by the Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

## **Note 5. Transactions With Parties-in-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of registered investment companies and a money market fund managed by the trustee. Therefore, these transactions qualify as permitted party-in-interest transactions.

Fees paid to the trustees for custodial and administrative services amounted to \$244,133 during 2024. The Company provides certain administrative services at no cost to the Plan.

## **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in all accounts.

## **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. During 2021 and 2020, the Plan engaged in prohibited transactions related to late deposits of employee contributions and loan repayments totaling \$91,115 and \$5,113, respectively. Management corrected these items in 2024.

## **Note 9. Income Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan sponsored by Schwab Retirement Plan Services Inc. This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated September 21, 2020, from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed

and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
