We have performed audits of the financial statements of Mall of America Employee Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mall of America Employee Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the financial statements

Note 1: Description of Plan

The following description of the Mall of America Employee Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of MOAC Mall Holdings, LLC, AD MOA, LLC, and MOAC Land Holdings, LLC (collectively the "Employer" or "Company"), which are indirectly under common ownership. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

The Plan covers substantially all employees of the Company who are age 21 or older and have completed two consecutive months of service as defined by the Plan. Eligible employees are permitted to enter the Plan on the first day of the month coinciding with or following the date on which the employee has met the Plan's eligibility requirements.

Contributions

Each year, participants may contribute voluntary pre-tax and Roth contributions up to 100% of eligible compensation, as defined in the Plan, subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Participants are eligible for Company matching contributions. Company matching contributions are equal to 100% of the first 5% of eligible compensation that an eligible participant contributes to the Plan. The Plan has an automatic enrollment feature whereby an employee is automatically enrolled at a contribution rate of 5% at the time that employee becomes eligible for the Company matching contributions unless they make a contrary election. Additional discretionary amounts may be contributed at the option of the Company. No additional discretionary amounts were contributed for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions and allocations of (a) the Company's discretionary non-elective contributions, and (b) plan earnings (losses). Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to the financial statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and the portion of their accounts credited with the Company's safe harbor matching contributions (prior to January 1, 2015, the Plan provided for Company safe harbor matching contributions), plus actual earnings thereon. Vesting in the portion of a participant's account credited with Company matching and discretionary contributions is based on years of service on a modified schedule over a four-year period. Participants also become fully vested when employed at age 65, upon death, upon permanent disability, or in the event of plan termination.

Notes Receivable From Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one note outstanding at any time, and the term of a note may not exceed five years, unless the note qualifies as a "home loan", as defined, in which case the term may not exceed 15 years. Outstanding notes are secured by the vested balance in the participant's account. The rate of interest on existing notes at December 31, 2024, ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, death, permanent disability or other termination of service, a participant has an option to receive the vested portion of his or her account balance as a lump-sum payment or as installment payments as described in the Plan agreement. The Plan allows in-service withdrawals after age 59½ for any reason and financial hardship withdrawals, as defined, before age 59½. Distribution of benefits upon termination becomes automatic if the participant's account balance is less than \$5,000. Participants with an account balance less than \$5,000 but greater than \$1,000 will have their account balance rolled over to an individual retirement account (IRA) unless they elect to receive a lump-sum payment. Participants with an account balance less than \$1,000 receive a lump-sum payment.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,247 and \$56,865, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, Employer contributions were reduced by \$650,001 from forfeited nonvested accounts.

SECURE 2.0 Act

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective January 1, 2023. Plan management evaluated the impact of the adoption and implementation of this legislation on the Plan and there was no material impact to the Plan for the years ended December 31, 2024 and 2023.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: The collective trust funds are valued at the NAV as reported by the trustee at year end based upon the fund's audited financial statements. The Reliance MetLife Series Stable Value Fund's underlying assets consist of investment contracts and security-backed contracts. The Putnam Retirement Advantage X Funds' underlying assets consist of investments in underlying collective investment trusts established and maintained by Putnam Fiduciary Trust Company. The NAV, as provided by the trustee, is used as a practical expedient to estimate the fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business matter.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, non-interest-bearing cash, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Trustee of the Plan.

Note 5: Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Milliman, Inc. is the record-keeper, as defined by the Plan and qualifies as a party-in-interest. Fees incurred and paid by the Plan for administrative expenses were \$171,893 for the year ended December 31, 2024.

Notes receivable from participants qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Company has adopted a nonstandard pre-approved plan document with an Internal Revenue Service notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
