INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees and Management of
Bread for the World, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bread for the World, Inc. ("Bread") 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements
December 31, 2024 and 2023

1. Plan Description

The following description of the Bread for the World, Inc. (“Bread”) 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 1997, and has been amended and restated to comply with the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined-contribution plan substantially covering all employees of Bread.

Eligibility

All employees, except for interns, consultants, fellows, temporary employees, and residents of Puerto Rico, are eligible to participate in the Plan. Employees who have completed at least one year of service in which they worked at least 1,000 hours and are still employed on the last day of the Plan year are eligible for employer contributions. There is no service requirement for employee deferrals.

Contributions

Participating employees can elect to make voluntary, pretax contributions to the Plan by salary deferral, subject to Internal Revenue Code (IRC) limitations. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Regardless of the type of deferral a participant makes, the amount an employee defers is counted as compensation for the purposes of Social Security taxes. Participants direct the investment of their funds into various investment options offered by the Plan.

The Plan also includes an automatic salary deferral feature where Bread automatically withholds a portion of employees’ compensation and contributes that amount to the Plan as a pretax deferral. These automatic contributions are based on 1% of an employee’s gross annual compensation. Bread will increase the automatic contribution amount by 1% per year, up to a maximum of 6% per year. Such increases will be applied as of the second period that begins after the period in which the initial deferral amount was withheld and will occur as of each April 1st. If the employees choose not to participate in the Plan, Bread will refund the deferrals within 90 days of the first automatic deferral, provided that the employees notify Bread within a reasonable period of time prior to the end of the 90-day period.

Contributions (continued)

The Plan is also funded by voluntary employer discretionary profit-sharing contributions to all eligible participants. Should Bread determine that distributions are to be made, as of December 31 of each year (the annual valuation date), Bread will make a contribution on behalf of each eligible employee who is employed on that date, based on 8.6% of the participant's compensation for the year ending on the annual valuation date, plus 4.3% of such compensation that exceeds 25% of the Social Security taxable wage base in effect on the annual valuation date and employee deferral contributions up to the maximum amount allowed by the Internal Revenue Service (IRS). Employees select the funds to which employer contributions are allocated.

Participant Accounts

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and allocations of Bread's contributions and Plan earnings and losses, less an allocation of administrative expenses. Earnings and losses are allocated by fund based on the ratio of a participant's account balance in a particular fund to all participants' account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account. Participants may change their investment elections and their contribution percentage at any time.

Vesting

All employee contributions and actual earnings thereon are 100% vested. Vesting of employer contributions is based on an employee's years of service, as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants may not have more than one loan outstanding at any time, and participants can borrow only from employee deferrals. The notes are secured by the balance in a participant's account and bear interest at the prime rate published in *The Wall Street Journal* on the date of the loan application plus 1%, which totaled 8.50% at December 31, 2024. Loan terms range from one to five years; however, loans made for the purpose of purchasing a primary residence may be for a longer term.

Payment of Benefits

Upon retirement, disability, resignation, or termination, a participant, or his or her beneficiary in the event of the participant's death, is entitled to receive, as of his or her determination date, an amount equal to the vested portion of the participant's account, determined in either a lump-sum payment or under various installment payment arrangements.

The funds of inactive participants are held in a personal retirement account (PRA) until a terminated employee elects a distribution from his or her account. PRA funds remain retirement funds until distributed. PRA funds for inactive participants that are less than \$5,000 are automatically distributed to the participant.

Forfeited Accounts

Forfeited contributions can be used to reduce future employer contributions or pay Plan expenses. During the year ended December 31, 2024, \$2,659 of the forfeited balance was used to reduce employer contributions. Forfeited nonvested accounts totaled \$1 and \$2,575 at December 31, 2024 and 2023, respectively. Accumulated forfeitures will be applied to reduce the employer contributions or pay Plan expenses in 2025.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair market value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Notes receivable from participants are exempt from the credit loss guidance in Financial Accounting Standards Board (FASB) issued Accounting Standards Update 2016-13, *Financial Instruments – Credit Losses* (Topic 326), *Measurement of Credit Losses on Financial Instruments*; therefore, no allowance for credit losses has been recorded at December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants totaling \$18,141 for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to 2024 contributions. The Plan distributed the 2024 excess contributions prior to March 15, 2025.

Payment of Benefits

Benefits and other distributions are recorded when paid.

Administrative Costs

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through August 28, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The Plan follows FASB Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, for its financial assets. This standard establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value measurement standards require an entity to maximize the use of observable inputs (such as quoted prices in active markets) and minimize the use of unobservable inputs (such as appraisals or other valuation techniques) to determine fair value. The categorization of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to the entity's perceived risk of that instrument.

The inputs used in measuring fair value are categorized into three levels:

Level 1: Inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to this valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following section describes the valuation methodologies the Plan uses to measure its assets at fair value.

Pooled separate accounts: The investments in the custodian's pooled separate accounts represent ownership of units of participation in the separate accounts. The separate accounts earn and hold the underlying mutual funds, which are valued daily at their net asset value (NAV). The value of a unit of participation is the total value of each separate account divided by the number of units outstanding. The investments in the pooled separate accounts are stated at fair value and are based on quoted redemption values on the last business day of the year.

Generally accepted accounting principles permit NAV per share to represent fair value for reporting purposes as a practical expedient when the fair value is not readily determinable, unless it is probable the investment will be sold at something other than NAV. Investments measured using the NAV practical expedient are not categorized in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive traditional investment contract available through an annuity contract issued by Voya Retirement Insurance and Annuity Company ("Voya Financial") totaling \$1,500,766 and \$1,477,474 for December 31, 2024 and 2023, respectively. The minimum crediting rate under this contract is 3.00%. The Voya Fixed Account is an obligation of Voya Financial's general account, which supports all of Voya Financial's insurance and annuity commitments. They are not portfolios of contracts whose yields are based on changes in fair value of underlying assets. As a result, the average yield earned by the Plan is the yield earned on the annuity contract. Voya Financial is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

When establishing interest credit rates for this product, Voya Financial considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The average yield based on actual earnings for the Voya Fixed Account was 2.75% and 2.71% for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include the following:

- (i) amendments to the Plan documents (including complete or partial plan termination or merger with another plan);
- (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
- (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary), which cause a significant withdrawal from the Plan; or
- (iv) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Plan's custodian, Voya Financial. Accordingly, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, Bread has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested, and the assets shall be allocated among participating employees and beneficiaries in proportion to the employees' respective account balances.

7. Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

A concentration is defined as an investment representing 10% or more of the total investment value as of December 31, 2024. There were three individual investments that represented a concentration of investments as of December 31, 2024.

8. Information Certified by the Custodian

The Plan Administrator has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Financial, the custodian of the Plan assets, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplementary schedule as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

9. Tax Status

The Plan is intended to be qualified under IRC Section 401(k). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC.

The Plan's management has evaluated the Plan's tax positions and concluded that there are no significant uncertain tax positions that qualify for either recognition or disclosure in the accompanying financial statements.
