### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Iowa Rotocast Plastics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. Description of Plan

The following description of the Iowa Rotocast Plastics, Inc. (Company) 401(k) Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

##### a. General

The plan is a defined contribution plan with 401(k) plan provisions covering all employees of Iowa Rotocast Plastics, Inc. and Kolor Graphics, LLC, who have attained age eighteen and have completed six months of service. Employees are automatically enrolled in the plan with a 5% automatic deferral rate unless the employee opts out of participating in the plan. On May 1, 2023, Grizzly Coolers ceased its participation in the plan as a result of the merger of Grizzly Coolers into Iowa Rotocast Plastics, Inc. The Board of Trustees is responsible for oversight of the plan. The Investment Committee determines the appropriateness of the plan's investment offerings, monitors investment performance and reports to the plan's Board of Trustees. The plan is subject to the provisions of the Employee Retirement Income Security Tax Act of 1974 (ERISA).

In December of 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect.

##### b. Contributions

The Company has chosen Safe Harbor Matching Contributions where 100% of deferrals that do not exceed 3% of compensation, plus 50% of deferrals that exceed 3% of compensation but do not exceed 5% of compensation, will be matched by the Company. Participants may elect to contribute any amount of their annual wages as defined in the plan subject to the following limitations. The maximum amount an individual can contribute to the plan in any calendar year is limited to the applicable limit under the Internal Revenue Code Section 402(g). The maximum amount under the Internal Revenue Code Section 402(g) is \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The maximum catch-up contribution is \$7,500 for each of the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Roth option is available as an investment option under the plan.

##### c. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

d. Vesting

Effective January 1, 2004, the Company has elected to make Safe Harbor Matching Contributions that are fully vested (see Note 1.b). Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Any employees participating in the plan prior to January 1, 2004, are now 100% vested.

e. Hardship Withdrawals

The amount of the withdrawal cannot exceed the amount of the hardship but may include the amount necessary to pay federal and state taxes. Hardship withdrawals can be for medical expenses, costs to purchase principal residence, tuition or related educational fees for the next twelve months of post-secondary education, payments to prevent eviction from principal residence, payments for burial or funeral expenses and expenses for the repair or damage to principal residence that would qualify for the casualty deduction under the Internal Revenue Code. Earnings on accounts may not be included in the hardship withdrawal.

f. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through weekly payroll deductions.

g. Retirement, Disability and Death Benefits

A participant may retire on their normal retirement date or any valuation date thereafter. Upon retirement, a participant's vested account is paid in a lump sum payment.

If a participant dies prior to retirement or termination of employment, the amount due him/her will be paid to their beneficiary in cash. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

2. Summary of Accounting Policies

a. Basis of Accounting

The financial statements of the plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

See Independent Auditor's Report.

2. Summary of Accounting Policies (Continued)

b. Investment Valuation and Income Recognition

The plan's investments are reported at fair value (except for the fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments purchased and sold as well as held during the year.

c. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. As of December 31, 2024 and 2023, the balance of notes receivable from participants totaled \$188,286 and \$193,699, respectively.

d. Payments of Benefits

Benefits are recorded when paid.

e. Management Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

f. Administrative Expenses

Certain expenses of maintaining the plan are paid by the plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Contract fee expenses for John Hancock Life Insurance Company (U.S.A.) are paid by the plan, from plan assets. The Company pays administrative expenses for the third-party administrator and the auditing firm.

g. Date of Management's Review

Management has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

4. Guaranteed Interest Accounts with John Hancock Life Insurance Company (U.S.A.)

Contributions under the group contract can be allocated to guaranteed interest accounts (referred to as "guaranteed accounts"), which are not, by definition, an investment contract, but rather are an investment option offered under the John Hancock Life Insurance Company (U.S.A.) group annuity contract. John Hancock Life Insurance Company (U.S.A.) maintains the contributions in a general account. Guaranteed accounts guarantee the return of principal plus compound interest earned over a defined three, five or ten-year term, less applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guarantee period.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the plan by John Hancock Life Insurance Company (U.S.A.), represents contributions made, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the group contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$18,667 and \$17,801 respectively. Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month. This is called the "new money" regular rate. For other types of contributions, interest rates may differ and may change during the month. At the end of each reporting year, a "composite rate" of interest is determined for each participant's account, depending on the amount contributed and the rate in effect on the day it is allocated under the participant's account. The composite rate is the effective annual rate earned by all contributions to that guaranteed account during the reporting year for that participant. Contributions continue to earn the calculated composite interest rate for the duration of the guaranteed term.

4. **Guaranteed Interest Accounts with John Hancock Life Insurance Company (U.S.A.) (Continued)**

Certain events might limit the ability of the plan to transact at contract value with John Hancock Life Insurance Company (U.S.A.). Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan trustees do not believe any events, which would limit the plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. **Fair Value Measurements**

The fair value measure accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs include quoted prices for similar assets and liabilities in active markets, and level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when level 1 or level 2 inputs were not available. The plan had no level 2 or level 3 measurements for the periods presented and there were no changes in the methods used to measure fair value as of December 31, 2024 and 2023.

Accounting guidance on fair value measurements are classified and disclosed in the following category:

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values on the shares as reported by the fund. The mutual funds held by the plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the plan are considered to be actively traded.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

6. **Income Tax Status**

The non-standardized pre-approved plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the underlying non-standardized, pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the plan administrator and the plan's tax counsel believe that the plan is currently being designed and operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified, and the related trust is tax exempt.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

8. Administrative Expenses

Contract fee expenses for John Hancock Life Insurance Company (U.S.A.) are paid by the plan, from plan assets. The Company pays administrative expenses for the third-party administrator and the auditing firm.

9. Related Party Transactions

Certain plan investments are shares of mutual funds managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the record-keeper and therefore, these transactions qualify as party-in-interest. Fees paid by the plan for the record-keeper services amounted to \$75,916 and \$64,089, for the years ended December 31, 2024 and 2023, respectively.

Certain employees and officers of Iowa Rotocast Plastics, Inc., who may also be participating in the plan, perform administrative services to the plan. Iowa Rotocast Plastics, Inc. does not charge fees for these administrative services to the plan.

10. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect each participant's account balances and the amounts reported in the statements of net assets available for benefits.
