### Note A – Description of Plan

The following description of the Chico's FAS, Inc. 401(k) Elective Deferral Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established to provide benefits for employees of Chico's FAS, Inc. (the "Sponsor"). The Plan was formed and adopted on January 1, 1992 and most recently restated effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

All employees of the Company are eligible to participate in the Plan except for leased employees, self-employed individuals, collectively-bargained employees, nonresident alien employees, employees who are residents of Puerto Rico, and the Sponsor's employees located in Guam, U.S. Virgin Islands, or other possessions of the U.S. Employees become eligible after working six months of service and attaining age 21, as defined in the Plan agreement. Eligible participants are enrolled in the pay period following meeting eligibility requirements.

#### Administration

The accounting records are maintained by the Company. The Plan's assets were held and managed by T. Rowe Price Trust Company (the "Trustee"). Contributions are held by the Trustee, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Sponsor Contributions

Under the Plan, the Sponsor provides a matching contribution of 50% of the first 6% of a participant's eligible compensation deferred in each payroll period. In addition, the Sponsor makes 1.75% contribution on maximum of 3.5%.

#### Participant Contributions

The Plan allows eligible participants to make contributions up to 75% of compensation per payroll period, as defined by the Plan agreement, limited by requirements of the Internal Revenue Code (IRC). The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to IRS limitations of \$7,500 for the year ended December 31, 2024. Participants can direct their contributions to any of the Plan's fund options and may change their investment options on a daily basis.

#### Participant Accounts

Each participant's account reflects the participant's contributions as well as an allocation of the Sponsor's contributions and Plan earnings and an allocation of administrative expenses. Allocations are based on participant earning or account balances, as defined. The benefit to which a participant is entitled is the aggregate total of such contributions and allocations. This benefit is subject to the application of the Plan's vesting schedule.

#### Vesting

Participants are fully vested in their contributions and the earnings thereon. A participant becomes fully vested in Sponsor matching contributions and earnings thereon upon reaching age 65, death, permanent disability, and after five years of credited service as follows:

#### Forfeitures

Forfeited accounts are used to pay administrative fees and reduce Sponsor contributions, with any remaining amounts allocated to participants on the last day of the Plan year. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$500 and \$31,000, respectively. For the year ended December 31, 2024, approximately \$276,000 of forfeitures were used to offset employer matching contributions.

#### Distribution of Benefits

Upon death, retirement, disability, or termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, substantially equal installments, partial withdrawals, or have the vested interest directly rolled over into an eligible retirement plan. Participants may also request in-service distributions at age 59 ½. Benefits may be received when a participant demonstrates a situation of financial hardship as defined by the IRC. Distributions are paid as soon as administratively possible.

#### Notes Receivable from Participants

Subject to approval, participants can secure a loan from the Plan against their account balance. Participants can borrow up to a maximum of \$50,000 or 50% of their vested account balances, whichever is less. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. The minimum amount to be taken for a loan is \$1,000. Loans must be repaid through automatic payroll deductions, unless otherwise provided by the Sponsor. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. At December 31, 2024, interest rates ranged from 3.25% to 8.50% on outstanding participant loans.

The Plan Administrator shall consider a loan in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. In the event of a default, death, disability, or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. However, if the termination of employment results from a corporate action on the part of the employer and the participant remains performing the same job after that corporate action, within 60 days of the termination of employment, the participant may request that the Plan Administrator roll over the loan to the new employer's retirement plan. Unless the participant rolls over the loan, any default in repayment to the Plan will result in the treating of the balance due as a taxable distribution from the Plan.

#### Plan Termination

Although it has not expressed any intent to do so, the Sponsor may, at its option, terminate the Plan. Upon termination of the Plan, the Trustee would provide payments to participants in accordance with the Plan agreement. In the event of Plan termination, all participants would become 100% vested in their account balances.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Participant loans are valued at their outstanding balances, which approximate fair value. The Plan's interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1*                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*                      Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### Fair Value Measurements (continued)

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common Collective Trusts:* Valued at net asset value ("NAV") provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, a qualified institution. For the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by T. Rowe Price Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Party-In-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are mutual funds and common collective trusts managed by the Trustee. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$383,000 during the year ended December 31, 2024.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Income Tax Status

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service (IRS) dated August 19, 2020 stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code, and therefore, the related trust is tax exempt. Subsequent to the issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note G – Subsequent Events

Subsequent events have been evaluated through September 4, 2025 which is the date the financial statements were available to be issued.
