**NOTE 1 - DESCRIPTION OF THE PLAN**

The Central California IBEW-NECA Profit Sharing Plan (the “Plan”) is a defined contribution multiemployer profit sharing plan with an optional 401(k) salary deferral plan covering all eligible employees in accordance with collective bargaining agreements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are reported on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results may differ from those estimates.

**C. Participant and Employer Contributions**

Contributions as reported are contributions made for hours worked during the year. Participant and employer contributions receivable are estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts. Participants have the option to defer up to \$9.00 per hour of their gross earnings, not to exceed Internal Revenue Code (“IRC”) annual deferral limits.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under a separate payroll compliance program.

**E. Investment Valuation and Income Recognition**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs are quoted prices in an active market.

- Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.
- Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Level 1 investments consist of mutual funds and a U.S. Treasury Note recorded at fair value based on quoted prices in active markets. The following tables represent the Plan's fair value hierarchy for its financial assets measured at fair value on a recurring basis as of December 31:

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Realized and unrealized gains and losses are computed using investments' cost for financial statement purposes. For Form 5500 reporting, realized and unrealized gains and losses are computed using investments' market values as of the beginning of the year.

**F. Tax-Exempt Status**

The Plan received its latest tax determination letter on February 17, 2016. The Plan administrator and the Plan's legal counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for federal or state income tax is made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investment. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonable possible that the changes in risks in the near term would materially affect the amounts reported in the financial statements.

**H. Subsequent Events**

Management has evaluated subsequent events through August 14, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.

**NOTE 3 - PLAN TERMINATION**

Upon the termination of the Plan, per the Agreement and Declaration of Trust, any and all monies remaining in the Plan after payment of all expenses and obligations of the Plan shall be either expended and used for the continuance of purposes of the Plan, until such monies have been exhausted, or transferred to another trust or trusts providing similar benefits.

**NOTE 4 - RELATED PARTY TRANSACTIONS**

The Plan uses personnel from Locals 413 and 639 (the "Locals"), which are parties to collective bargaining agreements governing the Plan, for various administrative and accounting services benefiting the Plan participants. A portion of the cost of these services is allocated between the Plan and the Central California IBEW-NECA Pension Trust Fund ("Pension Plan"). The Locals charge the Plan a fixed monthly fee based upon periodic time studies approved by the Board of Trustees.

The Plan shares common administrative expenses with the Pension Plan. The common administrative expenses are allocated based on the ratio of each plan's net assets available for benefits to the combined net assets available for benefits at the beginning of the plan year.

The Plan leases office space from Local Union 413 at \$43 per month.

The Plan administrator collects and processes reciprocity contributions on behalf of the Plan and the Pension Plan. At December 31, 2024 and 2023, the Plan owed the Pension Plan \$105,601 and \$174,776, respectively, for reciprocity contributions collected and processed for the Pension Plan.

**NOTE 5 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the year ended December 31, 2024, various contributing employers remitted some participant contributions later than required per the collective bargaining agreement. Failure to remit or untimely remittance of participant contributions constitutes a prohibited transaction under Department of Labor regulations. During the year ended December 31, 2024, the late contributions totaled \$76,131.
