Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Arroyo Vista 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Year Ended March 31, 2025**

Note 1 – Description of Plan

The following description of the Arroyo Vista 401(k) Plan (the “Plan”) provides only general information. Arroyo Vista Family Health Center (the “Company”) is the plan sponsor. Fidelity Management Trust Company (“Fidelity”) is the custodian of the Plan. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees who have completed one year of service with at least 1,000 hours of service and are age 21 or older. The Plan was established on October 1, 1990, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan agreement, subject to a maximum annual limit by the Internal Revenue Service. Effective January 1, 2025, pre-tax contributions are subject to a limitation of \$23,500, plus a catch-up contribution of \$7,500 for participants age 50 or older. Additionally, IRS made specific changes in 2025 where employees aged 60 to 63 may contribute up to \$11,250 instead of \$7,500 catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain IRAs (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary contributions at the option of its Board of Directors. For the year ended March 31, 2025, total Company discretionary contribution was \$273,558.

Participant accounts

Individual accounts are maintained for each participant in the Plan. Each participant’s account is credited with the participant’s contributions and the Company’s discretionary contributions, if any, as well as allocations of Plan earnings and allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company contributions plus actual earnings thereon is based on years of continuous service. Company's contributions are 100% vested after six years of credited service, as specified by the Plan agreement.

Investment options

The Plan offers various investment options which are managed by Fidelity. Upon enrollment in the Plan, participants may direct their contributions in any of the investment options offered at the time. Participants may change their investment options daily. Participants should refer to the investment literature provided by the Company for a complete description of the investment options and for the detailed composition of each investment fund.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$500 up to the lesser of (a) 50 percent of their account balance or (b) \$50,000 reduced by their highest unpaid loan balance outstanding (principal and interest) during the preceding twelve-month period. The loans are secured by the balance in the participant's account. Loan terms range from one to five years, or more than five years if a loan is for the purchase of a participant's primary residence, and loans are repayable ratably through payroll deductions. At March 31, 2025 and 2024, interest on notes receivable from participants ranged from 3.25% to 8.5% per annum, with maturities through March 2045.

Payment of benefits

Upon termination of service due to death, disability, retirement, termination of employment, or financial hardship, participants may elect to receive the vested interest of their accounts in the form of a single sum of cash payment, or a direct rollover to an individual retirement account or another employer plan. In-service distributions are available to employees who have attained age 59 1/2. Hardship withdrawals are also available.

Forfeited Accounts

At March 31, 2025 and 2024, forfeited nonvested accounts totaled \$44,900 and \$117,399, respectively. These accounts will be used to reduce future Company contributions and to pay administrative expenses of the Plan.

Note 2 – Summary of Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of estimates

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Significant estimates include the fair value of certain investments. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in aggregate fair value includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. At March 31, 2025 and 2024, there was no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances.

Payment of benefits

Benefits are recorded when paid in accordance with ERISA reporting requirements.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess contributions payable

At March 31, 2024, contributions in excess of amounts allowed by the Internal Revenue Service of \$5,703 are payable to certain participants, and are recorded as liabilities. At March 31, 2025, there were no excess contributions payable.

Note 3 – Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

Level 2 – Quoted prices other than those included in Level 1 that are observable either directly or indirectly. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or that can be corroborated by observable market data for substantially the full term of the financial instrument.

Level 3 – Inputs are unobservable and significant to the fair value measurement. Unobservable inputs reflect the Plan’s own judgements about assumptions that market participants would use in pricing the asset or liability.

The following are descriptions of the valuation methods and assumptions used for investments of the Plan. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Mutual funds: Mutual funds are valued at the daily closing price as reported on the active market on which the individual funds are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund held through a Collective Trust Fund: Participants may elect to invest in the Fidelity Advisors Stable Value II (“FA Stable Value II”), a stable value fund held through a common collective trust which primarily invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money

market funds. The Plan invests indirectly through FA Stable Value II in these investment contracts. The fair value of the investment in FA Stable Value II is measured at NAV per share as reported by the fund manager. The net asset value is used as a practical expedient to estimate fair value. The redemption frequency is daily and there are no restrictions or notice period required. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As of March 31, 2025 and 2024, there were no unfunded commitments or other redemption restrictions on the investment in FA Stable Value II.

During the year ended March 31, 2025, there were no transfers of assets between Levels 1, 2 and 3. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of March 31, 2025 and 2024:

Note 4 – Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the asset custodian of the Plan.

Note 5 – Related Party and Party-In-Interest Transaction

At March 31, 2025 and 2024, certain plan investments are interests in separate accounts managed by Fidelity. Therefore, the transactions with Fidelity are party-in-interest transactions. Additionally, the Company provides certain accounting and administrative services to the Plan for which no fees are charged. As the Company is the Plan sponsor, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions, if any.

Note 7 – Tax Status

The Plan currently operates under a prototype plan offered by Fidelity, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore is exempt from federal and state income taxes.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of March 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At March 31, 2025, the plan had three investments which exceeded 10% of total investments: Fidelity Freedom 2035 A Fund – 17.2%, Fidelity Freedom 2045 A Fund – 13.4%, and Fidelity Freedom 2015 A Fund – 13.2%.

At March 31, 2024, the plan had four investments which exceeded 10% of total investments: Fidelity Freedom 2035 A Fund – 16.8%, Fidelity Freedom 2015 A Fund – 13.2%, Fidelity Freedom 2045 A Fund – 13.0%, and Fidelity Freedom 2020 A Fund – 10.1%.
