NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of Wendpartners 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a multiple-employer defined contribution plan covering eligible employees from participating employers under the corporate action of Wendcentral Corp (collectively known as the “Employers”). In 2024, twenty-four companies participated in this Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Transfer of Assets

The Plan Sponsor signed a merger resolution with an existing plan with an effective date of December 31, 2024. All assets and liabilities of the Wabash Management Corp 401(k) Plan (EIN 35-1635315, Plan 001) were transferred into the Plan as of the effective date. A summary of the transferred in net assets are as follows and are included within the statements of net assets available for benefits and statements of changes in net assets available for benefits:

Eligibility

Employees are eligible to begin salary deferrals after they have completed one year of service with at least 1,000 hours worked and have attained the age of twenty-one. The discretionary employer match and profit-sharing feature of the Plan requires employees to have completed 501 hours of service during the plan year or be employed with the Employers as of the last day of the Plan year.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, subject to maximum limitations established by the Internal Revenue Code. Effective January 1, 2024, participants may make Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Discretionary employer matching and profit-sharing contributions may be made at the option of the Employers’ management. Contributions are subject to certain limitations and any matching contributions are intended to meet certain requirements under the Internal Revenue Code. Discretionary employer matching contributions of \$53,622 and \$57,404 were made in 2024 and 2023, respectively. No profit-sharing contributions were made in 2024 or 2023.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of discretionary employer contributions, Plan earnings/losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in the Employer's discretionary matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

Hardship withdrawals are permitted in the event of immediate and heavy financial need. Participants may elect to receive a hardship withdrawal in an amount equal to the value of their elective deferral contributions.

In-service withdrawals are permitted for participants that are age 59 ½ or older.

Notes Receivable from Participants

The plan does not typically allow notes receivable from participants. As part of the plan's joinder agreement, the Plan was amended to allow one of their new participating employers to maintain any existing notes, however no new loans will be allowed. The loan and interest thereon shall be repaid over a period. The loans are secured by the balance in the participant's account and bear interest at a rate of prime. The interest rates on outstanding loans range from 7.25% to 9.5% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Investment Options

Investments are held within various investment funds offered and maintained by John Hancock Life Insurance Company of New York. Contributions are invested, at the discretion of the participant, in one or a combination of available investment options.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$564 and \$1,324, respectively. These accounts are used to reduce Employer contributions. In 2024 and 2023, \$1,193 and \$2,568, respectively, of forfeitures were used to reduce Employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles general accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Employers absorb reasonable expenses incurred in the administration of the Plan that include Plan administrative, accounting and legal fees. Expenses related to certain participant transactions, such as fees related to distributions and participant loans, are deducted from the participant's accounts as the transactions occur. All other expenses, including certain plan administrative and advisory fees, are allocated against the accounts of all participants.

Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Fair Value Measurement - Definition and Hierarchy (Continued)

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value Measurement - Definition and Hierarchy

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 3.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

3. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets for which fair values are estimated using the net asset value (NAV) practical expedient.

- *Pooled separate accounts:* valued at NAV of units held by the Plan, based on the accumulated values of the underlying investments. Unit values are determined daily based on the net asset value of the quoted market prices of the underlying investment, the fund's dividends and the contract separate account changes.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by John Hancock Life Insurance Company of New York, who act as custodian as defined by the Plan. Transactions with this entity qualify as a party-in-interest transactions.

In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' account. Therefore, these related transactions qualify as party-in-interest transaction

6. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by CCH Incorporated, DBA FTWILLIAM.COM. The pre-approved plan received an IRS opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

While total net assets available for benefits and the total change in net assets available agree between the financial statements and Form 5500 for 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.
