## Plan Provisions (continued)

### Normal Retirement

#### Eligibility Definition

The normal retirement date for each participant is the first of the month coincident with or next following the attainment of age 62 and a minimum of five (5) years of plan participation.

#### Benefit Definition

The amount of annual retirement benefit payable according to the payment form chosen is calculated as follows:

- 8.0% of Final Average Compensation (FAC) times Years of Credited Service with a maximum of 10 years.

Credited Service is determined from years of participation.

### Accrued Benefit

The Monthly Accrued Benefit, with respect to the formula above, as of any date, is calculated using Credited Service earned to date.

### Delayed Retirement

Eligibility is the first of the month on or next following the actual date the participant terminates employment after normal retirement date. The benefit is based on the actuarial equivalent of the benefit payable at normal retirement date.

### Early Retirement

#### Eligibility Definition

The plan does not provide an early retirement benefit. Any benefit available prior to the normal retirement date will be calculated as a termination benefit.

#### Benefit Definition

None

### Disability

The plan does not provide a special benefit for disability. A disabled plan participant is entitled to any other benefit that might have been accrued under the plan.

## Plan Provisions (continued)

### Death Benefit

#### Eligibility

Eligibility is not contingent on vesting.

#### Benefit Definition

Pre-Retirement: Present value of the participant's accrued benefit at the date of death. If married, the Qualified Joint and 100% Survivor spouse benefit would be payable the balance, if any, of the present value payable to the named Beneficiary.

Post-Retirement: Benefit payable, if any, per terms of retirement option chosen.

### Method of Payments

Under the Normal Form of payment, a participant's retirement annuity is payable monthly for life, without further payments after death. A participant may elect to receive the annuity under one of the following actuarially equivalent option modes:

- A lump sum payment of the actuarial equivalence of the participant's retirement benefit (subject to the benefit restrictions of IRC § 436)

Unless the participant has elected an option above, it is automatically assumed that a married participant has elected a Joint and Last Survivor option with 100% of the initial amount continued to the surviving spouse as contingent annuitant.

## **Plan Provisions (continued)**

### **Amendments**

The employer reserves the right to amend the Plan at any time. If the Plan is terminated, the plan assets will be distributed among the plan participants based upon a priority allocation procedure and the Employer shall be liable for any unfunded vested benefits to the extent required by law.

## **Actuarial Funding Method**

### **Unit Credit Actuarial Cost Method**

Under the Unit Credit Actuarial Cost Method, the Target Normal Cost for the current plan year is the present value all benefits expected to accrue or be earned during the current plan year. The Funding Target (accrued liability) is the present value of all benefit accrued up to the plan valuation date.

PPA provides that any excess of the Funding Target over the Adjusted Assets will be amortized over a seven-year period. This shortfall amortization becomes part of the current year funding. The remaining balance of this amortization becomes part of the funding formula for the next plan year. In the event that there is no shortfall in a subsequent plan year then all amortization bases from prior plan years become zero.


