Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Graham Corporation Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note A - Description of the Plan

The following brief description of the Retirement Income Plan of Graham Corporation (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

This defined benefit plan provides pension benefits to employees of Graham Corporation (the Company) as described below. The assets of the Plan are maintained in an investment trust held by Vanguard Fiduciary Trust Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is covered by the Pension Benefit Guarantee Corporation (PBGC).

The Plan was frozen to new employees effective January 1, 2003. Each employee of the Company hired prior to January 1, 2003 became a participant of the Plan upon completion of one year of service. Plan participants are eligible for their plan benefit after terminating employment with vested rights.

The Graham Corporation Retirement Plan Committee of the Company, which is appointed by the Company's Board of Directors, is responsible for oversight of the Plan. The Graham Corporation Retirement Plan Committee determined the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Vesting

A participant is 100% vested in the Plan Sponsor's contribution after five years of credited service and 0% vested if less than five years of service have been credited. A participant also becomes fully vested if employed by the Company or a controlled group member at normal retirement age.

Funding Policy

As described in the Plan, the Company makes regular contributions to the Plan in such amounts as shall be determined by the actuary to be required under accepted actuarial principles in order to meet the minimum funding requirements of ERISA. The Company's contributions are based on annual normal service costs plus amortization of the unfunded prior service costs. The Company met the minimum funding requirements of ERISA for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, the Company did not make any contributions to the Plan.

Benefit Payments

Under the terms of the Plan, participants are eligible for normal retirement upon reaching age 65 and early retirement upon reaching age 55 with fifteen years of credited service. Payment of benefits shall be in the form of a lump-sum distribution (maximum \$65,000) or an annuity. The distribution method is selected by the participant upon commencement of payments.

The annual normal retirement benefit is as follows: 50% of the participant's average final compensation less their 50% of the participant's primary social security benefit. This is multiplied by a fraction, the numerator of which is the years of creditable service (up to a maximum of 30) and the denominator of which is 30.

Death and Disability Benefits

If an active employee dies, a death benefit equal to the value of the employee's accumulated pension benefit under the 100% joint and survivor option is paid to the employee's qualifying surviving spouse. Active employees who become totally disabled receive annual disability benefits that are equal to the normal retirement benefit at normal retirement based on average final compensation and social security on date of disability, with service projected to normal retirement date they have accumulated.

NOTES TO FINANCIAL STATEMENTS

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Risks and Uncertainties

The Plan holds investment securities, primarily mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The mutual funds are stated at fair value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Annuity Purchases

During 2024 and 2023, the Plan released liabilities for vested benefits of certain participants through the purchase of nonparticipating annuity contracts with a third party insurance company in the amount of \$1,451,920 and \$1,382,871, respectively. These assets are excluded from Plan assets upon purchase.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued. As of February 10, 2025, U.S. Bank N.A. has become the trustee of this Plan.

Note C - Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to service rendered by participants as of the valuation date. Accumulated plan benefits include benefits expected to be paid to (1) retired or terminated participants or their beneficiaries, (2) beneficiaries of participants who died, and (3) present participants or their beneficiaries. Benefits under the Plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefit for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The accumulated benefit information was determined by the Plans actuary, The Burke Group. Significant assumptions underlying this information included: (a) assumed investment return of 5.59%; (b) assumed normal retirement age is the earlier of age 63 with 15 years of service or age 65; and (c) assumed life expectancy of participants based upon the PRI-2012 mortality tables projected generationally with scale MP-2021. The interest rate used to discount the obligation for 2024 was 7.0%. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuation been performed as of December 31, 2023 there would be no material differences.

Note E - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds held by the Plan are measured at fair value based upon the net asset value of shares held by the Plan at year end (Level 1).

Note F - Federal Income Tax Status

The Plan obtained its latest determination letter on September 29, 2016 in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G - Party-in-Interest

Certain plan investments are managed by Vanguard Fiduciary Trust Company (Vanguard). Vanguard is the current trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. As described in Note B, the Plan paid certain expenses related to Plan Operations and investment Activity to various service providers which also qualify as party-in-interest transactions.

Note H - Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the Pension Benefits Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
3. Other vested benefits (that is, vested benefits not insured by the PBGC).
4. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the financial conditions of the Company and on the level of benefits guaranteed by the PBGC.

Note I - Nonexempt Transaction

During the year ended December 31, 2023, the Plan inadvertently paid an invoice for a separate defined contribution plan sponsored by the Company in the amount of \$17,000. The Company intends to correct the nonexempt transaction by refunding the Plan for the amount paid. The Company intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction will be made from the Company's assets and not from assets of the Plan.

Projected Unit Credit

The actuarial cost method used in the development of the maximum contribution and the at-risk liabilities, if applicable, was projected unit credit cost method.

Under this method, the normal cost is the sum of the individual normal costs for all participants. For an active participant, the individual normal cost is the present value at the current age of the projected benefit at the assumed retirement age, based on the actuarial assumptions, divided by the participant's expected years of credited service at that age. For a non-active participant, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all plan participants. For an active participant, the individual accrued liability is the product of the normal cost and the total years of credited service at the current age. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded actuarial accrued liability equals the actuarial accrued liability less the valuation assets.

Asset Valuation Method:

The actuarial value of the assets is determined by using the average value of the fair market value of the plan's assets at the valuation date over a 24 month period adjusted for contributions, distributions, expected earnings, and includes contributions receivable. The asset value determined under this method is adjusted to be no greater than 110% and no less than 90% of the fair market value of assets.

Participants included in valuation:

All employees who are eligible to participate as of the valuation date, plus retirees, beneficiaries and terminated participants entitled to current or future benefits.

50% of final average salary less 50% of the primary social security benefit, reduced for service less than 30 years. Effective January 1, 2002, salary is limited to \$200,000, indexed for inflation. Final average compensation is the average of the annual basic compensation for the highest five consecutive calendar years during the last ten years of employment prior to termination. Normal Retirement benefits cannot be less than greatest Early Retirement benefit.

Effective December 1, 2017 the Plan was amended to offer a lump sum option, subject to a \$65,000 threshold, to those participants who were previously excluded from a lump sum payout because they have both a benefit payable from the John Hancock Insurance Co. and from the Trust fund. Also, the Plan was amended to allow a temporary window which allowed for an unlimited lump sum distribution to vested terminated plan participants during the month of December, 2017.

Assumptions for Optional Forms of Payment

Optional forms of payments are approximately equivalent in value to the normal form of payment for single participants, i.e. the life annuity option. The conversion factors are calculated using actuarial equivalence, which by definition is based on the 1983 Group Annuity Mortality Table and an interest rate of 7.50%.

Contributions

The employer pays the total cost of the plan.
