Independent Auditors' Report

The Plan Participants and Plan Administrator
Massachusetts Mutual Life Insurance Company Agent Pension Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Massachusetts Mutual Life Insurance Company Agent Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical



requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and



disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting, as described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements (Modified Cash Basis)

1. Description of Plan

The following is a brief description of the Massachusetts Mutual Life Insurance Company Agent Pension Plan (the Plan) provided for general information purposes only. The plan document should be consulted for a more complete description of the Plan's provisions.

a. General

The Plan covers certain career contract agents of the Massachusetts Mutual Life Insurance Company (the Company). The Plan, a defined contribution plan, was frozen on February 28, 2001. As of that date, Company contributions to the Plan ceased and employee contributions were no longer permitted to be made to the Plan.

Mutual funds are held in the MassMutual Defined Contribution Master Trust (the Master Trust). The custodian of the Master Trust is Fidelity Management Trust Company. Plan assets invested in the guaranteed interest accounts are held in a group annuity contract issued by the Company. Fidelity Workplace Services LLC is the recordkeeper. The MassMutual Plan Administrative Committee is the plan administrator, and the MassMutual Investment Fiduciary Committee is the Plan's investment fiduciary.

On December 29, 2022, the SECURE 2.0 Act of 2022 was enacted. The Plan's legal counsel believes that the Plan is in compliance with the applicable mandatory provisions of SECURE 2.0 that are currently in effect.

The Plan is subject to the provisions of ERISA, as amended.

b. Participation

Eligibility to participate in the Plan is closed due to the Plan being frozen on February 28, 2001. Prior to the Plan being frozen, all career contract agents of the Company, after completing one year of service, were eligible to participate in the Plan.

c. Payment of Benefits

Upon termination of a participant in the Plan by reason of death, disability, retirement, or termination of career contract, the vested amount of the participant's account is distributed in accordance with the provisions of the Plan Document.

d. Vesting

When the Plan was frozen, all participants became 100% vested with respect to the Company's contributions. Prior to the Plan being frozen, participants were immediately vested in their contributions.

e. Participant Accounts

Each participant's account is credited with investment earnings or losses less expenses. The investment earnings or losses are reflected in investment income on the statement of changes in net assets available for benefits (modified cash basis). A participant is entitled to the benefit that can be provided from the participant's vested account.

f. Termination of the Plan

Although the Company has not expressed any intent to do so, it has the right under the Plan to amend or terminate the Plan, at any time, subject to the requirements set forth in ERISA.

g. Administrative Expenses

Expenses related to administering the Plan are shared between the Company and the Plan. Administrative expenses that are paid by the Company are excluded from these financial statements.

Individual transactional fees are paid by the Plan and are included as administrative expenses in the statement of changes in net assets available for benefits (modified cash basis).

h. Investment Options

The Company and the MassMutual Investment Fiduciary Committee, on behalf of the Plan, act as investment managers for the investment options offered by the Plan. Participants may direct their current account balance, unless otherwise noted, to various investment options offered by the Plan. The investment options offered by the Plan provide participants a range of risk and return opportunities to choose from.

Asset-based fees are deducted from an investment option asset, thereby reducing the investment return. Asset-based fees are included in investment income on the statement of changes in net assets available for benefits (modified cash basis).

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. The modified cash basis of accounting is a cash receipts and disbursement method of accounting. Interest income, benefit payments, and expenses are recorded when received or paid. Although a modified cash basis of accounting represents a departure from U.S. generally accepted accounting principles, it is an allowable method of accounting for employee benefit plans filing under the reporting requirements of ERISA.

b. Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, except for the investment contracts (fully benefit-responsive contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisers, custodians and insurance company (Note 6). Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts (fully benefit-responsive contracts) are stated at contract value. Contract value is the amount participants would receive if they were to initiate certain transactions under the terms of the Plan. A fully benefit-responsive contract provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments, loans, or transfers to other investment options offered to the participant by the Plan (Note 4).

d. Payment of Benefits

Benefits are recorded when paid to the participant or when an annuity is purchased for the benefit of a participant.

3. Investment in Master Trust

The Plan has a divided interest in the Master Trust where each participating plan has a specific interest in the Master Trust. As of December 31, 2024, the Plan and the MassMutual Thrift Plan has an interest in the Master Trust. 4. Investment Contracts

The asset of the fixed interest investment option is held in a guaranteed interest account held under a group annuity contract, managed by the Company. The Company, the group annuity contract issuer, is contractually obligated to repay the Plan a specified guaranteed interest rate, which is reset twice a year. The Company was rated AA+ by Standard & Poor's as of December 31, 2024.

The investment in the guaranteed interest account held under the group annuity contracts meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value which represents contributions, when applicable, made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct withdrawal or transfer all or a portion of their investment at contract value. No reserve has been recorded for credit risk. Certain events may limit the ability of the Plan's participants to transact at contract value. Such events include the following:

(1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Master Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA of 1974 or (5) premature termination of the contract. The Plan administrator believes the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, would be less than remote. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material amendment to the agreement without the consent of the issuer.

The interest rate used in the Plan's fully benefit-responsive contract is based on a formula that takes into account the investment earnings of the assets that support the contract using the investment year method, but not less than 3.00% as stipulated in the contract. Interest rates are reviewed on a semi-annual basis for resetting. The interest rate was 3.00% for the year ended December 31, 2024.

5. *Certified Information*

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments in the Master Trust, and investments at contract value held at December 31, 2024 and 2023, and the Plan's interest in the Master Trust and interest income on investments at contract value for the year ended December 31, 2024, was obtained and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company or by the Company's Institutional Solutions.

6. *Fair Value Measurements*

The Plan and the Master Trust use a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the SEC and are required to publish their daily NAV. Mutual funds held by the Plan are deemed to be actively traded and are therefore classified as Level 1.

7. Related Party Transactions (Parties-in-Interest)

Fidelity Workplace Solutions LLC is the Plan's recordkeeper.

Fidelity Management Trust Company provides trustee and custodian services.

The Plan invests in certain mutual funds that are managed by wholly-owned subsidiaries of the Company. Expenses associated with these investments, including the management fees paid to such subsidiaries, are paid out of the assets of the mutual funds. The Company is also the issuer of the group annuity contracts. The Company is an employer with respect to the Plan, therefore these transactions are party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA and the Internal Revenue Code.

8. Tax Status

The Plan was submitted to the Internal Revenue Service (the IRS) on January 29, 2016 for a determination that the terms of the Plan, as set forth in the Plan documents, satisfied the qualification requirements of the Internal Revenue Code. A favorable determination letter was issued by the IRS on August 17, 2016. The Plan's legal counsel believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. generally accepted accounting principles require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan provides for various investment options in several investment securities and instruments. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks and values in the near term could materially affect investment balances and the amounts reported in the statements of net assets available for benefits (modified cash basis) and the statement of changes in net assets available for benefits (modified cash basis).

10. Subsequent Events

The Plan has evaluated events and transactions subsequent to December 31, 2024 and through September 15, 2025, the date the financial statements (modified cash basis) were available to be issued and determined that there are no other events or transactions that would require adjustments or additional disclosure in the financial statements (modified cash basis).
