Independent Auditors' Report

Opinion

We have audited the financial statements of MassMutual Thrift Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan (modified cash basis) as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditors' Responsibilities for the Audit of the Financial Statements

Notes to Financial Statements (Modified Cash Basis)

1. Description of Plan

The following is a brief description of the MassMutual Thrift Plan (the Plan) provided for general information purposes only. The plan document should be consulted for a more complete description of the Plan's provisions.

a. General

The Plan is a long-term savings and investment defined contribution plan, which offers participating employees and active career contract agents certain tax deferral advantages including a 401(k) account. The following individuals may participate if they meet certain eligibility requirements: (1) any employee of Massachusetts Mutual Life Insurance Company (the Company) or of an affiliated company that has adopted the Plan with the consent of the Company, other than an intern, an employee of an agent, a general agent, a leased employee or a temporary employee, who is employed by the Company as an employee at the Company's home offices, field offices, regional offices or agency offices in various locations in the United States; and (2) any active career contract agent who is contracted with the Company as a statutory employee under Internal Revenue Code (IRC) Section 7701(a)(20).

Plan assets, other than the group annuity contract and certain life insurance policies, are held in the MassMutual Defined Contribution Master Trust (the Master Trust). The custodian of the Master Trust is Fidelity Management Trust Company. Plan assets invested in the guaranteed interest account are held in a group annuity contract issued by the Company. Fidelity Workplace Services LLC is the recordkeeper. The MassMutual Plan Administrative Committee is the plan administrator, and the MassMutual Investment Fiduciary Committee is the Plan's investment fiduciary.

On December 29, 2022, the SECURE 2.0 Act of 2022 was enacted. The Plan's legal counsel believes the Plan is in compliance with these applicable mandatory provisions of SECURE 2.0 that are currently in effect.

On December 31, 2024, the assets and liabilities of the MassMutual Ascend 401(k) Plan (Ascend 401(k)) were merged with and into the Plan.

The Plan is subject to the provisions of ERISA, as amended.

b. Participation

An employee or statutory employee under IRC Section 7701(a)(20) who meets the Plan's eligibility requirements may commence participation in the Plan on the date of their first hour of service.

Unless they elect otherwise, newly eligible employees and statutory employees are automatically enrolled in the Plan 30 days following date of hire or date of contract endorsement with a 5% before-tax contribution. Investment allocations for participants who do not make an election, including those who participate through automatic enrollment, will be made to the qualified default investment fund designated by the MassMutual Investment Fiduciary Committee.

c. Payment of Benefits

Benefits are paid to participants at retirement. Certain pre-retirement withdrawals are permissible under the Plan. Withdrawals made to individuals who have not attained the age of 59 ½ may be subject to a 10% early distribution penalty.

d. Contributions

The Company matches 100% of participant contributions up to 5% of eligible compensation, as defined in the Plan. The Plan permits participants to contribute up to 100% of eligible compensation, no more than 8% of which may be contributed as after tax dollars. Before tax and Roth contributions are generally limited by IRC regulations to \$23,000 for 2024. Combined employee and employer contributions are limited by IRC regulations to \$69,000. Participants who are age 50 or older by year end are eligible to contribute an additional \$7,500 for 2024 to the Plan as before tax and/or Roth catch-up contributions. The Plan permits participants to roll over certain eligible distributions, subject to the provisions of the Plan.

Contributions are subject to certain limitations imposed by applicable provisions of the Plan and the IRC.

e. Vesting

Participants are immediately vested in their own contributions plus any earnings thereon. Each participant shall become vested in the value of the Company contributions, plus any earnings attributable thereto in accordance with the following vesting schedule.

Company contributions are 100% vested at attainment of age 65, retirement, disability or death.

f. Participant Accounts

Each participant's account is credited with the participant's own contributions and allocations of (a) the Company's contributions, and (b) investment earnings or losses less expenses. The investment earnings or losses are reflected in investment income on the statement of changes in net assets available for benefits (modified cash basis). A participant is entitled to the benefit that can be provided from the participant's vested account.

g. Forfeitures

If a participant terminates employment with the Company, the nonvested portion of the participant's Company contributions and any earnings thereon are forfeited. If the participant is re-employed within five years from the calendar year of termination, the forfeited amount of the Company contributions may be restored, subject to certain Plan provisions, requiring repayment of distributed amounts, and if no distribution was made, restoration will be made upon rehire.

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$793,853 and \$400,981, respectively. Forfeitures shall be used to reduce employer contributions. For the year ended December 31, 2024, \$1,292,994 nonvested accounts were used to reduce employer contributions.

h. Amendments and Termination of the Plan

Effective January 1, 2024, the Plan was amended and restated to add a new Annual Retirement Contribution (ARC) and 2024 Transition Annual Retirement Contribution (TARC) for certain eligible employees hired

or rehired (or eligible career agents contracted or recontracted) on and after January 1, 2024, and to make certain other administrative changes. The ARC is an annual non-discretionary employer contribution. The TARC is a one-time non-discretionary employer contribution for the 2024 plan year. Contributions related to the 2024 ARC, in the amount of \$3,020,908 and contributions related to the 2024 TARC, in the amount of \$3,851,908, were remitted to the Plan during March 2025. Eligibility requirements are defined in the plan documents.

Although the Company has not expressed any intent to do so, it has the right, under the Plan, to discontinue its contributions at any time and amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested.

i. Notes Receivable from Participants

Participant loans are available under the terms of the Plan document. Participants may borrow a minimum of \$1,000, and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in the last 12 months, from their accounts. The loan is deducted proportionally from the investment funds in which the participant's account is invested. The rate of interest charged on these loans is the prime rate (at the time of loan application), plus 2%. The interest rates on loans outstanding were 5.25% to 12.00% on December 31, 2024 and 5.25% to 12.00% on December 31, 2023.

j. Administrative Expenses

Expenses related to administering the Plan are shared between the Company and the Plan. Administrative expenses that are paid by the Company are excluded from these financial statements.

Individual transactional fees are paid by the Plan and are included as administrative expenses in the statement of changes in net assets available for benefits (modified cash basis).

k. Investment Options

The Company and the MassMutual Investment Fiduciary Committee, on behalf of the Plan, act as investment managers for the investment options offered by the Plan. Participants may direct their current account balance and future contributions, unless otherwise noted, to various investment options offered by the Plan. The investment options offered by the Plan provide participants with a range of risk and return opportunities to choose from.

Asset-based fees are deducted from an investment option asset, thereby reducing the investment return. Asset-based fees are included in investment income on the statement of changes in net assets available for benefits (modified cash basis).

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. The modified cash basis of accounting is a cash receipts and disbursement method of accounting. Contributions, interest and dividend income, benefit payments and expenses are recorded when received or paid. Although a modified cash basis of accounting represents a departure from U.S. generally accepted accounting principles, it is an allowable method of accounting for employee benefit plans filing under the reporting requirements of ERISA.

b. Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, except for the investment contract (fully benefit-responsive contract). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisers, custodians and insurance company (Note 6). Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contract (fully benefit-responsive contract) is stated at contract value. Contract value is the amount participants would receive if they were to initiate certain transactions under the terms of the Plan. A fully benefit-responsive contract provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments, loans, or transfers to other investment options offered to the participant by the Plan (Note 4).

d. Payment of Benefits

Benefits are recorded when paid to the participant or when an annuity is purchased for the benefit of a participant.

3. Investment in Master Trust

The Plan has a divided interest in the Master Trust where each participating plan has a specific interest in the Master Trust. As of December 31, 2024 following the merger of the MassMutual Ascend 401(k) Plan into the Plan, the Plan and the Massachusetts Mutual Life Insurance Company Agent Pension Plan have a divided interest in the Master Trust. As of December 31, 2023, the Plan, the MassMutual Ascend 401(k) Plan, and the Massachusetts Mutual Life Insurance Company Agent Pension Plan had divided interests in the Master Trust.

The Plan has 97% and 95% interest in the Master Trust as of December 31, 2024 and 2023, respectively.

The tables below present the Plan's interest in the Master Trust.

4. Investment Contract

The asset of the fixed interest investment option is held in a guaranteed interest account held under a group annuity contract, managed by the Company. The Company, the group annuity contract issuer, is contractually obligated to repay the Plan a specified guaranteed interest rate, which is reset twice a year. The Company was rated AA+ by Standard & Poor's as of December 31, 2024.

The investment in the guaranteed interest account held under the group annuity contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct withdrawal or transfer all or a portion of their investment at contract value. No reserve has been recorded for credit risk. Certain events may limit the ability of the Plan's participants to transact at contract value. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Master Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA of 1974 or (5) premature termination of the contract. The Plan administrator believes the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, would be less than remote. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material amendment to the agreement without the consent of the issuer.

The interest rate used in the Plan's fully benefit-responsive contract is based on a formula that takes into account the investment earnings of the assets that support the contract using the investment year method, but not less than 3.00% as stipulated in the contract. Interest rates are reviewed on a semi-annual basis for resetting. The interest rate was 3.00% for the years ended December 31, 2024 and 2023.

5. Life Insurance Policies

Certain plans that were merged into this Plan provided for the purchase of life insurance as an investment alternative for participants as plan assets. After the plans were merged into this Plan, the existing life insurance policies continued as an investment option under the Plan. With respect to the life insurance investments, the cash surrender value of these policies is reported on the statements of net assets available for benefits (modified cash basis). Cash surrender value approximates fair value. No additional policies can be purchased.

6. Fair Value Measurements

The Plan and the Master Trust use a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Observable inputs in the form of quoted market prices for identical investments in active markets.

Level 2 Observable inputs other than Level 1 prices, such as quoted market prices for similar investments, quoted prices in markets that are not active or other inputs that are observable or can be derived from observable market data for substantially the full term of the investments.

Level 3 One or more unobservable inputs that are supported by little or no market activity and are significant to the fair value of the investments. Level 3 investments include investments whose value is determined using internal models, as well as investments for which the determination of fair value requires significant management judgment or estimation.

An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used to measure fair value of investments:

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the SEC and are required to publish their daily NAV. Mutual funds held by the Plan are deemed to be actively traded and are therefore classified as Level 1.

Life Insurance Policies: The fair value of the life insurance policies is based on their cash surrender value, as provided by the third-party insurance carrier. These policies are categorized as Level 3 because the cash surrender value does not represent a quoted price in an active market and relies on unobservable inputs significant to the overall fair value measurement. Cash surrender values are reviewed for reasonableness.

7. Related Party Transactions (Parties-in-Interest)

Fidelity Workplace Solutions LLC is the Plan's recordkeeper.

Fidelity Management Trust Company provides trustee and custodian services.

The Plan invests in certain mutual funds that are managed by wholly-owned subsidiaries of the Company. Expenses associated with these investments, including the management fees paid to such subsidiaries, are paid out of the assets of the mutual funds. The Company is also the issuer of the group annuity contract.

The Company is an employer with respect to the Plan, therefore these transactions are party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA and the IRC.

8. Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated May 12, 2017, that the Plan and related trust are established in accordance with applicable sections of the Code. Although the Plan has been amended and restated since receiving this determination, legal counsel believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

U.S. generally accepted accounting principles require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements (modified cash basis).

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan provides for various investment options in several investment securities and instruments. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks and values in the near term could materially affect investment balances and the amounts reported in the statements of net assets available for benefits (modified cash basis) and the statement of changes in net assets available for benefits (modified cash basis).

In November 2022, a putative class action complaint was filed in federal court (D. Mass) by a current participant in the MassMutual Thrift Plan (the “Plan”) against the Company, Roger Crandall, the Plan Fiduciary and Plan Administrative Services Committees (and the unnamed members of those Committees), alleging, among other things, violations of ERISA. The case was dismissed on March 29, 2024.

10. Nonexempt Transactions

As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, for the year-ended December 31, 2024, certain participant contributions and loan repayments were not remitted to the Plan within the time frame specified by the DOL’s Regulation 29 CFR 2510.3-102 thus constituting nonexempt transactions between the Plan and the Company. The untimely remittances related to the 2024 plan year, in the amount of \$3,914,098, along with lost earnings of \$8,460 were remitted to the Plan in 2024. The untimely remittances related to the 2023 plan year, in the amount of \$485,826, were remitted to the Plan in 2023. Lost earnings on these nonexempt transactions, in the amount of \$451, was remitted to the Plan in 2024.

11. Subsequent Events

Effective January 1, 2025, the Plan was amended and restated to merge the assets and liabilities of the MassMutual Ascend 401(k) Plan with and into the Plan at the end of the day on December 31, 2024; add Glidepath Holdings Inc. (providing services to MassMutual Ascend) as a participating employer; extend the ARC to all eligible participants; add a TARC for the 2025 and 2026 plan years; and make certain other administrative changes. The ARC is an annual non-discretionary employer contribution. The 2025 and 2026 TARC is a one-time, non-discretionary employer contribution for the 2025 and 2026 plan years. Eligibility requirements are defined in the plan documents.

The Plan was again amended and restated effective June 1, 2025 to add Artemis Real Estate Holdings, LLC as a participating employer; credit Artemis service for purposes of Plan vesting; add a special one-time contribution for Artemis participants; revise the Plan’s small benefit cashout provision to raise the maximum cashout from \$1,000 to \$7,000; and make certain other administrative changes and clarifications.

The Plan has evaluated events and transactions subsequent to December 31, 2024 and through September 15, 2025, the date the financial statements (modified cash basis) were available to be issued and determined that there are no other events or transactions that would require adjustments or additional disclosure in the financial statements (modified cash basis).
