INDEPENDENT AUDITORS' REPORT

To the Administrative Committee
Regional Industries 401 (k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Regional Industries 401 (k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Regional Industries 401 (k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Regional Industries 401 (k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Regional Industries 401 (k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note A - Description of Plan

The following description of the Regional Industries 401 (k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all eligible employees of Regional Industries, LLC, Waste Industries, LLC, and Meadowbrook Industries, LLC (collectively the "Company"), who are at least twenty-one years old and have one year of credited service, other than employees who are covered by a collective bargaining agreement, nonresident aliens and leased employees. Eligible employees may enter the Plan on the first day of each month of the Plan year coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may contribute a percentage of their pre-tax annual compensation, as defined in the plan, as well as post-tax Roth contributions, as voluntary contributions in accordance with the provisions of Section 401(k) of the Internal Revenue Code ("IRC"). Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Company safe-harbor matching contributions are calculated based on the sum of 100% of the amount of the participant's elective deferrals that do not exceed 4% of the participant's compensation. Additionally, the Company may also make an discretionary non-elective contribution. For the year ended December 31, 2024, the Company did not make discretionary non-elective contributions.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants:

Participants may borrow against their investment account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. Generally, loans can be made for a period not exceeding five years. The loans are collateralized by the vested balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions.

Note A - Description of Plan (Continued)

Vesting:

Participants are immediately 100% vested in their salary deferral contributions and safe-harbor matching contributions plus actual earnings thereon. Vesting in nonelective contributions is based on years of service with the Company. A participant is fully vested in nonelective contributions after six years of service.

Payment of Benefits:

Participants may elect to receive a partial lump sum or lump-sum amount equal to the value of their vested interest upon retirement (age 65), termination of service, death or disability. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,103 and \$29,356, respectively. Forfeitures may be used by the Plan to pay administrative expenses or to reduce any Company contributions. For the year ended December 31, 2024, forfeitures of \$29,352 were used to reduce Company contributions.

Note B - Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note B - Significant Accounting Policies (Continued)

Plan Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Company personnel perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as plan expenses. Fees related to participant recordkeeping and specific participant transactions are charged directly to each participants' account and are included in administrative expenses.

Risk and Uncertainties:

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the financial statements.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Contributions:

Participant contributions and the related Company safe harbor matching contributions are recognized in the period the participant contribution is withheld from compensation

Payment of Benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Note C - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note D - Income Tax Status

Effective January 1, 2022, the sponsor adopted the non-standardized pre-approved profit sharing plan with CODA that has received an opinion letter dated November 23, 2020, for the Internal Revenue Service (IRS) as to the volume submitter plan's qualified status. The non-standardized pre-approved profit sharing plan with CODA's opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods.

Note E - Related Party Activity

Certain plan investments are investments managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the trustees, as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note F - Information Certified by the Trustees of the Plan

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the trustees of the Plan).

Note G - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts (PSAs) invest in mutual funds or common collective trusts. The fair value of the mutual funds is a publicly quoted pricing input and is used for determining the net asset value (NAV) of the PSAs, which is not publicly quoted. The unit value of the pooled separate account with underlying common collective trust investments are calculated based on the price of the underlying investment received from the fund manager. These PSAs can generally be redeemed at NAV as of the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are held primarily in pooled separate accounts across a range of categories, including equity funds, balanced funds, fixed income and bond funds, and asset allocation/target-date funds. The general investment objectives of these funds are as follows:

- Equity Funds (Large Cap, Mid Cap, Small Cap, International): Seek long-term capital growth, capital appreciation, or total return through investments in domestic and international equity securities. Certain index funds within this category are designed to replicate the performance of established benchmark indices (e.g., S&P 500, Russell mid-cap, or comparable indices).
- Balanced and Asset Allocation / Target-Date Funds: Seek to achieve total return over time through a combination of capital growth and income. These funds employ either static balanced allocations or dynamic strategies that automatically adjust based on investment risk profiles or projected retirement dates.
- Bond and Fixed Income Funds: Seek current income and/or total return through diversified investments in fixed income securities, including investment-grade bonds, high-yield debt, and index-tracking bond strategies.
- Specialty or Other Strategies: Certain pooled separate accounts may be designed to provide exposure to specific asset classes or sectors.

Gains and losses included in changes in net assets available for benefits are reported in net appreciation (depreciation) in fair value of investments.

*** Certain funds impose restrictions intended to discourage short-term trading. These generally include limitations on transferring into a fund within 30 days of a transfer out, or restrictions on large transfers (e.g., \$5,000 or \$20,000 or more) if a similar transfer out occurred in the prior 30-day period. These restrictions did not materially impact participants' ability to transact in Plan investments during the reporting period.

Note H - Guaranteed Investment Contract with Insurance Company

The Plan entered into a Group Annuity Contract (or "GAC") with Massachusetts Mutual Life Insurance Company (the original issuer). Effective December 31, 2020, Empower Retirement (through its affiliate Great-West Life & Annuity Insurance Company) assumed administration of the contract. The Fixed Account is an investment choice specific to the GAC and invests in the general account of the issuer, which contains the insurer's general account assets, excluding separate accounts, and is available to the insurer's creditors. Participants have no ownership interest in the assets of the Fixed Account. Contributions to the Fixed Account are credited with a Declared Interest Rate established periodically by the issuer, subject to a minimum guaranteed interest rate as defined in the Agreement.

The GAC credits interest at the Declared Interest Rate, which may change from time to time, but will not be less than the contractually specified Minimum Guaranteed Interest Rate. The issuer is responsible for investment and credit risks of the assets supporting the Fixed Account. Empower considers this investment option to be fully benefit responsive notwithstanding the market value events under the contract that limit the ability of the Plan to transact at contract value. Because the GAC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GAC. Contract value, as reported by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

All bona fide participant-initiated withdrawals from the GAC, including benefit payments at termination or retirement, loans and transfers to other non-competing investment options, are paid at contract value. Similar to other stable value alternatives, transfers to competing fixed income investments are not allowed.

Note H - Guaranteed Interest Accounts (Continued)

Upon full or partial contract or plan termination and certain other sponsor-initiated events, the sponsor must elect whether distributions from the GAC are paid under either the (a) Book Value Installment Alternative or (b) Market Value Adjustment Lump Sum Alternative. Under the Book Value Installment method, the net surrender value is paid in six equal installments, plus interest, annually over a five year period on the anniversary date of the event that initiated the distributions. The Market Value Adjustment Lump Sum method involves discounting the book value as prescribed by a formula in the contract, and the amount will be paid in a single lump sum payment not later than thirty days from the event that initiated the distributions.

Note I - Subsequent Events

Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

Note J Reconciliation of Financial Statements to Schedule H of Form 5500

The Plan has several investment options including pooled separate accounts which are reported differently on the IRS Form 5500 than in these financial statements. These investments do not report directly to the Security and Exchange Commission as a direct filing entity (DFE), and therefore, are required to be reported at the details of the underlying investments on the Form 5500. However, these investments are reported in the statements of net assets available for benefits as pooled separate accounts in total, as provided by the trustee. This represents a classification difference, however, the reported amounts per financial statements and Form 5500 agree as of and for the years ended December 31, 2024 and 2023.
