Independent Auditor's Report

To the Participants and Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Ogeechee Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of The Ogeechee Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution retirement plan which was established November 1, 1999, and covers employees of The Ogeechee Group, Inc. (the Company) who have been credited with ninety days of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Contributions to the Plan are made voluntarily by participating employees who elect a salary reduction which is remitted to the Plan by the Company on behalf of the participants. Participants elected contributions not to exceed \$23,000 and \$22,500 during the plan years ended December 31, 2024 and 2023, respectively. Participants who were age 50 or older before the end of the Plan year were eligible to make additional contributions up to \$7,500 during the plan years ended December 31, 2024 and 2023, subject to certain Internal Revenue Service (IRS) limitations. Contributions made by the employer are determined annually by management on a discretionary basis. The Company's profit sharing contribution totaled \$350,000 and \$311,304 for the years ended December 31, 2024 and 2023, respectively, of which \$53,000 and \$8,700, respectively, was paid from the forfeiture account balance.

Participant accounts and vesting

Each participant's account is credited with the participant's contributions and with an allocation of the Company's contributions and Plan earnings. Allocations of the Company's contributions are based on participant compensation while allocations of Plan earnings are based on participant account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are vested immediately in their contributions plus actual earnings thereon and are entitled to 100% of their individual contributions upon retirement or termination. Vesting in the Company's contribution to participant accounts occurs over a period of six years as follows:

Benefits are payable upon (a) termination of service, (b) early retirement after attainment of age 55, (c) normal retirement after attainment of age 65, (d) late retirement upon termination of service if the participant continues to work for the Company after his or her normal retirement date, or (e) death or permanent disability. A participant may elect to receive a lump sum equal to the value of his or her account or one of several annuity options which is in compliance with the Internal Revenue Code (IRC) and Regulations. The plan allows for in-service distributions when participants reach age 65 and for financial hardship withdrawals subject to Plan provisions.

Contributions receivable

Contributions receivable are based upon the timing difference between the determined contributions of the employer and employees and the receipts by the investment custodian.

Forfeitures

Forfeitures serve to reduce a participant's balance when termination occurs before the employee is fully vested in the employer contributions. Forfeited balances can be used to pay Plan expenses or employer profit sharing contributions in the year following the Plan year in which the forfeiture occurs. Unused forfeiture balances total \$4,942 and \$5,864 as of December 31, 2024 and 2023, respectively.

Investment options

Investments are participant-directed among twenty-three funds.

Participant loans

The Plan does not permit participant loans.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, contributions are recognized when determined rather than when received, and expenses are recognized when incurred rather than when paid.

Valuation of investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 9 for discussion of fair value measurements. Purchases and sales of securities are recognized on their transaction dates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

NOTE 3 - RELATED PARTY TRANSACTIONS

The Company absorbs certain administrative expenses of the Plan which totaled \$21,966 and \$25,421 for the Plan years ended December 31, 2024 and 2023, respectively.

NOTE 4 - PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 5 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The custodian is authorized under contract provisions, and by ERISA regulations providing an administrative or statutory exemption, to invest in funds under its control. Certain Plan investments, including shares of mutual funds, are managed by Empower Retirement. These transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund.

NOTE 6 - INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated January 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that 'more likely than not' would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - DESCRIPTION OF INFORMATION CERTIFIED BY THE INVESTMENT CUSTODIAN

Effective December 31, 2020, Empower Retirement acquired the retirement plan and group insurance business of Massachusetts Mutual Life Insurance Company (MassMutual), and became the sole administrator of the retirement business. The group insurance business written by MassMutual is reinsured by Empower Annuity Insurance Company of America (EAICA).

As permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected to have the investment custodian of the Plan, Empower Retirement, certify as to the accuracy and completeness of certain information included in the accompanying financial statements and schedule in lieu of the Plan's independent accountants examining such information. Accordingly, the following information was certified by the investment custodian and was not subjected to any auditing procedures except for comparing such information with the related information contained in the accompanying financial statements and supplemental schedule:

- A. Investments in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- B. Activity in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- C. Information included in the supplemental schedule, as listed in the accompanying table of contents.

NOTE 8 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Guaranteed Interest Account with MassMutual and E I Fixed Account with EAICA are fully benefit-responsive investments and are reported at contract value in the statements of net assets available for benefits. The statement of changes in net assets available for benefits is also prepared on a contract value basis for these investments. Benefit responsiveness is defined as the extent to which a contract's terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The benefit-responsive investment contract with MassMutual is general account evergreen group annuity contract. MassMutual maintains the contributions in a general account. Specific securities within the general account are not attributed to the investment contract with the Plan. The Plan owns a series of guarantees that are embedded in the insurance contract. The contractual guarantees are backed up by the full faith and credit of MassMutual, the contract issuer. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MassMutual is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and includes such factors as the investment-year method experience of the underlying contract or pool, projected levels of cash flows within the current interest rate environment, and the projected maturity of the underlying investments. Such interest rates are reviewed on a semiannual basis for resetting.

NOTE 8 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (continued)

This contract is an unallocated insurance contract, which is credited each January 1 and July 1 for interest earned. The average yield for the Guaranteed Interest Account was 3.00% for 2024 and 2023. The interest rate earned on the Guaranteed Interest Account was 3.00% at December 31, 2024 and 2023.

The benefit-responsive investment contract with EAICA is a general account product in which participants' principal and interest amounts are fully guaranteed by the general assets of EAICA. The fixed account is contractually obligated to repay the principal and guaranteed interest rate for the life of the contract. The effective annual interest rate is reset at least annually and no more frequently than quarterly. The average yield for the E I Fixed Account was 2.66% for 2024, and the interest rate earned on the E I Fixed Account was 2.70% at December 31, 2024.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to, a participant termination of employment due to: (i) removal of a group of participants from plan coverage as a result of temporary absence; (ii) change in position or other occurrence qualifying as a temporary break in service under the plan; (iii) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (iv) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business. Such events also include: (i) removal from the Plan of one or more groups or classifications of participants; (ii) partial or complete Plan termination; or (iii) Plan disqualification. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 9 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy follow:

NOTE 9 - FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuities: Valued at the adjusted daily closing price. The initial pricing input is the quoted price obtained for the underlying mutual fund adjusted to apply the expense factor disclosed in the annuity contract.

Collective investment trusts and fixed annuities: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan holds investment securities which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - PLAN AMENDMENT

On October 17, 2024, the Plan was amended to be a profit sharing and Safe Harbor 401(k) Plan. Effective January 1, 2025, the employer matching contribution will be 100% of salary deferrals up to the first 3% of eligible compensation, plus 50% of salary deferrals up to the next 2% of eligible compensation.
